1. PERFORMANCE OF THE FUND AND CAPITAL MARKETS OUTLOOK

1.1. A report by Deloitte describing the performance of the fund over the three month period to 31 December is attached as appendix one.

2. COMPLIANCE WITH STATUTORY REQUIREMENTS

- 2.1. The Local Government Pension Scheme (LGPS) investment regulations under which the Fund operates contain statutory limits for certain types of investments.
 - a) Not more than 10% of the Fund can be invested in any one company.
 - On 31 December, 2011 the largest share-holding was in GlaxoSmithKlein which represented 1.87% of the Fund.
 - b) Not more than 35% of the Fund can be invested in collective investment schemes managed by a single manager.
 - On 31 December, 2011, the largest element of the portfolio in collective investment schemes was the passive UK (16.56%) and Global (13.30%) mandates both managed by State Street. This represented 29.85% of the Fund.
 - c) Not more than 5% can be invested in employer related investments.
 - On 31 December, 2011 the Fund has no employer related investments.
- 2.2. The Fund is therefore complying with statutory requirements.
