1. Executive Summary

- 1.1 This report presents proposals to improve the public realm on Harrow Road, Hermitage Street and North Wharf Road, London W2 and seeks approval to:
 - Complete the detailed design and implement the public realm improvements identified in this report;

- Modify and make traffic regulation orders;
- Capital expenditure necessary to implement the proposals;
- Give authority to the Executive Director for City Management and Communities to approve minor modifications to the scheme in consultation with the Cabinet Members for Built Environment, Sustainability and Parking and City Management and Customer Services; and
- Enter into an Agreement with the developer pursuant to section 278 of the Highways Act 1980.
- 1.2 Attention is drawn to the comments received in response to the consultation exercise and the Executive Director's responses to them, contained in Appendix D. No objections were received.

2. Recommendations

Cabinet Member for The Built Environment

- 2.1 That approval be given to complete the design and to implement the proposed public realm improvements shown on the General Arrangement drawing 70006740-CD-01a-B included in Appendix B.
- 2.2 That authority be given to the Executive Director for City Management and Communities to approve minor modifications to the approved scheme, in consultation with the Cabinet Members for Built Environment, Sustainability and Parking and City Management and Customer Services.
- 2.3 That the Cabinet Member concurs with the decisions of the Cabinet Member for City Management and Customer Services and the Cabinet Member for Sustainability and Parking to the extent that they are within his/her terms of reference

Cabinet Member for City Management and Customer Services

- 2.4 That approval be given to capital expenditure of up to £288,000 necessary for the detailed design and implementation of the works. All costs will be fully funded by the developer in advance of the works being carried out.
- 2.5 That the Cabinet Member concurs with the decisions of the Cabinet Member for Built Environment and the Cabinet Member for Sustainability and Parking to the extent that these are within his/her terms of reference.

Cabinet Member for Sustainability and Parking

- 2.6 That approval be given to make such traffic regulation orders under sections 6 and 45 of the Road Traffic Regulations Act 1984 necessary to accommodate the public realm improvements together with the Statement of Reasons as set out in Appendix C.
- 2.7 That the Cabinet Member concurs with the decisions of the Cabinet Member for the Built Environment and the Cabinet Member for City Management and Customer Services to the extent that they are within his/her terms of reference.

3. Reasons for Decision

- 3.1 The proposed public realm improvements identified in this report will improve the streetscape for highway users by repaving the footway of Harrow Road, Hermitage Street and North Wharf Road using high quality robust materials, providing improved public lighting and drainage, better pedestrian and vehicular accessibility and increasing the on-street parking provision out of the restricted hours.
- 3.2 The estimated cost for the detailed design and implementation of the works is £280,000 which includes risk and contingency and Westminster City Council's costs, and will be fully funded by the developer under the terms of a section 278 agreement.
- 3.3 The recommendations will allow the design of the proposals outlined in this report to be completed together with capital expenditure necessary to implement the works and any minor design changes to be undertaken.

4. Background, including Policy Context

- 4..1 Conditional planning permission for the redevelopment of the western side of the former North Westminster Community School (from now on known as North Wharf Gardens) was granted by Westminster City Council on 9th August 2013 and is the subject of a section 106 agreement. This agreement required the developer to enter into a section 278 agreement to secure the public realm improvements.
- 4..2 Under the terms of the section 278 agreement, the developer has opted to use the Council's service provider FM Conway Ltd to design and implement the public realm improvements.
- 4..3 The public realm improvements referred to in this report are shown on the General Arrangement drawing 70006740-CD-01a-B included in Appendix B.

5. Scheme Design Proposals

- 5..1 The aim of the proposals is to accommodate the new development and improve the public realm for all highway users.
- 5..2 The proposals are shown on the General Arrangement drawing 70006740-CD-01a-B in Appendix B and include:
 - Widening and repaving of the eastern footway of Hermitage Street in concrete paving;
 - Repaving of the footway outside the new development on Harrow Road and North Wharf Gardens in concrete paving;
 - Widening the carriageway and changes to the geometry of the junction of Hermitage Street with Harrow Road and North Wharf Road to enable a twoway traffic flow along Hermitage Street;
 - Improve vehicular movement along Hermitage Street by introducing three lay-bys on Hermitage Street where loading will be permitted at any time and parking will be prohibited during the restricted hours;
 - Modifications to the existing waiting and loading restrictions to accommodate the new vehicular entrance to the new development (North Wharf Gardens) and the three new lay-bys;
 - Removal of the contra-flow cycle lane;
 - New informal pedestrian crossing on North Wharf Road immediately west of Hermitage Street;
 - Improving the public lighting along Hermitage Street;
 - Planting of up to 4 trees, where possible, subject to investigations; and
 - Improving the surface water drainage within the whole extents of the scheme.

6. Parking, Waiting and Loading

- 6..1 In order to accommodate the new vehicular entrance and the three new lay-bys the following changes are required:
 - Replace 48m of double yellow line 'at any time' waiting restrictions on the eastern side of Hermitage Street with single yellow line;
 - Remove 57m of double blips 'at any time' loading restrictions on the eastern side of Hermitage Street;
 - Introduction of 25m of double blips 'at any time' loading restrictions on the southern side of Harrow Road outside the new development; and

- Introduction of 5m of double blips 'at any time' loading restrictions on the northern side of North Wharf Road outside the new development, immediately west of the existing bus stand.
- 6..2 Details of the existing and proposed parking, waiting and loading facilities are shown on drawing 70006740-CD-02-C and 70006740-CD-03-B respectively, included in Appendix C.

7. Programme

7..1 The works are currently programmed to commence in August 2016 with an anticipated duration of 3 months to complete

8. Outstanding Issues

8..1 Following approval, traffic order consultation for the proposed changes identified in this report will be progressed. The Executive Director for City Management and Communities will use his delegated powers to consider any objections received in consultation with the Cabinet Members for Built Environment, Sustainability and Parking and City Management and Customer Services.

9. Financial Implications

- 9..1 The section 278 highway works will be implemented by WCC's term contractor FM Conway.
- 9..2 All costs of implementing the public realm improvements are being funded by the developer.
- 9..3 The estimated cost of the public realm improvements is £288,000 including an allowance for risk and contingency and will be fully funded by the developer.

10. Legal Implications

- 10..1 Section 106 of the Town Planning Act 1990 enables a Local Authority to enter into an agreement with a person with an interest in land to regulate the use of the land, including amelioration of development impacts. The section 106 required the developer to enter into a section 278 to secure the public realm improvements.
- 10..2 Section 278 of the Highways Act 1980 enables a Local Authority, acting in its capacity as "Highway Authority" to enter into agreements with developers (in order to facilitate development) for the developer to either pay for, or make alterations or improvements to the highway at the developers own cost and expense.
- 10..3 The pre-conditions for an agreement under section 278 are firstly that the Local Authority should be satisfied that it will be of benefit to the public to enter into the agreement for the execution of the works by the authority and secondly that the

- works must be such that the Local Authority are authorised to execute, i.e. they must fall within the highway authorities powers of road building, improvement or maintenance.
- 10.4 The Director of Law has read the report and is satisfied that the highway elements of the proposed public realm works fall within the ambit of section 278 of the Highways Act 1980.

11. Consultation

- 11..1 A consultation exercise was carried out during May 2016 involving Ward Councillors, local amenity groups and section 6 consultees including frontages. This consultation exercise attracted 1 response from one Ward Councillor.
- 11..2 A summary of the response is attached as Appendix D.
