Executive Summary

- 1.1. Following the local elections in May 2022, the new administration has reviewed nominations to certain outside bodies, including subsidiary companies.
- 1.2. In line with the administration's review of such nominations, this report proposes the removal of Councillor Tony Devenish as Chair of Westco Trading Limited and as a company director and secondarily proposes that Councillor Max Sullivan is appointed as a company Director and to serve and Chair of Westco Trading Limited.
- 1.3. The new appointee will become a member of the Westco Trading Limited Board.

1.4. The Shareholder Committee holds delegated authority to act on behalf of the Council for a number of key decisions, including the removal and appointment of Directors to be appointed to the Board of a subsidiary. The Shareholder Committee may make such appointments by acting collectively outside of a formal Committee meeting through a signed majority resolution – this report shall serve as that resolution.

2. Recommendations

2.1.It is recommended that:

- Councillor Tony Devenish is removed as Chair, company director and Board member of Westco Trading Limited.
- Councillor Max Sullivan is appointed as Chair, company director and Board member of Westco Trading Limited.
- The Company is instructed to make the necessary entries in the statutory books of the Company and to make the necessary filings at Companies House.

3. Reasons for Decision

3.1. Following a review of appointments, the new administration has indicated that it would like to refresh the leadership of Westco. The nominee's knowledge and experience in the area of communications will ensure continued input and oversight with regard to the strategic and financial direction of the company.

Financial Implications

4.1. None – Directors are not remunerated or compensated for undertaking these roles.

Legal Implications

- 5.1. The authority for the Shareholder Committee to nominate directors to the boards of the council's wholly owned companies was delegated by decision of Cabinet on 12 July 2021.
- 5.2. In line with the original recommendations, the terms of reference approved by Cabinet were subsequently amended in September 2021 by the Executive Director of Finance and Resources, in consultation with the relevant Cabinet Member, to allow certain decisions, including the

- nomination of Directors, to be taken outside of meetings by signed resolution of a majority of Committee Members.
- 5.3. Westco Trading Limited's ("Westco") articles of association stipulate that the holder of the A Shares in Westco (i.e. the City Council) has the sole right to appoint directors and has the right to remove and / or replace such directors on 5 working days' notice to the company
- 5.4. Training should be provided to the director so as to ensure conflicts of interest are understood and managed appropriately and that the individual appointed understands and is able to comply with their statutory duties under the Companies Act 2006 and associated legislation.

Carbon Impact

6.1. There are no direct carbon implications from the appointment of an existing councillor to the Board of Westco Trading Limited.

7. Equalities implications

7.1. This decision has no known direct equalities impacts due to the nature of the change involved. Due consideration has however, been given to the council's diversity and inclusion ambitions when making senior level appointments.
