Executive Summary

The Co-operative Councils' Innovation Network is a non-party-political active hub working alongside the LGA establishing co-operative policy development, innovation and advocacy.

There is increasing interest, across the political spectrum, in how to share power and responsibility with citizens, support the development of community and civic life and find more cost-effective ways to create successful and resilient communities. Membership is open to all councils, opposition groups, and businesses wishing to show their support and engage in the processes of developing innovative co-operative councils.

They provide a voice for co-operative councils, informed by real experience and practice, with the aim of drawing on, influencing and framing national policy and political debates about the future of public services, local democracy, and communities across the country.

1. Recommendations

 (i) That the Leader of the Council agrees that Westminster City Council (WCC) should become a member of the Co-operative Councils Innovation Network.

2. Reasons for Decision

The Co-operative Councils' Innovation Network is a collaboration between local authorities who are working together to find better ways of working for, and with, local people for the benefit of their local community.

The Fairer Westminster strategy puts residents at the heart of decision-making and emphasises the importance of collaboration and engagement in order to build a Fairer Westminster for all.

The strategy dovetails perfectly with the network's aims and objectives. The network is about sharing best practice for collaboration and engagement and will provide WCC with support and advice from peers across local government. Working together with the network will allow the council to draw on further expertise and work collaboratively to achieve our Fairer Westminster objectives.

3. Background, including Policy Context

The Co-operative Council Innovation Network is the fastest-growing Network in Local Government and currently have 126 Members and Supporters. The members believe the unprecedented challenges facing the public sector and local communities mean that traditional top-down governance models and economic growth are no longer fit for purpose. They want to reclaim the traditions of community action, community engagement, and civic empowerment that can transform communities. This approach will help deliver radical and innovative programmes designed, led, and delivered in partnership with communities and other sector partners, maximising the social dividend they bring.

4. Financial Implications

The fiscal implications arising as a result of membership would be \pounds 7,900 per annum which would begin on the 1st of August 2023. Given the relatively minor expenditure this can be accommodated within the existing budget of the Innovation and Change department.
