- 5. BSF PROCUREMENT PROCESS EVALUATION OF BIDDERS' RESPONSES AND INVITATION TO SUBMIT FINAL TENDERS (see report of the Director of Building Schools for the Future – agenda item 6)
- 5.1 The Director of Building Schools for the Future (BSF) introduced a report (a) providing Members with information about the progress of the procurement process for Westminster's BSF programme and (b) setting out the process for evaluation of Bidders' responses to the Invitation to Continue the Dialogue. Members noted that the recommendations in the report relating to the evaluation of the initial bids and the Invitation to Submit Final Tenders were agreed in principle by the BSF Strategic Board at its meeting on the 30 March 2007.
