1 NOTICE OF MOTION - HONORARY ALDERMAN: MR ALAN BRADLEY, MR MICHAEL BRAHAMS DL AND MR CYRIL NEMETH MBE, MA, MRCGP, JP, MRCP

RESOLVED:

That the Council confer the title of Honorary Alderman on:

- (a) Mr Alan Bradley MA, FIA, who was first elected as a Westminster City Councillor on 4 May 1978 and who retired in May 2014, served as a Councillor for 36 years. He represented the Tachbrook ward since 2002 and prior to that the St George's ward from 1978 to 2002. He served as Lord Mayor in 1995-1996.
- (b) Mr Michael Brahams, DL, who was first elected as a Westminster City Councillor on 3 May 1990 and who retired in May 2014 after 24 years service as a Councillor for Bayswater ward. Mr Brahams served as Lord Mayor in 2000-2001.
- (c) Dr Cyril Nemeth MBE, MA, MRCGP, JP, MRCP, who was elected as a City Councillor on 8 May 1986 and retired in May 2014, served as a Councillor for Abbey Road ward since 2002 and prior to that Lord's ward from 1986 to 2002. A total of 28 years service. He served as Lord Mayor in 1992 – 1993.

Over the years they have contributed so much to the work of the Council through their caring personality, wisdom, knowledge and vast experience between them undertaking the various roles of Cabinet Member and Chairmen of numerous committees. They have served the Council and people of Westminster with enormous dedication and the Council is asked to agree that they each be honoured by the conferring of the title of Honorary Alderman.
