in Twickenham, where we have been trading since 2005 as an 'independent bottle shop', a use that is becomingly increasingly widespread throughout London (other examples include Hop Burns and Black, Beer Boutique and We Brought Beer). A concept which is increasing in London, as the interest in craft beer increases (please see the images which are referred to in the plan). The named applicant, Nicholas Dolan, is also the owner of a brewery (Woodforde's Brewery in Norfolk).

Facilities available for customers will include some select seating on the ground floor, with the seating focused around the front windows, and during warmer times of the year two tables with two chairs to positioned directly outside of the retail space (in keeping with the café next door). As part of our application we would like to apply for a pavement licence with the Council.

We plan to allow customers to consume alcohol in the basement area, where there will a mix of seating and product for sale on purpose built shelving. This area will also be used for seating and as an area for 'event tastings' as well as 'meet the brewer' style events. The maximum capacity of the basement will be for 20 people seated only. On the ground floor the maximum capacity for seating will be 8 people, across 2 tables only (at the front of the store). Alcohol may be only consumed by customers who are seated (across both floors this will be 28 people), with the exception of one off 'private tasting events'.

'Private tasting events' are those pre-organised or private events where members of the general public are not permitted on a walk-in basis. The maximum capacity for the basement seating area will always remain at 20 seated customers only.

The ground floor and the basement will always be staffed by a minimum of 2 persons if there are customers situated on either floor.

The designated premises supervisor is our existing Store Manager (at Real Ale in Twickenham).

This representation is based on the operating schedule and accompanying plans of Basement & Ground Floor by Bob Trimble dated 9 March 2017 ref 1851/1.

The applicant is seeking the following licensable activities:

1. Provision of recorded music "Indoors" at the following times:

Monday: 10:00 - 22:00 hours

Tuesday to Sunday: 10:00 - 22:30 hours

2. Supply of Alcohol for consumption "On & Off" the premises at the following times:

Monday: 10:00 - 22:30 hours

Tuesday to Sunday: 10:00 – 23:00 hours

I wish to make the following representation

1. The provision and hours requested for recorded music will have the likely effect of causing an increase in Public Nuisance within the area.

2. The provision and hours requested for the Supply of Alcohol will have the likely effect of causing an increase in Public Nuisance and impact on Public Safety within the area.

The granting of the application as presented would have the likely effect of causing an increase in Public Nuisance and impact on Public Safety within the area

The applicant has provided some conditions in support of the application which are being considered but do not fully address the concerns of Environmental Health.

The applicant is requested to contact the undersigned to discuss all these issues and to arrange a site visit after which Environmental Health may propose additional conditions to allay its concerns

<u>Further discussion with Environmental Health</u>

- 1. The sale of alcohol at the premises, at all time, shall be ancillary to the premises remaining a specialist craft beer shop
- 2. There shall be no bar servery within the basement area
- 3. There shall be no tables and chairs placed outside the premises
- 4. The number of seated persons permitted in the premises at any one time (excluding staff) shall not exceed
 - Basement: 12
 - Ground floor 8

With no more than 20 persons

- 5. No noise generated on the premises, or by its associated plant or equipment, shall emanate from the premises nor vibration be transmitted through the structure of the premises which gives rise to a nuisance
- 6. The external door shall be kept closed after **21:00** hours except for the immediate access and egress of persons
- 7. Notices shall be prominently displayed at the exit requesting patrons to respect the needs of local residents and businesses and leave the area quietly
- 8. After **21:00** hour patrons permitted to temporarily leave and then re-enter the premises, e.g. to smoke, shall be limited to 5 persons at any one time
- 9. All waste shall be properly presented and placed out for collection no earlier than 30 minutes before the scheduled collection times
- 10. No waste or recyclable materials, including bottles, shall be moved, removed from or placed in outside areas between **23.00** hours and **08.00** hours on the following day
- 11. No collections of waste or recycling materials (including bottles) from the premises shall take place between 23.00 and 08.00 hours on the following day

- 12. During the hours of operation of the premises, the licence holder shall ensure sufficient measures are in place to remove and prevent litter or waste arising or accumulating from customers in the area immediately outside the premises, and that this area shall be swept and or washed, and litter and sweepings collected and stored in accordance with the approved refuse storage arrangements by close of business
 - 13. The approved arrangements at the premises, including means of escape provisions, emergency warning equipment, the electrical installation and mechanical equipment, shall at all material times be maintained in good condition and full working order.
 - 14. The means of escape provided for the premises shall be maintained unobstructed, free of trip hazards, be immediately available and clearly identified in accordance with the plans provided.
 - 15. All emergency exit doors shall be available at all material times without the use of a key, code, card or similar means.
 - 16. All emergency doors shall be maintained effectively self-closing and not held open other than by an approved device.
 - 17. The edges of the treads of steps and stairways shall be maintained so as to be conspicuous.
- 18. No licensable activities shall take place at the premises until the premises have been assessed as satisfactory by the Environmental Health Consultation Team at which time this condition shall be removed from the Licence by the Licensing Authority.

With reference to the above application, I am writing to inform you that the Metropolitan Police, as a Responsible Authority, make a representation against the above application.

It is our belief that if granted the application would undermine the licensing objectives in relation to the prevention of crime and disorder as there are insufficient conditions within the operating schedule.

We have concerns that this application will cause further policing problems in an already demanding area.

Details of further Police discussions:

I have put together a list of conditions that Police believe would address our concerns in

relation to crime and disorder.

- 1.The premises shall install and maintain a comprehensive CCTV system as per the minimum requirements of the Westminster Police Licensing Team. All entry and exit points will be covered enabling frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Viewing of recordings shall be made available immediately upon the request of Police or authorised officer throughout the entire 31 day period.
- 2. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises is open. This staff member must be able to provide a Police or authorised council officer copies of recent CCTV images or data with the absolute minimum of delay when requested.
- 3. A Challenge 21 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram.
- 4. An incident log shall be kept at the premises, and made available on request to an authorised officer of the City Council or the Police. It must be completed within 24 hours of the incident and will record the following: (a) all crimes reported to the venue (b) all ejections of patrons (c) any complaints received concerning crime and disorder (d) any incidents of disorder (e) any faults in the CCTV system (f) any refusal of the sale of alcohol (g) any visit by a relevant authority or emergency service.
- 5. There shall be a personal licence holder on duty on the premises at all times when the premises are authorised to sell alcohol.
- 6. All sales of alcohol for consumption off the premises shall be in sealed containers only, and shall not be consumed on the premises.
- 7. No super-strength beer, lagers, ciders or spirit mixtures of 5.5% ABV (alcohol by volume) or above shall be sold at the premises, except for premium beers and ciders supplied in glass bottles.
- 8. There shall be no self-service of alcohol for consumption on the premises.
- 9. The supply of alcohol on the premises shall only be to a person seated and to a maximum of 8 persons on the ground floor and XX in the basement. (To be confirmed by EH)
- 10. The supply of alcohol shall be by waiter or waitress service only.

- 11. Food and non-intoxicating beverages, including drinking water, shall be available in all parts of the premises where alcohol is sold or supplied for consumption on the premises.
- 12. Patrons permitted to temporarily leave and then re-enter the premises, e.g. to smoke, shall not be permitted to take drinks or glass containers with them.

After having studied the application I would be opposed to having another alcohol selling place with background music and open 7 days a week, and clients seating outside. This cannot be a quiet place, and would be located near our very residential street - Warrington Crescent. The pub in Formosa str - Prince Alfred - is already quite noisy with clients standing outside, and I would not be keen on having another place like this closer to my home where balconies give to Warrington Crescent so music could potentially be heard in the street 7 days a week and especially in summer time when the door is permanently open.

We live in the flat directly above 4 Formosa Street, and, as we would be very directly and very personally affected if the license is granted, we would like to register our objections to it being granted.

We are concerned about the following:

The evening trading hours (right up to 11pm most evenings), combined with a Licence to play music indoors. It is unavoidable that this will have a disruptive impact on our home life, and our right to be able to relax and enjoy the peace of our home. This old building does not 'contain' sound well. The noise shall not end when closing time is reached... the bottles shall be put outside and shall be collected during the night.

Customers congregating outside the premises by our front door, and right below our window. As can be expected, customers will congregate outside to smoke, to talk, to arrive and leave - we shall suffer from a loss of privacy and security; the noise will be disruptive; the smoke shall be unpleasant, and pushing past people to get in and out of

our home shall be a nuisance.

This stretch of Formosa Street between Castellain Rd and Warrington Crescent is no more than 60 meters in length, and yet it already has an Off-License (Dhigs), a large Pub (The Prince Alfred) with attached Restaurant (Formosa Dining Rooms), 2 other licensed Restaurants (Les Petits Gourmets & The Red Pepper), and 2 further restaurants without license - there is no need for another establishment to be granted a license - it is not what the area, and specifically, the residents of Formosa Street need. See attached Formosa St map...

The above premises combined already cause considerable disorder, disruption and nuisance to the residents of the street:

Already, the noise from patrons enjoying their drinks out of the street is often incredibly noisy, and impossible to shut out from our apartment. It is a quite common for our peace to be disrupted for most of the evening by the loud sounds of aggressive shouting, laughing, chanting, etc. See attached sound recording 1 taken from our window recently...

Already, each of these establishments stack their refuse bags of empty bottles out on the street throughout the evening, quite often stacked up against the entrances to the residential apartments above. The view we are confronted with approaching our street and our home is horrible, and the refuse attracts vermin and insects, etc towards our homes.

Already, The Prince Alfred, Les Petits Gourmets and The Red Pepper, have collections of their empty bottles etc after their trading hours. This means that even after 11pm the peace and sleep of the residents is disturbed again, as each seems to have a separate contractor engaged to collect their empty bottles. Between 12:30am and 2am, 3 large and noisy rubbish trucks separately drive into and down Formosa St, and the bags of empty bottles are thrown onto the trucks. See attached sound recording 2 taken from our window taken recently (not the best or loudest recording, but still illustrative)...

I would argue that already this small residential street cannot handle the level of late evening / early morning noise disruption and nuisance. Granting another license to another premise is only going to exacerbate the problems, and it is the residents such as ourselves, in the apartments directly above that will suffer most of all and considerably.

Therefore we ask that Westminster Council reject the application for a license, and encourage a retailer to the premises that is less intrusive to the lives of the residents of the street, and will add more community value to the street - we don't need another pub / off-license.

As a recognised amenity society by Westminster City Council, we are officially charged with working towards the preservation and enhancement of the architectural and environmental quality of Little Venice, Maida Vale and the Paddington Waterway area (including planning and licensing issues). We are concerned with the well-being and sense of community of its residents, including those who live in the vicinity of this part of Formosa Street, which is at this point a narrow street, with residential accommodation above first floor level on either side. In this short stretch, there are already one public house, three licensed restaurants (all with table licences outside) and a newsagent with an off licence.

We recognise that this proposal is designed to provide services for locals as well as people who are not residents in this area. Were this application to be food-led, we would probably be supportive, subject to appropriate safeguards. However, in relation to potential noise, crime and disorder, we are very regretfully concerned at the proposal for on and off sales, with no provision for food. If it were food led, we would be more likely to regard this as a real asset, attracting more people to the stretch of street which we would like to see "kept alive".

As this is a drink-led operation, we also object to the use of tables outside. This is in line with our earlier objections to the nearby public house having this facility. We do not wish to see customers drinking outside, due to the nuisance this would cause to residents of flats above.

Inevitably there is the issue of smoking. Those drinking in the basement would have to go outside and occupy the narrow pavement, potentially obstructing passers-by. In addition we object strongly to the idea that they could take their drink with them.

Finally, nearby residents have complained in the past about the level of external noise from the nearby pub, to the point where both WCC Licensing officers and the local ward Officer have regularly reminded the individual operators of the need to keep noise level down, much magnified because of the narrowness of the street, particularly in the warmer months.

Were the Council minded to grant such a licence, we would ask that it be restricted to off sales only, Sunday trading be restricted to Core Hours and no outside tables. If the Council were minded to grant any element of 'on' sales, we would ask it should be restricted to private, prebooked tasting events only.

We would also seek appropriate conditions on deliveries and recycling and waste collections (particularly because of the likely number of glass bottles), given the residential accommodation nearby.

We would like to iterate that we are supportive of any proposal which adds life to the street. However we regret that, in our view, the application as currently presented will fail to promote the licensing objectives.

Should there be a hearing, I hope to attend but if unable, will ask Richard Brown to represent us.

I live opposite the subject property, and it is immediately adjacent to many peoples' homes.

I have no objection to the sale of alcohol on the premises, but I must strenuously object to the consumption of alcohol and playing of recorded music on the premises.

In Formosa Street we already suffer the noise and antisocial behaviour from the patrons of the Prince Alfred pub as well as alcohol being served at the Red Pepper restaurant (also consumed on outside tables). The ongoing consumption of alcohol on premises results in behaviour such as shouting, signing in loud and obnoxious voices, and at times yelling and physical fighting - all because the patrons are intoxicated. I do Not believe that a third venue which exists to feed alcohol into people is desirable in our neighbourhood. People live in extremely close proximity to this property and we know that if alcohol is consumed on premises (this seems to be the sole purpose of the basement level plans here) then it will only add to our suffering. This is a predominantly residential area and people are trying to sleep at 10 and 10:30pm. We all know that after an evening of drinking, patrons are loud and do not respect the fact that others are sleeping mere yards away. Our buildings are listed and double glazing is not an option for most. I have to question why it is necessary for so many places for people to drink. A business like this is better suited to a more commercial, less residential area.

I am the chairman of the 21 Warrington Crescent Ltd, a building located at the intersection of Formosa Street (Nos. 1 and 2) and Warrington Crescent. The application pertains to No. 4 Formosa Street. Our building is the home of multiple families and houses school age children. We welcome a new occupant to No. 4 Formosa Street and understand that alcohol is already for sale at a number of outlets on Formosa Street, however, we wish to express our concern at the proposed opening hours. Currently, we suffer in the evenings from loud and occasional confrontational conversation in the evening from 1) patrons choosing to consume their beverages out of doors (despite well intentioned efforts of those managing premises) and 2) patrons departing around the hours of closing. The latter is particularly heightened in the warmer weather. This is detrimental to all of us and particularly to those younger who are studying. We are not a unique house and most of our neighbouring houses have similar demographics. Thus, we ask that that the proposed establishment have its opening hours limited to 20:00 for on-site consumption. We note that not many years ago a very similar application was made for alcohol service at 5 Formosa Street and it was refused due to neighbours' concern. It created much anxiety for the families living here. We do not see that anything has changed.





When determining an application for a new premises licence under the provisions of the Licensing Act 2003, the licensing authority must, unless it decides to reject the application, grant the licence subject to the conditions which are indicated as mandatory in this schedule.

At a hearing the licensing authority may, in addition, and having regard to any representations received, grant the licence subject to such conditions which are consistent with the operating schedule submitted by the applicant as part of their application, or alter or omit these conditions, or add any new condition to such extent as the licensing authority considers necessary for the promotion of the licensing objectives.

This schedule lists those conditions which are consistent with the operating schedule, or proposed as necessary for the promotion of the licensing objectives by a responsible authority or an interested party as indicated. These conditions have not been submitted by the licensing service but reflect the positions of the applicant, responsible authority or interested party and have not necessarily been agreed

Mandatory Conditions

- 1. No supply of alcohol may be made at a time when there is no designated premises supervisor in respect of this licence.
- 2. No supply of alcohol may be made at a time when the designated premises supervisor does not hold a personal licence or the personal licence is suspended.
- 3. Every supply of alcohol under this licence must be made or authorised by a person who holds a personal licence.
- 4. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to;
 - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;

- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 5. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 6. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
 - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
 - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
 - (a) a holographic mark, or
 - (b) an ultraviolet feature.
- 7. The responsible person must ensure that—
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
 - (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml;
 - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
 - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

A responsible person in relation to a licensed premises means the holder of the premise licence in respect of the premises, the designated premises supervisor (if any) or any individual aged 18 or over who is authorised by either the licence holder or designated premises supervisor. For premises with a club premises certificate, any member or officer of the club present on the premises in a capacity that which enables him to prevent the supply of alcohol.

- 8(i) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 8(ii) For the purposes of the condition set out in paragraph 8(i) above -
 - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
 - (b) "permitted price" is the price found by applying the formula -

P = D+(DxV)

Where -

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol:
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
 - (i) the holder of the premises licence,
 - (ii) the designated premises supervisor (if any) in respect of such a licence, or
 - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 8(iii). Where the permitted price given by Paragraph 8(ii)(b) above would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 8(iv). (1) Sub-paragraph 8(iv)(2) below applies where the permitted price given by Paragraph 8(ii)(b) above on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
 - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Conditions consistent with the operating schedule

- 9. Effective management and training of all staff.
- 10. All staff to have a personal licenses.

- 11. Clear 'challenge 21' information to prevent the supply of alcohol to under-age drinkers
- 12. CCTV installed throughout, with a recording mechanism.
- 13. CCTV installed on the ground and basement levels, also pointing out on to the street and fixed to the outside area of the shop frontage.
- 14. A staff member from the premises who is conversant with the operation of CCTV system shall be on the premises at all times when the premises is open. This staff member will be able to provide the Police or authorised council officers with copies of recent CCTV images or data with minimum of delay.
- 15. Notice on the shop front showing the normal hours of opening and closing, to which licensed activities are permitted.
- 16. There will be a maximum numbers policy for customers consuming alcohol on the premises, of 28 people who must be seated only, during the hours of 1200 and 22.00 on a Monday and 1200 and 22.30 Tuesday to Sunday.
- 17. The refusal of sale of alcohol to intoxicated customers
- 18. Prevention of drugs of any kind in the premises or outside of it
- 19. Fixed Internal lighting to promote public safety and Emergency lighting throughout the basement and ground floor.
- 20. A log book to be kept to record matters arising, including any inspections made by the authorities.
- 21. The building and all fixtures and fittings will be kept in good working order and safe for customers and our staff, to also include heating and air-conditioning.
- 22. Clear and prominent signage requesting the public to respect local residents
- 23. Deliveries only to be made in the hours of business to prevent any nuisance to neighbours.
- 24. Customers will be expected to move on from the premises and not to talk loudly both during opening hours and also once the premises have closed.
- 25. Any waste will be removed quietly and not in such a way to disturb residents (and not after 2300).
- 26. An appropriate cigarette dispenser will be installed outside of the premises to keep cigarette litter to a minimum.
- 27. Unaccompanied children under the age of 16 will not be allowed in the premises.
- 28. Children will not be permitted after the hours of 2000.

- 29. Staff will be required to check the ID of anyone appearing to be under the age of 18 and we would operate challenge 21 in conjunction with this policy. Reliable proof of age will be required (a photo driving licence, a passport, a proof of age card which carries the PASS hologram).
- 30. Staff will be trained to check anyone who looks under the age of 21 and the necessary steps required if they suspect they are under legal drinking age.
- 31. Challenge 21 signage will be evident in the front store window

Conditions proposed by the Environmental Health

- 32. The sale of alcohol at the premises, at all time, shall be ancillary to the premises remaining a specialist craft beer shop
- 33. There shall be no bar servery within the basement area
- 34. There shall be no tables and chairs placed outside the premises
- 35. The number of seated persons permitted in the premises at any one time (excluding staff) shall not exceed
- Basement: 12
- Ground floor 8With no more than 20 persons
- 36. No noise generated on the premises, or by its associated plant or equipment, shall emanate from the premises nor vibration be transmitted through the structure of the premises which gives rise to a nuisance
- 37. The external door shall be kept closed after **21:00** hours except for the immediate access and egress of persons
- 38. Notices shall be prominently displayed at the exit requesting patrons to respect the needs of local residents and businesses and leave the area quietly
- 39. After **21:00** hour patrons permitted to temporarily leave and then re-enter the premises, e.g. to smoke, shall be limited to 5 persons at any one time
- 40. All waste shall be properly presented and placed out for collection no earlier than 30 minutes before the scheduled collection times
- 41. No waste or recyclable materials, including bottles, shall be moved, removed from or placed in outside areas between **23.00** hours and **08.00** hours on the following day
- 42. No collections of waste or recycling materials (including bottles) from the premises shall take place between 23.00 and 08.00 hours on the following day
- 43. During the hours of operation of the premises, the licence holder shall ensure sufficient measures are in place to remove and prevent litter or waste arising or accumulating from customers in the area immediately outside the premises, and

that this area shall be swept and or washed, and litter and sweepings collected and stored in accordance with the approved refuse storage arrangements by close of business

- 44. The approved arrangements at the premises, including means of escape provisions, emergency warning equipment, the electrical installation and mechanical equipment, shall at all material times be maintained in good condition and full working order.
- 45. The means of escape provided for the premises shall be maintained unobstructed, free of trip hazards, be immediately available and clearly identified in accordance with the plans provided.
- 46. All emergency exit doors shall be available at all material times without the use of a key, code, card or similar means.
- 47. All emergency doors shall be maintained effectively self-closing and not held open other than by an approved device.
- 48. The edges of the treads of steps and stairways shall be maintained so as to be conspicuous.
- 49. No licensable activities shall take place at the premises until the premises have been assessed as satisfactory by the Environmental Health Consultation Team at which time this condition shall be removed from the Licence by the Licensing Authority.

Conditions proposed by the Police

- 50. The premises shall install and maintain a comprehensive CCTV system as per the minimum requirements of the Westminster Police Licensing Team. All entry and exit points will be covered enabling frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Viewing of recordings shall be made available immediately upon the request of Police or authorised officer throughout the entire 31 day period.
- 51. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises is open. This staff member must be able to provide a Police or authorised council officer copies of recent CCTV images or data with the absolute minimum of delay when requested.
- 52. A Challenge 21 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram.

- 53. An incident log shall be kept at the premises, and made available on request to an authorised officer of the City Council or the Police. It must be completed within 24 hours of the incident and will record the following:
 - (a) all crimes reported to the venue
 - (b) all ejections of patrons
 - (c) any complaints received concerning crime and disorder
 - (d) any incidents of disorder
 - (e) any faults in the CCTV system
 - (f) any refusal of the sale of alcohol
 - (g) any visit by a relevant authority or emergency service.
- 54. There shall be a personal licence holder on duty on the premises at all times when the premises are authorised to sell alcohol.
- 55. All sales of alcohol for consumption off the premises shall be in sealed containers only, and shall not be consumed on the premises.
- 56. No super-strength beer, lagers, ciders or spirit mixtures of 5.5% ABV (alcohol by volume) or above shall be sold at the premises, except for premium beers and ciders supplied in glass bottles.
- 57. There shall be no self-service of alcohol for consumption on the premises.
- 58. The supply of alcohol on the premises shall only be to a person seated and to a maximum of 8 persons on the ground floor and XX in the basement. (To be confirmed by EH)
- 59. The supply of alcohol shall be by waiter or waitress service only.
- 60. Food and non-intoxicating beverages, including drinking water, shall be available in all parts of the premises where alcohol is sold or supplied for consumption on the premises.
- 61. Patrons permitted to temporarily leave and then re-enter the premises, e.g. to smoke, shall not be permitted to take drinks or glass containers with them.

The application seeks to permit the following:

Sales of alcohol between 11:00hrs and 23:00 hrs every day of the week. We note that on Sundays these times fall outside the current core Hours.

The licensing authority is concerned that this premises has been in previous operation and has come to cause concerns to the Councils enforcement team. The applicant has been the director of the company which previously held the licence which lapsed when TGFC Limited went into liquidation. Previous incidents that have required the Councils intervention have included failure to comply with conditions, undermining the licensing objectives. 

A check of Companies House however reveals that the applicant Mr. Nirav Gor appears to have been a Director of the old company and the relevance of this will become clear.

The venue is not located within a cumulative impact zone however it is within the footprint of Lords so when there are matches licensed venues in this locality benefit from a much larger customer base. Further the venue is located very close to Baker Street Railway Station so there is a large footfall of customers when there are matches at Wembley.

The applicant has sought a new Premises Licence with opening times for the premises from 07:00 hrs until 23:30 hrs. This represents an extended opening period for the venue of 2.5 hrs compared with their old authorisation. They have applied for licensable activities to commence at 11:00 hrs and end at 23:00 hrs. In view of the difference in opening hours and permitted hours with the venue also seeking to have 'off sales' of alcohol, I would recommend that consideration be given to imposing MC28 requiring lockable cabinets making the alcohol inaccessible outside of permitted hours. Further as they intend to operate as a restaurant then could consideration be given to imposing MC 29 restricting beers etc. to an aby of not more than 5.5%

I note that the applicant has put forward a number of steps that they intend to implement should the application be granted. However I note that these do not include all of the conditions attached to the previous Premises Licence and I would request that consideration be given to imposing additional conditions to those put forward by the applicant with a view to promoting the licensing objectives and for the reasons outlined below.

The applicant has stated that the venue operates as a small restaurant with deli food but has not put forward any food conditions such MC 41 requiring that substantial food be available or MC 38 making sales of alcohol ancillary to a substantial table mean. In May 2016 on day of the FA Cup Final a number of males were outside the premises with alcohol. There were lots of bottles on the external tables and whilst some food had been obtained not everyone seen had food despite the venue having a restriction on their Premises Licence at that time. My concern is that with the number of sporting events that take place throughout the year and the large footfall in the area without a restriction on the Premises Licence regarding sales of alcohol there is a potential for 'stand-up' drinking at the premises which could potentially lead to crime and disorder in the area.

The applicant has sought to include a CCTV condition however it is not MC 01 in their They have put forward that recordings would be available to Police or other application. responsible authorities within 48 hours of a request. Under their previous licence it stated:- "All recordings shall be stored for a minimum period of 31 days with date and time stamping. Recordings shall be made available immediately upon the request of Police or authorised officer throughout the preceding 31 day period." In addition the applicant has omitted the previously imposed Model Condition MC 02 requiring that "A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises are open to the public. This staff member shall be able to show Police recent data or footage with the absolute minimum of delay when In May 2016 the venue was unable to comply with either of these requested." conditions. Due to the location of the premises and the potential for crime and disorder particularly when major sporting events take place I would recommend that both of the previous CCTV model conditions be imposed on the Premises Licence should the application be successful. I have referred to this point as the Police Licensing Team may not be aware of the issues found during my visit in May.

Previously the premises had MC 65 requiring that "All deliveries and rubbish collections shall take place between 07:00 and 21:00" I would recommend that similar conditions be imposed however I would recommend that the old condition be varied as follows: "All deliveries shall take place between 07:00 and 21:00" In respect to rubbish collections the

hours should mirror the collection times for this location (which is a Bags off Street area) and state that waste should not be placed outside more than 30 minutes prior to collection times (which are currently 09:00 hrs; 19:30 hrs and 00:30 hrs). In view of the venue being located on a 'Red Route' in an extremely busy area I would recommend that consideration be given to imposing these conditions on the new licence should the application be granted with a view to preventing public nuisance and promoting public safety.

In addition to the above I would recommend that consideration also be given to imposing one or more of the following conditions should the application be successful:-

MC 17 - (off sales of alcohol) only permitted in sealed containers or MC 36 - (off sales of alcohol) only permitted when ancillary to the sale of take away Food. This would prevent the potential of crime and disorder and/or public nuisance from persons consuming alcohol in the street outside this venue.

MC 18 - (alcohol) only to be consumed outside the building by persons seated at tables. Alternatively MC70 - (alcohol) only permitted to outside tables and chairs and when ancillary to food. This would prevent public nuisance from 'stand-up' drinking outside the venue.

As the venue has outside tables and chairs and there are residential premises in the area:-

MC 19 - (tables and chairs) to be rendered unusable after specified time or MC 20 - (tables and chairs) to be removed from outside area by specified time such as 23:00 hrs. This would prevent public nuisance from the use of the outside area for licensable activities.

MC 42 - sweeping and washing of pavement and storage of waste. This would prevent public nuisance from waste or other detrius outside the venue from the use of the tables and chairs.

MC 37 - capacity limit as under the previous licence the venue was restricted to 50 persons (excluding staff). This issue may be addressed further by Environmental Health.

Whilst this venue is a small restaurant/deli with a limited external area for tables and chairs the management of the venue were found in May 2016 to be breaching a number of conditions of the then existing Premises Licence. Despite requests to meet with Director(s) of the company (which would have included Mr. Gov the applicant for the new licence) it took until October 2016 to get a meaningful meeting with a 'share-holder' for the Company Mr. Paresh Pandya. However neither the Designated Premises Supervisor at that time nor a Director of the Company attended the meeting. Further after a long discussion about the conditions of the Premises Licence the venue decided to cease selling

alcohol until they felt able to put sufficient management techniques in place to ensure compliance with their licence conditions. As far as I am aware they have not been selling alcohol since October 2016.

I would not wish to adversely affect this small business however I do consider that sufficient safe-guards in the form of appropriate and proportionate conditions are needed to ensure the promotion of the licensing objectives.

CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE AND CONDITIONS PROPOSED BY A PARTY TO THE HEARING

- 8(iv). (1) Sub-paragraph 8(iv)(2) below applies where the permitted price given by Paragraph 8(ii)(b) above on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
 - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Conditions consistent with the operating schedule

- 9. The premises will operate to a high standard, and will do so should this licence be granted in terms of the sale of alcohol. All staff will be fully trained in their responsibilities with regard to the sale of alcohol, and will be retrained every six months, with recorded training records kept for inspection. The DPS will maintain a DPS Written Authorisation Sheet which will show the names of the staff members who have been given delegated authority to make sales of alcohol.
- 10. All current security measures will remain in operation. All staff will be fully trained in this area. Sufficient staff will be on duty at all busy times. Staff will refuse entry to customers who, in their opinion are drunk. CCTV cameras will be in operation during the opening hours and for a period of two hours after closing. The time and date stamp will be correct and will be generated onto both recorded and real time images. A camera will record clear images of all customers from the waist and above at the entrance/exit. Recordings will be maintained for 31 days and, in the event of an incident/investigation of an offence, will be available for Police/responsible authorities to view on request and will be downloaded into a removable format and provided to Police or other responsible authorities within 48 hours of a request.
- 11. In the event of a technical failure the premises licence holder will ensure that the DPS, or other named person in their absence, informs the Licensing Authority and Police as soon as is reasonably practicable. This information will be contemporaneously recorded in the incident report register and shall include the time, date and means this was done and to whom the information was reported. Equipment failures will be repaired without undue delay and the Licensing Authority and Police will be informed when the fault is rectified.
- 12. Staff will be trained to be alert to any potential danger to customers and react accordingly. If they are unable to quickl difuse the situation without risk to customer or staff, then they are instructed to call the police. Effective management and supervision of the premises shall be maintained. The premises shall comply with all current Health and Safety and Fire legislation. There shall be no smoking on the premises and free drinking water shall be made available. There shall be access to licensed taxi and private hire services for customers if required.
- 13. Customers will be requested to leave the premises in a quiet and orderly manner. A sign shall be displayed asking customers to leave the premises quietly.
- 14. Only photographic ID is accepted (passport, driving licence, proof of age card with PASS hologram, and Military ID). Anyone who appears to be under the age of 25 is challenged to provide ID. If the customer is unable to provide identification then no sale is made. No ID no sale. If it is known that a customer intends to purchase

alcohol to provide to minors then that sale will be refused. All refused sales will be recorded in a refusals book, which will be made available for inspection by Police or Licensing Officers of the council on request.

Conditions proposed by the Police and agreed by applicant

- 15. The premises shall install and maintain a comprehensive CCTV system as per the minimum requirements of the Westminster Police Licensing Team. All entry and exit points will be covered enabling frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Viewing of recordings shall be made available immediately upon the request of Police or authorised officer throughout the entire 31 day period.
- 16. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises are open. This staff member must be able to provide a Police or authorised council officer copies of recent CCTV images or data with the absolute minimum of delay when requested.
- 17. A Challenge 25 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram.
- 18. An incident log shall be kept at the premises, and made available on request to an authorised officer of the City Council or the Police. It must be completed within 24 hours of the incident and will record the following:
 - (a) all crimes reported to the venue
 - (b) all ejections of patrons
 - (c) any complaints received concerning crime and disorder
 - (d) any incidents of disorder
 - (e) all seizures of drugs or offensive weapons
 - (f) any faults in the CCTV system,
 - (g) any refusal of the sale of alcohol
 - (h) any visit by a relevant authority or Emergency service
- 19. The supply of alcohol on the premises without food shall only be to a person who is seated, where the supply of alcohol is by waiter or waitress service only and is identified within the revised hatch area plan as per your E-Mail dated 14th April 2017

- 20. The remainder of the premises shall only operate as a restaurant
 - (i) in which customers are shown to their table,
 - (ii) where the supply of alcohol is by waiter or waitress service only,
 - (iii) which provide food in the form of substantial table meals that are prepared on the premises and are served and consumed at the table using non disposable crockery,
 - (iv) which do not provide any take away service of food or drink for immediate consumption,
 - (v) which do not provide any take away service of food or drink after 23.00.

- 14. A log shall be kept detailing all refused sales of alcohol. The log should include the date and time of the refused sale and the name of the member of staff who refused the sale. The log shall be available for inspection at the premises by the police or an authorised officer of the City Council at all times whilst the premises are open.
- Notices shall be prominently displayed at all exits requesting patrons to respect the needs of local residents and businesses and leave the area quietly.
- Prominent signage indicating the permitted hours for the sale of alcohol shall be displayed so as to be visible before entering the premises, where alcohol is on public display, and at the point of sale.
- There shall be no sale or supply of alcohol by draught.
- 18. The premises shall only operate as a restaurant:
 - (i) In which customers are shown to their table,
 - (ii) Which provide food in the form of substantial table meals that are prepared on the premises and are served and consumed at the table using non disposable crockery,
 - (iii) which do not provide any take away service of food or hot drinks for immediate consumption after 23.00hrs Monday to Saturday and after 22.30hrs on Sundays,
 - iv) where intoxicating liquor shall not be sold, supplied, or consumed on the premises otherwise than to persons who are bona fide taking substantial table meals and provided always that the consumption of intoxicating liquor by such persons is ancillary to taking such meals.
- The maximum number of persons accommodated at the premises at any one time (excluding staff) shall not exceed 50 persons.
