#### Core hours When Customers Are Permitted to Be on The Premises

#### Procedure for virtual hearings held under the Licensing Act 2003

The purpose of this procedure is to clarify how the Licensing Sub-Committee ("the Sub-Committee") will conduct virtual licensing hearings made under the Licensing Act 2003 (as amended) and for licensing applications under other regimes. All hearings are conducted with due regard to the Council's Constitution, relevant legislation and case law, regulations and guidance.

#### **Accessing virtual hearings**

Virtual Licensing Sub-Committee hearings will be held on Microsoft Teams as a live Teams event. Each application will be dealt with by a separate Teams meeting. All applicants, responsible authorities and other persons (who have submitted a valid representation) (collectively called "Parties") will be provided with a link to the meeting beforehand. **Only these parties will be able to participate in the hearing** (together with their adviser) provided they have registered, in advance, with the Licensing Authority, as specified below. A link for the general public to watch the meeting will be available on the Council's website.

#### Final Submissions before the Hearing

The parties (or their representatives) should use their best endeavours to ensure that all of their final submissions have been made so as to be included in the Sub-Committee report (typically **no later, than 5.pm, 5 working days** before the Sub-Committee hearing). This means by 5pm on the Thursday, the week before the Sub-Committee hearing is due to take place. Final submissions should set out the key points, policies and conditions that a party wishes the Sub-Committee to take account of in determining the application. Any final submissions that a party wishes to make, (that have not been submitted so as to have been included in the report), **must** be submitted to the Licensing Service by **no later than 12 noon 3 working days** before the hearing is due to take place. The Licensing email address is: Licensing@westminster.gov.uk.

#### **Rules during Licensing Hearings**

The following rules must be followed by all parties to ensure the virtual hearing can progress as successfully as possible:

- All parties wishing to participate in the hearing must register their wish to
  participate in the hearing and provide their email addresses to the Licensing
  Service at Licensing@westminster.gov.uk no later than 12 noon on the Monday
  before the Thursday hearing is scheduled to take place.
- All parties should join the virtual hearing at least 15 minutes before the
  advertised start time to ensure they are ready to start at the advertised start time.
  After the advertised start time has passed no registered parties will be allowed to
  join, except in exceptional circumstances, when permitted by the Chairman, as this
  could disrupt the meeting.
- All parties must only address the hearing when invited to do so by the Chairman.
- All parties must keep their microphones on mute unless they are speaking. The Chairman has the ability to mute all parties' microphones.
- If a party wishes to interject, they should put their name in the messaging field. The chairman has the discretion to invite the party to make their comment at an appropriate stage in the hearing.
- All parties are asked to keep their comments as succinct as possible.

- If a party has a question for another party, this must be addressed to the Chairman who will have the discretion to ask the relevant party to respond.
- Parties wishing to make suggestions as to the conditions that may be imposed in
  the event of the application being granted should do so by reference to the
  schedule of proposed conditions set out in the Conditions Schedule annexed to the
  committee papers. In so doing, they should use the same numbering in that
  schedule. This is to ensure that there is ease of referencing the conditions by all the
  parties.
- To ensure the smooth running of hearings, a time limit will be placed on each party's submissions. This time limit must be adhered to but the Chairman has the flexibility to amend the time limit when it is considered appropriate to do so.
- When referring to the hearing papers, participants should give the page and paragraph number when appropriate.
- The Chairman has the discretion to amend these rules in any given case where they consider it is appropriate to do so.

#### **Procedure**

- 1. The Chairman will open the meeting and introduce the members of the Sub-Committee and the other officers attending with the members, including the legal adviser, policy adviser and committee officer.
- 2. The Chairman will confirm the procedure that the hearing will follow.
- 3. The Sub-Committee members and officers will be asked to declare any interests they may have and any other procedural business will be transacted.
- 4. The presenting officer from the licensing service will introduce the application, giving a brief description of the application and introducing all the Parties in attendance for each application
- 5. Each party who has registered to speak, will be invited to make their representations and will be allowed a maximum of 10 minutes each. In order to ensure that the hearing is fair to all parties and is conducted in an orderly manner, the Chairman has the discretion to extend this time limit where it is appropriate for the determination of the application.
- 6. Parties will normally speak in the following order, (the order may change for other types of licensing applications):
  - a. The applicant
  - b. Responsible authorities
  - c. Other persons
- 7. The Chairman has the right to grant each party the opportunity to ask questions of each other for the purposes of clarification only where it is appropriate to do so. The Sub-Committee members will then be able to ask questions of the parties.

- 8. The legal adviser and/or policy officer may ask questions of the parties as they consider appropriate, including in relation to the conditions which should be attached to the application if the Sub-Committee is minded to grant the application.
- 9. Each party will have an opportunity to make a short closing submission each (not introducing any new evidence or case law) of no more than **5 minutes each**, in the following order:
  - a. Responsible authorities
  - b. Other persons
  - c. The applicant
- 10. The Chairman shall then close the meeting and all parties will leave the meeting. A Decision will not be announced at the end of the hearing unless there is a legal requirement to do so.
- 11. The Sub-Committee will deliberate in closed session and all parties will be advised of the outcome in a written Summary Decision. Unless otherwise required or permitted by Regulations, summary decisions will be made within a period of five working days of the last day of the hearing. The written summary of the decision ("Summary Decision") will be sent to all the parties as soon as possible after the Decision has been made. The full Decision, setting out the reasons for the Decision, (Formal Notification) will be sent to the parties as soon as possible thereafter. The time limit for appealing will not commence until the Formal Notification has been sent to the parties.

With reference to the above, I am writing to inform you that the Metropolitan Police, as a responsible authority, are making a representation against this application.

The venue is situated within the Cumulative Impact Area. It is our belief that if granted, the application would undermine the Licensing Objectives in relation to The Prevention of Crime and Disorder.

Following agreement of conditions with the applicant, The Metropolitan Police withdrew their representation on 6<sup>th</sup> September 2021.

I write in relation to the application submitted for a variation of the premises licence for Wands & Wizard Exploratorium, 26 Greek Street, London, W1D 5DE

As a responsible authority under section 13 (4) of the Licensing Act 2003 as amended under the Police and Social Responsibility Act 2011, the Licensing Authority have considered your application in full. The Licensing Authority has concerns in relation to this application and how the premises would promote the four Licensing Objectives:

- Public Nuisance
- Prevention of Crime & Disorder
- Public Safety
- Protection of children from harm

The application seeks the following:

 To Regularise changes to the authorised layout of the premises as shown on the plans appended to the application, including the addition of the basement and third floor to the licence demise.

Add the following associated works condition:

"No licensable activities shall take place at the premises until the licensing authority are satisfied that the premises is constructed or altered in accordance with the appropriate provisions of the District Surveyor's Association – Technical Standards for Places of Entertainment and the reasonable requirements of Westminster Environmental Health Consultation Team, at which time this condition shall be removed from the licence by the licensing authority. Amended plans shall be substituted and lodged with the Licensing Authority in the event there has been minor changes to layout."

Add the following new condition to the premises licence:
 "The licensable activities authorised by this licence and provided at the premises shall be ancillary to the main function of the premises as a shop and venue providing magical and theatrical entertainment."

- Replace existing premises licence condition 17 with the following:
   Alcohol may only be supplied to:
  - a) Persons attending a pre booked and bona fide private:
  - (i) magical/theatrical experience;
  - (ii) class or seminar;
  - (iii) function or event; or
  - b) Persons on the ground, first, second or third floors which shall operate as a restaurant:
  - (i) in which customers are shown to their table,
  - (ii) where the supply of alcohol is by waiter or waitress service only,
  - (iii) which provide food in the form of substantial table meals that are prepared on the premises and are served and consumed at the table using non disposable crockery, (iv) which do not provide any take away service of food or drink for immediate consumption,
  - (v) which do not provide any take away service of food or drink after 23:00 and (vi) where alcohol shall or be sold or supplied, otherwise than for consumption by persons who are seated in the restaurant and bona fide taking substantial table meals there and provided always that the consumption of alcohol by such persons is ancillary to taking such meals; or

Notwithstanding condition [17], alcohol may be supplied before 21:00 on the ground, first, second or third floors by up to a maximum at any one time of 20 seated persons.

- Amend existing condition 26 to: "The number of persons permitted on the premises for licensable activities at any one time (excluding staff) shall not exceed 50."
- To add authorisation for the sale of alcohol for consumption off the premises until 11pm Monday to Saturday and 10.30pm on Sundays, subject to the following new condition: "The sale and supply of alcohol for consumption off the premises shall be restricted to sealed containers only, except for alcohol consumed at appropriately authorised outside tables and chairs which shall be served by waiter or waitress service, served only to a person seated"

The premises are located within the West End Cumulative Impact Area and as such various policy points must be considered, namely CIP1, COMB1 and PB1.

#### Policy CIP1 states:

A. It is the Licensing Authority's policy to refuse applications within the West End Cumulative Impact Zone for: pubs and bars, fast food premises, and music and dancing and similar entertainment, other than applications to:

- 1. Vary the hours within Core Hours under Policy HRS1, and/or
- 2. Vary the licence to reduce the overall capacity of the premises.
- C. Applications for other premises types within the West End Cumulative Impact Zones will be subject to other policies within this statement and must demonstrate that they will not add to cumulative impact.

#### Policy COMB1(B) states:

Applications inside the West End Cumulative Impact Zones for premises that propose to operate as a 'combined use premises' will be considered on their merits and subject to:

- 1. The application meeting the requirements of policies CD1, PS1, PN1 and CH1.
- 2. The hours for licensable activities for the relevant premises use being within the council's Core Hours Policy HRS1.
- 3. The applicant demonstrating that they will not add to cumulative impact within the Cumulative Impact Zone.

In accordance with COMB1(B) the applicant is required to make further submissions in respect of the operation of the premises and demonstrate that the grant of the application will not add to

cumulative impact with particular reference to the increase of the licensable area and the proposed increase in capacity.

The Licensing Authority note that the premises trade predominantly as a restaurant and have proposed Westminster's model restaurant condition (model condition 66) however it is also noted that this will only come into effect at 21:00 and therefore before 21:00 the premises will be able to trade as a bar albeit with a requirement that customers are seated and limited to a maximum capacity of 20 persons.

The Licensing Authority would seek further submissions from the applicant as to how the premises is proposing to trade prior to 21:00 in order to assess whether the application needs to be further considered under other relevant policies such as PB1 and RTN1. For example, before 21:00 the premises intend to operate with a bar function therefore policy PB1(B) is relevant and as such the applicant would need to provide exceptional circumstances as to why the application should be granted when the policy is to refuse.

The Licensing Authority's policies, in relation to the Cumulative Impact Areas, are directed at the global and cumulative effects of licences on the area as a whole. The Licensing Authority encourages the applicant to provide further submissions as to how the premises will not add to cumulative impact in the cumulative impact area, as per policy CIP1 and COMB1.

The applicant is also required to provide further submissions in respect of the Off Sale provision which is now sought and what this will consist of?

Subject to any further submissions, It will be for Licensing Sub-Committee Members to determine this application, given its location within the West End Cumulative Impact zone and the proposed style of operation.

The Licensing Authority looks forward to receiving further submissions from the applicant in due course.

objects to this application as it is currently presented, on the grounds of prevention of crime and disorder, prevention of public nuisance, public safety and cumulative impact in the West End Cumulative Impact Area.

**About** 

is a charitable company limited by guarantee established in 1972. The society is a recognised amenity group and was formed to make Soho a better place to live, work or visit by preserving and enhancing the area's existing diversity of character and uses, and by improving its facilities, amenities and environment. In particular, the society supports the Westminster City Council's policies, including the cumulative impact policy, as set out in the Statement of Licensing Policy.

- Notwithstanding condition (17), alcohol may be supplied before 21.00 on the ground, first, second or third floors by up to a maximum at any one time of 20 seated persons.

• amend existing condition to 26 to: the number of persons on the premises for licensable activities at any one time (excluding staff) not exceed 50.

#### **PART E**

• To add authorisation for the sale of alcohol for consumption off the premises until 11 pm Monday to Saturday and 10:30 pm on Sundays, subject to the new condition: The sale and supply of alcohol for consumption off the premises shall be restricted to sealed containers only, except for alcohol consumed at appropriately authorised outside tables and chairs which have been served by waiter service, served only to a person seated.

#### The Position

- The application: Members of the licensing committee attended the premises where they discussed the nature of the operation and the proposed application. These premises are small and present as a quirky entertainment place, offering a magic wand experience, afternoon teas and a potion experience (alcoholic and non alcoholic) for families, adults and groups, they also propose to offer off sales of their own gin and beer. We note the application seeks to permit bar use for on sales on the ground, 1st, 2nd and 3rd floors for 20 people seated until 21:00, and off sales to authorised tables and chairs until 23:00, the objects to these proposed changes. We do not object to the off sales of their own gin and beer and ask that off sales be restricted to these products.
- We are concerned this application provides the opportunity for these premises to turn into a
  drinks focussed experience in the West End Cumulative Impact Zone and in an area with the
  highest concentration of licensed premises. In our view this application if granted will fail to
  promote the licensing objectives of the prevention of crime and disorder and public nuisance
  and increase cumulative impact in the West End Cumulative Impact Zone.
- Licensed premises: Soho is at the forefront of evening and night time economy in Westminster with its numerous restaurants, bars and members clubs and entertainment establishments. The small area comprising of Greek St, Old Compton St, Frith and Dean St contains the largest number of licensed premises in Soho, there are over 106 such premises offering the full range of venues with opening hours up to 3.30am. These streets are already saturated with premises serving alcohol and can accommodate no more.

#### Statement of Licensing Policy 2021

This application as presented is contrary to the Pubs & Bars Policy PB1, and Cumulative Impact Policy CIP1.

• Public Houses and Bars Policy PB1; it is the Licensing Authority's policy to refuse applications within the West End Cumulative Impact Zone other than, '1. Applications to vary the existing licence hours within the council's Core Hours Policy HRS1, 2. Applications to seek to vary the existing license so as to reduce the overall capacity of the premises.' The policy also states an exception may be permitted to applications no later than 9pm, if they meet other policies in the statement which include CD1 and PN1. It goes on, under the reasons for this Policy, F10 states, '.... Premises that primarily serve alcohol, with or without the provision of any ancillary playing of music, can give rise to public nuisance for residents and other

businesses, particularly with there is a concentration of such premises. This is principally due to noise from the premises and from patrons when they leave. Pubs and bars present opportunities for crime and they can also give rise to disorder.' The council's own policy clearly highlights the negative impact of pubs and bars on residents. In our view there is no exception in this case, it will fail to promote the licensing objectives CD1 and PN1 and should be rejected on these grounds.

- Cumulative Impact Policy CIP1; this area has been identified by the Westminster City Council as under stress because of the cumulative effect of the concentration of late night and drink led premises and night cafes has led to serious problems of disorder and/or public nuisance affecting residents, visitors and other businesses. The Cumulative Impact Assessment 2020 highlights the cumulative impact in the West End Zone, 1(p.9) stating, 'The rate of incidence per square kilometre here, as well as the rate of license premises per square kilometre, was approximately nine times than the borough average rat. For crimes in particular, the rate was 10–13 times higher between 6pm 6am compared to the borough's average.' In relation to the impact of bars in an area, F82 states, 'among specific premises types assessed within the CIA, pubs and bars were one of the top licensed premises operation types that were most significantly aligned with incidents in their proximity.'
- The policies in relation to the cumulative impact zone are directed at the global and cumulative effects of licences on the area as a whole (D16. of the policy). The policy provides an assumption to refuse pubs and bars, music and dance venues and fast food premises, the policies are intended to be strict and will only be overridden in genuinely exceptional circumstances (D.11 of the policy). The growth in the number of licensed premises in Soho has led to a marked deterioration in the quality of life and well-being of local residents and it has jeopardised the sustainability of the community. Soho has a substantial residential community and many of these residents suffer from problems such as, but not limited to, high levels of noise nuisance, problems with waste, urinating and defecating in the streets, threats to public safety, anti-social behaviour, crime and disorder and the change in character of this historic area.

#### The Licensing Objectives

The Statement of Licensing Policy 2021 or Section 182 Guidance does not provide for any circumstance, including exceptional or otherwise, which would permit an application to be granted if the licensing objectives were harmed. We now consider the impact of this application on these objectives.

#### **Prevention of Crime and Disorder - CD1**

Under this Policy the criteria applied is, 'whether the premises make or will make a significant contribution to levels of crime and disorder, and whether the operating schedule is based on an adequate risk assessment, undertaken by the applicant, which takes account of all the relevant considerations below to reduce the likelihood of crime and disorder occurring as a result of the grant of the application.'

The recently published Cumulative Impact Assessment 2020 presents overwhelming evidence of the year on year increase in cumulative impact in the West End Zone 1, *it highlights the rate of crime as 10 - 13 times higher between 6pm - 6am compared to the borough average.* It goes on to detail the number and types of crimes in the West End,

- Public realm crimes: (serious violence, robberies, theft and drug offences), alcohol-related callouts incidents, anti-social behaviour and demands on services were prevalent in Westminster between 2017 and 2019, among the highest in London and the country. All incidents observed concentrated in the West End many occurring in the evening and at night as well as weekends.
- Total incident type 2017-2019: serious violent crimes Night, 795 proportion of Borough's

incidents (31%). Robberies Night, 2237 (33%). Theft and Handling Night, 24,407 (33%). Drug Offences Night, 1529 (40%). Noise Complaints Night, 1389 (16%). Reactive Waste Management, 6630 (10%). Ambulance call outs to locations of licensed premises, 5353 (22%). Anti-Social behaviour on transport Night, 592 (13%), Anti-Social behaviour MPS, 9662 (16%). Total = 50,594.

- Data description of incidents in 2017-2019 found all incident categories observed varied both in space and time. Many occurred in the evening and at night and on weekends when alcohol related activities typically peak. Incidents where primarily concentrated in the West End where licensed premises are disproportionally concentrated.
- **Robberies**: clustered within the West End, Charing Cross, Oxford Street in the evening and night.
- Serious violent crimes: recorded between 6pm and 6am concentrated overwhelmingly in the West End.
- **Drug related crimes**: Westminster recorded the highest volume of drug offences of any borough between 2017-2019. Half of crimes were reported (48%) in the evening and night time. Drug related crimes between **6pm 6am** were significantly clustered in and around the West End to varying degrees.
- **Theft and Handling:** most common crime type in the borough, in the evening and night they are particularly concentrated in the West End and along Oxford Street.

Crime statistics (September 2019 to February 2020) for this area supports the findings of the CIA, the overall total of crimes being **1,397**.

**Old Compton St**: Robbery = 19. Theft person = 162. Violence with injury = 47. All crime = 429

**Wardour St**: Robbery = 6. Theft from person = 70. Violence with injury = 22. All crime = 301

**Dean St**: Robbery = 12, Theft person = 57, Violence with injury = 30, All crime = 280.

Greek St: Robbery = 12, Theft person = 76, Violence with injury = 33, All crime = 244

**Frith St**: Robbery = 13, Theft person = 46, Violence with injury = 23, All crime = 143.

For residents living in Soho the findings of the Cumulative Impact Assessment is unsurprising, Soho transforms in the evening and night-time into an area which feels very unsafe and where levels of crime and disorder are high. As evidenced above criminal activity associated with the large number of venues and the large numbers of people on the streets (including following the lifting of COVID restrictions) results in high levels of serious crime.

To add another premises functioning as a bar in area already saturated will only increase crime and disorder and fail to promote the licensing objectives.

#### **Prevention of Public Nuisance Policy PN1**

Under this Policy the criteria applied states, 'the potential for nuisance associated with the style, characteristics and activities of the business to be carried on at the premises and the potential steps which could be taken to reduce the risk of a nuisance occurring. This will particularly apply in areas of residential accommodation and where there is residential accommodation in the proximity of the premises.'

Residents live along the length of Greek St and all dispersal routes from these premises, residents already suffer from late night noise, disturbance (pedicabs playing loud music, waiting taxis) anti-social behaviour including street fouling and high levels of crime and disorder from

the existing number of licensed premises in the area. We are particularly concerned that these residents will be disturbed by intoxicated people leaving these premises.

#### In summary

The application proposes a new bar in the West End Cumulative Impact Area, evidence presented within this representation highlights how this application if granted will fail to support the licensing objectives and increase cumulative impact.

- 5. **Outdoor Spaces:** Monday to Thursday: 9am to 11.30pm. Friday and Saturday: 9am to 12am. Sunday: 9am to 10.30pm. Sundays immediately prior to a bank holiday: 9am to 12am.
- 6. **Pubs and bars, Fast Food and Music and Dance venues:** Monday to Thursday: 10am to 11.30pm. Friday and Saturday: 10am to 12am. Sunday: 9am to 10.30pm. Sundays immediately prior to a

bank holiday: 12pm to 12am.

- 7. **Qualifying Clubs:** Monday to Thursday: 9am to 12am. Friday and Saturday: 9am to 12am. Sunday: 9am to 10.30pm. Sundays immediately prior to a bank holiday: 9am to 12am.
- 8. **Restaurants:** Monday to Thursday: 9am to 11.30pm. Friday and Saturday: 9am to 12am. Sunday: 9am to 10.30pm. Sundays immediately prior to a bank holiday: 9am to 12am.
- 9. **Sexual Entertainment Venues and Sex Cinemas**: Monday to Thursday: 9am to 11.30pm. Friday and Saturday: 9am to 12am. Sunday: 9am to 10.30pm. Sundays immediately prior to a bank holiday: 9am to 12am.
- D. Core hours are when customers are permitted to be on the premises and therefore the maximum opening hours permitted will be to the same start and terminal hours for each of the days where licensable activity is permitted.

- 2. The current and proposed use of the premises.
- 3. When those uses will take place.

4. What the primary use of the premises is or the uses that will take place in different parts of that premises.
5. Whether there would normally be a presumption to refuse an application for that use if it was operating as that premises type and not a combined use premises.
6. Whether the hours sought for the all or parts of the premises are within or outside the Core Hours.
D. The Licensing Authority will take into account, when considering the application, the relevant considerations from each of the appropriate premises uses policies within this statement
E. For the purpose of this policy a Combined Use Premises means premises which require a premises licence and where there is more than one premises use, and where the uses are not dependent on/



- 2. No supply of alcohol may be made at a time when the designated premises supervisor does not hold a personal licence or the personal licence is suspended.
- 3. Every supply of alcohol under this licence must be made or authorised by a person who holds a personal licence.

4.

- (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
  - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to;
  - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
  - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
  - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
  - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
  - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
  - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 5. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

6.

- (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
  - (a) a holographic mark, or
  - (b) an ultraviolet feature.
- 7. The responsible person must ensure that—
  - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
    - (i) beer or cider: ½ pint;
    - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
    - (iii) still wine in a glass: 125 ml;
  - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
  - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

A responsible person in relation to a licensed premises means the holder of the premise licence in respect of the premises, the designated premises supervisor (if any) or any individual aged 18 or over who is authorised by either the licence holder or designated premises supervisor. For premises with a club premises certificate, any member or officer of the club present on the premises in a capacity that which enables him to prevent the supply of alcohol.

- 8(i) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 8(iii). Where the permitted price given by Paragraph 8(ii)(b) above would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

8(iv).

- (1) Sub-paragraph 8(iv)(2) below applies where the permitted price given by Paragraph 8(ii)(b) above on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

#### Annex 2 – Conditions consistent with the operating Schedule

- 9. A record shall be kept detailing all refused sales of alcohol. The record shall include the date and time of the refused sale and the name of the member of staff who refused the sale. The record shall be available for inspection at the premises by the police or an authorised officer of the City Council at all times whilst the premises is open.







In the past we have seen that the bar that was supposed to close at 11 pm would still have people on the road till about 12.30/1 am and even after numerous complaints and discussions nothing could be accomplished as people used to be so drunk and anything said to them used to create more issues for us (the residents)

It seems the new licence is now being done for live music/recorded music with public speaker and poker game club. The licence is being asked for 7 days from 11 am to 11 pm. This would create so much noise and social issues in the area. We are very nervous as this would just become unbearable if this licence is granted.

If any licence is to be given, which we strongly object to, then following things should be ascertained:

- No table/chair on the pavement at all. It is a narrow pavement and restricts walking. Also anything on the pavement amplifies the noise in the area as poeple end up drinking and talking loudly till late in the night
- Maybe 5 day licence so that residents can at least get some relief in the area as opposed to everyday noise/social issues

Our comments are made as an Amenity Society recognised by Westminster City Council. We are officially charged with working towards the preservation and enhancement of the architectural and environmental quality of Little Venice, Maida Vale and the Paddington Waterway area (including planning and licensing issues).

We recognise that these premises are run as a business and we are aware that it has to be a viable operation. We are very keen to ensure that an appropriate balance is maintained between the legitimate rights of business and the equally legitimate and important rights of nearby residents.

Our representation is made on the basis of the likely effect on the 'prevention of public nuisance' licensing objective.

We understand the application is for a new 'club premises certificate' under Licensing Act 2003, which is a different type of permission to a 'premises licence', which is the current authorisation permitting sale of alcohol and recorded music at the premises. We believe the key difference is that a premises licence permits sale of alcohol/provision of entertainment to the general public, whereas a club premises certificate does not - but is less regulated as a result.

We understand a 'qualifying' club may hold a club premises certificates. Which means it must have at least 25 members and meet the qualifying conditions set out in the Act. As such the grant of a club premises certificate means it would be entitled to certain benefits. We also understand that a qualifying club is not the same as a proprietary club, which is run as a business for a profit.

There is not much information available on the applicant or the Club, which makes us ask whether they meet the qualifying conditions in order to hold a club premises certificate in any event?

We note there is a decrease in the closing time and recorded music from that currently permitted under the premises licence. Although live music has been included in the application, this is in fact not licensable between the hours requested – however, we would need to know how the applicant intends to eliminate noise emanation.

We realise that a premises licence exists already, however we feel that if the licensing authority is minded to grant the application, there must be robust and enforceable conditions added to the certificate. We ask that the applicant provides much more information about the proposed operation so that we can properly assess the risks and what we will ask for should the authority grant the application.

In any case, we would ask you to take into account any local objections that may have been raised.

I write to make a relevant representation in respect of this application. Representation is therefore based largely on the licensing objective of 'prevention of public nuisance', although depending on the nature of the proposed operation it may engage one or more of the other licensing objectives.

I am writing on behalf of the which represents all the residents of Clarendon Court, 33 Maida Vale, which is a large block of 100 flats which has its front easterly facing side and main entrance on Maida Vale, its north side on Clarendon Terrace and the west side on Lanark Place. It is approximately 12 metres from the premises, 4 Clarendon Terrace, off which the roadway accounts for approximately 7.5 m. All the flats on the north side face the proposed club. Other flats at the rear, i.e. on the west side overlook Lanark Place. There are six floors and flats on each floor. A number of the flats are occupied by families with young children.

Clarendon Terrace and Lanark Place are predominately residential. The few business premises on Clarendon Terrace have always been small, quiet operations with minimal impact on the residential nature of the area, such as a small clothing alterations shop, the offices of an interior design company. The current licensed premises at No.4 has always been very quiet causing little or no disruption. No.4 is directly below the residential block Blomfield Court and directly opposite Clarendon Court.

The through road from Maida Vale, via Clarendon Terrace and Lanark Place, to Clifton Road, (which avoided the traffic lights at the junction with Clifton Road), was blocked off many years ago, to avoid traffic in that area. In consequence, Clarendon Terrace and Lanark Place are a dead end. There is very limited car parking in these streets, apart from the private car park under Clarendon Court. Residents usually walk from the main entrance of Clarendon Court down Clarendon Terrace to the shops on Clifton Road and they currently feel very safe taking their children along that route away from the heavy traffic on Maida Vale.

The premises previously operated under a premises licence ref: 11/01922/LIPDPS. The application is for a new 'club premises certificate' under Licensing Act 2003. We do not know if the applicant has any link with the previous operation.

The application seeks permission to supply alcohol and provide 'regulated entertainment' such as recorded music and live music. I am advised that a 'club premises certificate' is a different type of permission to a 'premises licence', which is the current authorisation permitting sale of alcohol and recorded music at the premises. The key differences are that a premises licence permits sale of alcohol/provision of entertainment to the general public, whereas a club premises certificate does not. However, a premises licence is more heavily regulated. The application for the club premises certificate states that 'THE CLARENDON MEMBERS CLUB IS AN EXCLUSIVE CLUB FOR PAID MEMBERS WHICH IN TURN PROVIDES ENTERTAINMENT FOR ITS MEMBERS AT EXCLUSIVE EVENTS'. The hours sought are:

Supply/ sale by retail of alcohol -11 am to 11 pm Mon-Sun

Live music -same hours

Recorded music -same hours

Anything similar -same hours

Hours club premises are open to members and guests -same hours.

There is no information available in the application or on line as to what the 'Clarendon Members Club' is; whether it has previously been situated elsewhere; whether it is, on the

contrary, a new venture; what the target membership is; how many members they have; what the membership cost is; how people join; etc

We understand that only a 'qualifying' club may hold a club premises certificates. In order to be a qualifying club, a club must have at least 25 members and meet the qualifying conditions set out in the Act. The grant of a club premises certificate means that a qualifying club is entitled to certain benefits. These include:

- the authority to supply alcohol to members and sell it to guests on the premises to which the certificate relates without the need for any member or employee to hold a personal licence;
- more limited rights of entry for the police and authorised persons because the premises are considered private and not generally open to the public; and
- exemption from orders of the magistrates' court for the closure of all licensed premises in an area when disorder is happening or expected.

The qualifying conditions set out in the Act include:

- that the club is established and conducted in good faith as a club
- that the club has at least 25 members.
- that alcohol is not supplied, or intended to be supplied, to members on the premises otherwise than by or on behalf of the club.
- that no arrangements are, or are intended to be, made for any person directly or indirectly to derive any pecuniary benefit from the supply of alcohol by or on behalf of the club to members or guests, apart from-
- (a) any benefit accruing to the club as a whole, or
- (b) any benefit which a person derives indirectly by reason of the supply giving rise or contributing to a general gain from the carrying on of the club.

We understand that a qualifying club is not the same as a proprietary club, which is run as a business for a profit. Given the uncertain nature of the applicant Club, is a club premises certificate the appropriate permission? Has the licensing authority assessed whether they meet the qualifying conditions in order to hold a club premises certificate?

Although there has been an alcohol licence at the premises for a number of years, we are concerned that this new operation would bring more intensity of use and a different style of operation. It would also mean that no Designated Premises Supervisor would have to be specified, nor would a personal licence holder be needed to oversee sales of alcohol. We have specific concerns about:

As we have explained, Clarendon Terrace is a narrow street which is essentially residential in nature. The proposed new club could have a significantly detrimental impact on the residents of the surrounding apartment blocks and houses on Lanark Place. Examples being noise emanating from the club and its surrounding area, traffic problems and general disruption in what is a predominately residential area.

First, if it leads to additional noise it could be hugely upsetting for residents as it is very close to the north side of Clarendon Court the RTM building, where many flats are occupied by families with small children who would be trying to sleep during the later hours that the club is open. More generally, many residents would be going to sleep around the time the club was closing, when people might be spilling out on the road as they leave.

Secondly, there is parking on either side of the road and, and as it is a narrow road, only one vehicle can pass down the middle of the road at any time. If there are two in the street at one time, vehicles have to back up and allow the other vehicle to pass. It is a dead end, but it leads to the Clarendon Court car park which houses about 80 cars. As it stands, it is necessary to be cautious in travelling down that street due to its size. If there were large numbers of additional taxis dropping or collecting, or other cars trying to park in the area as a result of the club there is simply no space and this again could be incredibly disruptive and potentially dangerous as it might back up onto the main road at Maida Vale, which is a very busy road close to traffic lights with the junction of St Johns Wood Road.

Thirdly, if there were people spilling out onto the street to smoke and drink, the pavement is narrow and there is simply no space to do so without blocking the pavement and possibly also the road. We know from the recent pandemic that outside space has been utilised to avoid difficulties inside and there is simply no opportunity for this to happen without increasing the noise and impacting adversely on the area.

We understand that Policy QUC1 sets out the licensing authority's approach to 'qualifying clubs'

and club premises certificates. This states that applications 'will be considered on their own merits and subject to the application demonstrating that the operation of the club will promote the licensing objectives, the location where the club will operate, the proposed hours, the proposed licensable activities and whether they meet the specific conditions for a Qualifying Club.'

Overall, we feel that this small residential enclave is a highly inappropriate location for a Club Premises providing music and alcohol.

The potential impact of the differences between these two types of certificates is troubling. Clarendon Terrace is a narrow street which is essentially residential in nature. The proposed new club could have a significantly detrimental impact on the residents of the surrounding apartment blocks and houses on Lanark Place.

4 Clarendon Terrace does have a premises licence but not a club premises certificate. I understand that a club premises certificate is less heavily regulated. There is no information available in the application or online as to what the 'Clarendon Members Club' is; whether it has previously been situated elsewhere; whether it is, on the contrary, a new venture; what the target membership is; how many members they have; what the membership cost is; how people join; etc

My concern is that the proposed club could bring more intensive use and greater disruption. More noise from music and members leaving late in the evening. More traffic in what is a culde-sac. There is the possibility of the pavement being blocked by people exiting the club for a cigarette. Clarendon Terrace is used as a pedestrian cut through to Clifton Road, away from the busy traffic and polluted air of Maida Vale.

The area is residential and is a quiet enclave, even though it is a short distance from the shops at Clifton Road. The few business premises in Clarendon Terrace (apart from the licensed premises) have always been small, quiet operations with minimal impact on the residential nature of the area, such as a small alteration shop and the offices of an interior design company.

My specific concerns are:

clubs...please!

First, if it leads to additional noise it could be hugely upsetting for residents as it is very close to the north side of Clarendon Court the RTM building, where many flats are occupied by families with small children who would be trying to sleep during the later hours that the club is open.

Secondly, there is parking on either side of the road and, and as it is a narrow road, only one vehicle can pass down the middle of the road at any time. If there are two in the street at one time, vehicles have to back up and allow the other vehicle to pass. I am a resident of Clarendon Court and I understand that an application has been made for permission to turn the present use of the above premises from its existing use as a bar into a club.

I wish to object strongly to this application as it would have an adverse affect on the whole of the surrounding area.

In the first instance Clarendon Terrace is a T junction so there is no through traffic. There is only access to underground parking in Clarendon Court or limited surface parking.

This means that if the application was granted the street would be jammed up with visitors to the club trying to park and taxis dropping people off and picking them up.

This would of course make life much more difficult for residents trying to park on or just off Clarendon Terrace or merely to gain access to the underground car park.

It should also be noted that Clarendon Terrace is a narrow street. I believe that the road width is just slightly over 7.5 metres which means that vehicles pass each other with difficulty having to pull into the sides as much as possible. A new club premises would simply exacerbate the situation.

The next problem is that a successful application would give rise to anti social behaviour such as drunkenness, noise, violence and possibly drug dealing.

This may necessitate the police having to be called on many occasions.

It must be remembered that this is a residential neighbourhood with families and children and in consequence any consent to this application would be extremely detrimental to the entire area.

We are writing to object in the strongest possible terms to the granting of a Club Premises Licence at the above premises recently submitted by Clarendon Members Club Limited.

We object to the licence being granted for the following reasons:

- The application includes a licence for live and recorded music. Live music in particular will produce unacceptable levels of intrusive noise in this largely residential neighbourhood.
- 2. No provision is made within the proposed plans for noise attenuation at source and for the proper control of intrusive noise affecting neighbours.
- 3. The proposed closing time will mean increased street noise and possible disturbances after 11pm which will be wholly unacceptable to local residents.

# 3. Policy & Guidance

- 3. Whether there is residential accommodation in the proximity of the premises that would likely be adversely affected by premises being open or carrying out operations at the hours proposed.
- 4. The proposed hours of the licensable activities and when customers will be permitted to remain on the premises.
- 5. The proposed hours when any music, including incidental music, will be played.
- 6. The hours when customers will be allowed to take food or drink outside the premises or be within open areas which form part of the premises.
- 7. The existing hours of licensable activities and the past operation of the premises (if any) and hours of licensable premises in the vicinity.

- 8. Whether customers and staff have adequate access to public transport when arriving at and leaving the premises, especially at night.
- 9. The capacity of the premises.
- 10. The type of use, recognising that some venues are more likely to impact the licensing objectives than others; for example, pubs and bars are higher risk than theatres, cinemas and other cultural and sporting venues due to the nature of the operation.
- 11. The Licensing Authority will take into account the active measures proposed for a 'winding down' period including arrangements for people to be collected from the premises to travel home safely.
- 12. Conditions on hours may be attached that require that the supply of alcohol for consumption on the premises ceases a suitable period of time before customers are required to leave the premises.
- 13. The council, acting as the Licensing Authority, may reduce hours if, after review, it is necessary to impose conditions specifying shorter hours in order to promote the licensing objectives.
- 14. Specific days for non-standard hours should be identified and justified as part of the application to allow responsible authorities and interested parties to evaluate the impact that these licensable activities may have, and to plan accordingly. The consideration of applications for later hours for Bank Holiday Mondays will take into account that later hours are generally granted for preceding Sundays and that the next day is a working day. Non-specific days are expected to be covered by Temporary Event Notices or variation applications.

- 3. The operation of any delivery services for alcohol and/or latenight refreshment meeting the council's Ancillary Delivery of Alcohol and/or Late-Night Refreshment Policy DEL1.
- 4. The applicant has demonstrated that they will not add to cumulative impact within the Cumulative Impact Zone.
- 5. The application and operation of the venue meeting the definition for a Qualifying Club as per Clause C.
- C. For the purpose of this policy a Qualifying Club for the sale of alcohol for members and guests will meet the requirements of the

general conditions in section 62, and the additional conditions in Section 64 of the Licensing Act 2003

# 4. Equality Implications

The Council in its capacity as Licensing Authority has a duty to have regard to its public sector equality duty under section 149 of the Equality Act 2010. In summary, section 149 provides that a Public Authority must, in the exercise of its functions, have due regard to the need to:

- (a) eliminate discrimination harassment, victimisation and any other conduct that is prohibited by or under this Act;
- (b) advance equality of opportunity between persons who share a relevant protected characteristic and persons who do not share it; and
- (c) foster good relations between persons who share a relevant protected characteristics and persons who do not share it.

Section 149 (7) of the Equality Act 2010 defines the relevant protected characteristics as age, disability, gender reassignment, marriage and civil partnership, pregnancy and maternity, race, religion or belief, sex, and sexual orientation.







#### Good afternoon

Thank you for your comments in respect of the above application.

Westminster encourage mediation between the parties. I attach an email which has been received from the applicant providing further information in respect of the application. I have been asked to circulate this to all of the interested parties.

You will note that the applicant is now withdrawing live music from the application.

In addition, following consultation with the Metropolitan Police, the applicant has agreed a number of additional conditions as set out below. On that basis, the Police have not objected to the application:

- 1) (a) The premises shall install and maintain a comprehensive CCTV system as per the minimum requirements of the Westminster Police Licensing Team.
- (b) All entry and exit points will be covered enabling frontal identification of every person entering in any light condition.
- (c) The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises and will include the external area immediately outside the premises entrance.
- (d) All recordings shall be stored for a minimum period of 31 days with date and time stamping.
- (e) Viewing of recordings shall be made available immediately upon the request of Police or authorised officer throughout the entire 31-day period.
- 2) A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises is open. This staff member must be able to provide a Police or authorised council officer copies of recent CCTV images or data with the absolute minimum of delay when requested.
- 3) There shall be a personal licence holder on duty on the premises at all times when the premises are authorised to sell alcohol.

- 4) A minimum of one (1) SIA licensed door supervisors shall be on duty at the premises at all times whilst it is open for business and they must correctly display their SIA licence(s) when on duty so as to be visible.
- 5) There shall be no sales of alcohol for consumption off the premises
- 6) Waiter / waitress service shall be available throughout the whole of the premises.
- 7) Challenge 25 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram.
- 8) An incident log shall be kept at the premises, and made available on request to an authorised officer of the City Council or the Police. It must be completed within 24 hours of the incident and will record the following:
- (a) all crimes reported to the venue
- (b) all ejections of patrons
- (c) any complaints received concerning crime and disorder
- (d) any incidents of disorder
- (e) all seizures of drugs or offensive weapons
- (f) any faults in the CCTV system
- (g) any refusal of the sale of alcohol
- (h) any visit by a relevant authority or emergency service.
- 9) Alcohol may only be sold for consumption by members of a private club and their bona fide guests (not exceeding (4) guests per member). No person shall be admitted to membership of the private club or be entitled to take advantage of any of the privileges of membership without an interval of at least 48 hours between their nomination or application for membership and their admission.
- 10) A list of the names and addresses of members of the Club shall be kept on the premises at all times together with a book showing the names and dates of attendance of any guests introduced by members. Both the list and the book shall be produced on demand for inspection by the Police or an authorised officer of the Council.

I would be grateful if you could confirm if the additional measures proposed by the applicant have addressed your concern and whether you wish to withdraw your objection at this stage?

  - games or other activities which require or encourage, or are designed to require or encourage, individuals to;
  - drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
  - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
  - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);
  - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;
  - (d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on;
  - (i) the outcome of a race, competition or other event or process, or
  - (ii) the likelihood of anything occurring or not occurring;
  - (e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
- 5. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 6. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.
- 7. (1) The premises licence holder or club premises certificate holder shall ensure

- that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
- (2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.
- 8. The responsible person shall ensure that;
  - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures;
  - (i) beer or cider: ½ pint;
  - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
  - (iii) still wine in a glass: 125 ml; and
  - (b) customers are made aware of the availability of these measures.

A responsible person in relation to a licensed premises means the holder of the premise licence in respect of the premises, the designated premises supervisor (if any) or any individual aged 18 or over who is authorised by either the licence holder or designated premises supervisor. For premises with a club premises certificate, any member or officer of the club present on the premises in a capacity that which enables him to prevent the supply of alcohol.

- (f) On New Year's Eve on a Sunday, 12:00 to 22:30
- (g) On New Year's Eve from the end of permitted hours on New Year's Eve to the start of permitted hours on the following day (or, if there are no permitted hours on the following day, 00.00 midnight on 31st December).

NOTE - The above restrictions do not prohibit:

- during the first twenty minutes after the above hours the consumption of the alcohol on the premises;
- (b) during the first twenty minutes after the above hours, the taking of the alcohol from the premises unless the alcohol is supplied or taken in an open vessel;
- (c) during the first thirty minutes after the above hours the consumption of the alcohol on the premises by persons taking table meals there if the alcohol was supplied for consumption as ancillary to the meals;
- (d) the sale or supply of alcohol to or the consumption of alcohol by any person residing in the licensed premises;
- the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;
- (f) the sale of alcohol to a trader or registered club for the purposes of the trade or club;
- (g) the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces;
- (h) the taking of alcohol from the premises by a person residing there;
- the supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied;
- (j) the supply of alcohol for consumption on the premises to persons employed there for the purposes of the business carried on by the holder of the licence, or the consumption of liquor so supplied, if the liquor is supplied at the expense of their employer or of the person carrying on or in charge of the business on the premises.

In this condition, any reference to a person residing in the premises shall be construed as including a person not residing there but carrying on or in charge of the business on the premises.

- 12. No person under fourteen shall be in the bar of the licensed premises during the permitted hours unless one of the following applies:
  - (a) He is the child of the holder of the premises licence.
  - (b) He resides in the premises, but is not employed there.
  - (c) He is in the bar solely for the purpose of passing to or from some part of the premises which is not a bar and to or from which there is no other convenient means of access or egress.
  - (d) The bar is in railway refreshment rooms or other premises constructed, fitted and intended to be used bona fide for any purpose to which the holding of the licence is ancillary.

In this condition "bar" includes any place exclusively or mainly used for the consumption of intoxicating liquor. But an area is not a bar when it is usual for it to be, and it is, set apart for the service of table meals and alcohol is only sold or supplied to persons as an ancillary to their table meals.

13.	The terminal hour for late night refreshment on New Year's Eve is extended to 05:00 on New Year's Day.







# CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE AND CONDITIONS PROPOSED BY A PARTY TO THE HEARING

When determining an application for a new premises licence under the provisions of the Licensing Act 2003, the licensing authority must, unless it decides to reject the application, grant the licence subject to the conditions which are indicated as mandatory in this schedule.

At a hearing the licensing authority may, in addition, and having regard to any representations received, grant the licence subject to such conditions which are consistent with the operating schedule submitted by the applicant as part of their application, or alter or omit these conditions, or add any new condition to such extent as the licensing authority considers necessary for the promotion of the licensing objectives.

This schedule lists those conditions which are consistent with the operating schedule, or proposed as necessary for the promotion of the licensing objectives by a responsible authority or an interested party as indicated. These conditions have not been submitted by the licensing service but reflect the positions of the applicant, responsible authority or interested party and have not necessarily been agreed

### **Mandatory Conditions**

- 1. The supply of alcohol for consumption off the premises must be made at a time when the premises are open for the purposes of supplying alcohol to members of the club for consumption on the premises.
- 2. Any alcohol supplied for consumption off the premises must be in a sealed container.
- 3. Any alcohol supplied for consumption off the premises must be made to a member of the club in person.
- 4. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
  (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises
  - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to;
  - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
  - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
  - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
  - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
  - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone,

encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;

- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 5. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 6. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
  - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
  - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either -
  - (a) a holographic mark, or
  - (b) an ultraviolet feature.
- 7. The responsible person must ensure that -
  - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures -
  - (i) beer or cider: ½ pint;
  - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
  - (iii) still wine in a glass: 125 ml;
  - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
  - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

A responsible person in relation to a licensed premises means the holder of the premise licence in respect of the premises, the designated premises supervisor (if any) or any individual aged 18 or over who is authorised by either the licence holder or designated premises supervisor. For premises with a club premises certificate, any member or officer of the club present on the premises in a capacity that which enables him to prevent the supply of alcohol.

- 8. (i) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
  - (ii) For the purposes of the condition set out in paragraph 8(i) above -
  - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979:
  - (b) "permitted price" is the price found by applying the formula -

P = D+(DxV)

#### Where -

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
- the holder of the premises licence,
- (ii) the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 8. (iii). Where the permitted price given by Paragraph 8(ii)(b) above would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 8. (iv). (1) Sub-paragraph 8(iv)(2) below applies where the permitted price given by Paragraph 8(ii)(b) above on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
  - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.
- 9. All persons guarding premises against unauthorised access or occupation or against outbreaks of disorder or against damage (door supervisors) must be licensed by the Security Industry Authority.

### Conditions consistent with the operating schedule

- 10. The Club will have a designated a full time employee to ensure the rules under the Licensing Act 2003 are followed at all times. The role of this individual is to ensure the Members are provided with the information they require, to liaise with the Council and to manage the events in line with License requirements.
- 11. Club Rules' will be issued to all members
- 12. Security will be posted at the entrance of the Club at all times and Identification of members and their guests will be checked prior to entry.
- 13. At all times a Manager will be present during each event ensuring Club Rules / House Rules are operating.


Conditions proposed by the Police and agreed by the applicant so as to fomr part of the operating schedule

- 14. (a) The premises shall install and maintain a comprehensive CCTV system as per the minimum requirements of the Westminster Police Licensing Team.
  - (b) All entry and exit points will be covered enabling frontal identification of every person entering in any light condition.
  - (c) The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises and will include the external area immediately outside the premises entrance.
  - (d) All recordings shall be stored for a minimum period of 31 days with date and time stamping.
  - (e) Viewing of recordings shall be made available immediately upon the request of Police or authorised officer throughout the entire 31-day period.
- 15. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises is open. This staff member must be able to provide a Police or authorised council officer copies of recent CCTV images or data with the absolute minimum of delay when requested.
- 16. There shall be a personal licence holder on duty on the premises at all times when the premises are authorised to sell alcohol.
- 17. A minimum of one (1) SIA licensed door supervisors shall be on duty at the premises at all times whilst it is open for business and they must correctly display their SIA licence(s) when on duty so as to be visible.
- 18. There shall be no sales of alcohol for consumption off the premises
- 19. Waiter / waitress service shall be available throughout the whole of the premises.
- 20. Challenge 25 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram.
- 21. An incident log shall be kept at the premises, and made available on request to an authorised officer of the City Council or the Police. It must be completed within 24 hours of the incident and will record the following:
  - (a) all crimes reported to the venue
  - (b) all ejections of patrons
  - (c) any complaints received concerning crime and disorder
  - (d) any incidents of disorder
  - (e) all seizures of drugs or offensive weapons
  - (f) any faults in the CCTV system
  - (g) any refusal of the sale of alcohol
  - (h) any visit by a relevant authority or emergency service.
- 22. Alcohol may only be sold for consumption by members of a private club and their bona fide guests (not exceeding (4) guests per member). No person shall be admitted to membership of the private club or be entitled to take advantage of any of the privileges of membership without an interval of at least 48 hours between their nomination or application for membership and their admission.
- 23. A list of the names and addresses of members of the Club shall be kept on the premises at all times together with a book showing the names and dates of attendance of any guests introduced by members. Both the list and the book shall be produced on demand for inspection by the Police or an authorised officer of the Council.
