10. No person under fourteen shall be in the bar of the licensed premises during the permitted hours unless one of the following applies:

- (a) He is the child of the holder of the premises licence.
- (b) He resides in the premises, but is not employed there.
- (c) He is in the bar solely for the purpose of passing to or from some part of the premises which is not a bar and to or from which there is no other convenient means of access or egress.
- (d) The bar is in railway refreshment rooms or other premises constructed, fitted and intended to be used bona fide for any purpose to which the holding of the licence is ancillary.

In this condition "bar" includes any place exclusively or mainly used for the consumption of intoxicating liquor. But an area is not a bar when it is usual for it to be, and it is, set apart for the service of table meals and alcohol is only sold or supplied to persons as an ancillary to their table meals.

11. The terminal hour for late night refreshment on New Year's Eve is extended to 05:00 on New Year's Day.

1-D Conditions to be added.

Proposed Conditions

1. (a) The premises shall install and maintain a comprehensive CCTV system as per the minimum requirements of the Westminster Police Licensing Team.
 (b) All entry and exit points will be covered enabling frontal identification of every person entering in any light condition.
 (c) The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises and will include the external area immediately outside the premises entrance.
 (d) All recordings shall be stored for a minimum period of 31 days with date and time stamping.
 (e) Viewing of recordings shall be made available immediately upon the request of Police or authorised officer throughout the entire 31-day period.
2. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises is open. This staff member must be able to provide a Police or authorised council officer copies of recent CCTV images or data with the absolute minimum of delay when requested.
3. No noise generated on the premises, or by its associated plant or equipment, shall emanate from the premises nor vibration be transmitted through the structure of the premises which gives rise to a nuisance.
4. No drinks to be taken outside after 23.00 hours.
5. All outside tables and chairs shall be rendered unusable by 23.00 hours each day.
6. Notices shall be prominently displayed at all exits requesting patrons to respect the needs of local residents and businesses and leave the area quietly.
7. All waste shall be properly presented and placed out for collection no earlier than 30 minutes before the scheduled collection times.
8. No waste or recyclable materials, including bottles, shall be moved, removed from or placed in outside areas between 23.00 hours and 08.00 hours on the following day.
9. Substantial food and non-intoxicating beverages, including drinking water, shall be available in all parts of the premises where alcohol is sold or supplied for consumption on the premises.

10. A Challenge 21 or Challenge 25 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram.

11. An incident log shall be kept at the premises, and made available on request to an authorised officer of the City Council or the Police. It must be completed within 24 hours of the incident and will record the following:

- (a) all crimes reported to the venue
- (b) all ejections of patrons
- (c) any complaints received concerning crime and disorder
- (d) any incidents of disorder
- (e) all seizures of drugs or offensive weapons
- (f) any faults in the CCTV system, searching equipment or scanning equipment
- (g) any refusal of the sale of alcohol
- (h) any visit by a relevant authority or emergency service.

12. No deliveries to the premises shall take place between 23.00 and 08.00 hours on the following day.

13. The premises licence holder shall ensure that any patrons drinking and/or smoking outside the premises do so in an orderly manner and are properly supervised by staff so as to ensure that there is no public nuisance or obstruction of the public highway.

The Licensing Authority has concerns in relation to this application and how the premises would promote the four Licensing Objectives:</p> <ul style="list-style-type: none"> • Public Nuisance • Prevention of Crime & Disorder • Public Safety • Protection of children from harm <p>The application seeks to vary the following:</p> <ol style="list-style-type: none"> 1. To extend the hours for the sale of alcohol on Friday and Saturday until 23:30 hours 2. Extend the premises opening hours on Friday and Saturday until 00:00 3. Extend the hours for late night refreshment Friday and Saturday until 00:00. 4. Representation
We object to this application to extend the operating hours of this public house to 12am on Friday and Saturday. This extension will fail to promote the licensing objectives and will increase cumulative impact in the West End Cumulative Impact Zone.

The premises are within Soho, an area at the heart of the West End’s entertainment district, with its **482** licensed premises which include a large proportion of late night **119 (25%)** licensed

premises with a terminal hour between **1am - 6am and a capacity of 22,560**. There are over 200 restaurants, 39 bars, 46 pubs, 31 clubs (including members clubs) and entertainment premises. The area is densely populated at night with people on a night out creating loud levels of noise, thus causing disturbance, alongside increasing crime rates, disorder and anti-social behaviour.

The applicant acknowledges the pub is situated within the West End Cumulative Impact Zone and highlights the Pubs and Bars Policy PB1 which states the policy is to refuse a variation of hours but it does not apply when they are within core hours. However, the applicant still has to demonstrate that there will be no increase in cumulative impact and will promote the licensing objectives. We find it difficult to believe how a pub selling alcohol to 11.30pm and closing at midnight on Friday and Saturday, the busiest nights of the week in Soho, will not increase cumulative impact.

Considering the high and increasing crime rates in the area and the noise disturbance already experienced by residents who live on Soho's streets, it is clear this application should be refused.

Residents

There are real concerns amongst residents about the ever increasing numbers of licensed premises. They have been subjected to noise disturbance and anti-social behaviour that is beyond acceptable levels. They are disturbed by the late night activity as people walk by either shouting, screaming or arguing, noise from pedicabs, car doors slamming and horns honking.

This pub is situated in an area with a large number of residential properties. We know residents living in the area are disturbed by this late night activity. Often there are drug dealers in cars playing thumping bass music from sound systems. Residents are also subjected to anti-social behaviour with people vomiting and urinating in the street and in their doorways.

Residents are also disturbed even if an establishment is not located directly on their street, as patrons usually intoxicated leave premises and either carry on their night out in Soho or as they make their way home making a noise and disturbing residents along the way.

With all of the above it is unsurprising residents experience sleep disturbance. A recent survey conducted by the [REDACTED] confirms that residents are disturbed by noise at night and this is having a negative impact on their lives. 87 people responded of which 78 are Soho residents with ages spread fairly evenly from 22 to 80, 59% having lived in Soho for more than 10 years.

When asked about disturbed sleep; 24% of respondents say they have their sleep disturbed 7 nights a week, 16% 5 or 6 nights a week and 19% 3 or 4 nights a week.

Furthermore, 64% of the respondents agreed that noise nuisance from increased commercial activity at night is the most serious problem impacting Soho residents' quality of life.

62% of respondents agreed that the council should not grant any extensions of hours for premises in Soho.

60% of respondents agreed that "noise nuisance and sleep deprivation is adversely impacting my health" and the health of the people they live with.

46% of respondents agreed that noise nuisance is so bad that they have considered moving away from Soho.

Crime and Disorder

The Cumulative Impact Assessment 2020 presents overwhelming evidence of the year on year increase in cumulative impact in the West End Zone 1, **it highlights the rate of crime as 10 - 13 times higher between 6pm - 6am compared to the borough average.** The level of crime, disorder and anti social behaviour continues to be a huge problem in Soho, the crime figures are high and increasing. The recent police crime report for April/May shows the level of alcohol related assaults, sexual assaults and robberies within the West End are now higher than at pre-COVID levels. There are high levels of crime in all areas of Soho.

The Committee will be aware of recent serious incidents on Greek Street, these incidents confirm what residents already know, that Soho is unsafe at night. Public safety is a huge concern and has been for a long time. The large number of licensed premises plus the numbers of people out on the streets at night attract criminal gangs, which in turn result in high levels of crime and disorder creating a very unsafe environment for the public.

In Soho the majority of robberies take place at night, people are targeted as they leave venues. Alongside the robberies and assaults, drug dealing is a huge problem with groups of dealers congregating to sell drugs to people as they leave premises or as they pass by. There are more dealers in the area at night than during the day, which is directly linked to the large number of venues and people which creates the drugs market. Pickpockets also operate in the area, they are a part of a well organised criminal group who arrive in a van at night and disperse into Soho before returning to be driven away.

It is well known that intoxicated people become victims of crime, their vulnerability being exploited by gangs or individuals who are in Soho explicitly to target them. We believe patrons leaving this pub at night will be at high risk of becoming victims of crime.

Cumulative Impact Policy CIP1

This area has been identified by Westminster City Council as under stress because the cumulative effect of the concentration of late night and drink led premises and night cafes has led to serious problems of disorder and/or public nuisance affecting residents, visitors and other businesses. The evidence presented in the Cumulative Impact Assessment 2020 is overwhelming, it describes the high level of cumulative impact in the West End Zone between 2017-2019. It concludes that,

'After consideration of the cumulative impact assessment it is the Licensing Authority's view that the number of premises licences in the West End, are such that it is likely granting further types of licences or varying existing licences would be inconsistent with the authority's duty to promote the licensing objectives. The granting of licences for certain types of operation that are likely to add to Cumulative Impact within these areas would not be consistent with the Licensing Authority's duty under the Licensing Act 2003.'

(p.19) **(Our emphasis)**

This evidence supported further policy restrictions in the West End, however, the impact of COVID-19 resulted in the Licensing Authority deciding not to implement greater restrictions at this stage, but it may in the lifetime of the policy if footfall moves toward pre-March 2020 levels (D1). Soho is fully open for business and thriving, our observation is Soho attracts more people now than at pre-COVID times.

The policies in relation to the cumulative impact zone are directed at the global and cumulative effects of licences on the area as a whole (D16. of the policy).

D23. **'The proximity of residential accommodation is a general consideration with regard to the prevention of public nuisance.** It goes on, **'The nature of cumulative impact is that it is cumulative and affects not only the immediate vicinity of the premises, but the wider area;** thus the number of people visiting the premises, the nature of licensable activities and **the lateness of operations have an impact on an area as a whole, irrespective of whether or**

not there is residential accommodation in proximity to the premises.’ (our emphasis)

It is important to note the policy relates to the global effects of alcohol licences in the whole impact zone and not just a part of it.

We acknowledge the Pubs and Bars Policy PB1 allows for this variation to the existing licence, but the applicant still has to demonstrate they will not increase cumulative impact, in our view they have failed to do so.

In summary

Any increase in hours of a public house in the West End Cumulative Impact Zone will fail to promote the licensing objectives and increase cumulative impact.

Appendix 1 : ██████████ Sleep Survey Results - 31 October 2022

The survey conducted by the ██████████ confirms that residents are disturbed by noise at night and this is having a negative impact on their lives.

87 people have responded of which 78 are Soho residents with ages spread fairly evenly from 22 to 80.

59% have lived in Soho more than 10 years

26% between 3 and 10 years

6% between 1 and 3 years and

9% have lived here less than a year

42% own their homes

20% are Soho Housing Association and the rest tenants with other landlords

10 respondents have children living at home with them

58% have double glazing

37% single glazing

5% have triple glazing

24% of respondents have their sleep disturbed 7 nights a week

16% of respondents have their sleep disturbed 5 or 6 nights a week

19% of respondents have their sleep disturbed 3 or 4 nights a week

19% of respondents have their sleep disturbed once or twice a week

20% do not have a problem with environmental noise pollution

Topping the list in September was people drinking in the street with 54 mentions, then pedicabs with 51, waste collections at 48, construction noise 36 and car horns 33 and deliveries at 25. Other noise sources identified were air conditioning, motorbikes revving, building alarms and music from licensed venues. The most common identified problem at 42% of respondents was people drinking and shouting in the street.

64% of respondents agreed that noise nuisance from increased commercial activity at night is the most serious problem impacting Soho residents quality of life

46% of respondents agreed that noise nuisance is so bad that they have considered moving away from Soho

60% of respondents agreed that noise nuisance and sleep deprivation is adversely impacting

my health and the health of the people they live with.

67% of respondents agreed that the council should base its noise policy on the World Health Organisation guidelines

64% of respondents agreed that our ward councillors should make this their priority during the next four years

69% of respondents agreed that during the time I have lived in Soho noise pollution has got significantly worse

73% of respondents agreed that if noise limits are being exceeded the council should consider reviewing existing alcohol licenses.

72% of respondents agreed that the council should install electronic noise monitoring in Soho

56% of respondents agreed that the council should not grant additional premises licence for the sale of alcohol in Soho.

62% of respondents agreed that the council should not grant any extensions of hours for premises in Soho

68% of respondents agreed that the council should renew its noise strategy as a matter of urgency

Many respondents made additional comments:-

I left Soho 4 years ago. After 20 years, the noise & air pollution finally broke me. Like the frog in the pan of water with the heat gradually turned up, it took me a while to realise that it wasn't me going soft, it was the significant degradation of the environment around me. Since moved out of my flat, several other tenants have moved in & swiftly out again citing sleep disruption & excessive night noise as their reason for leaving. The flat is now used as an office rather than as residential.

I am disappointed that another restaurant unit is going to be let on Hopkins Street by Shaftesbury when the residents already have an enormous amount of noise from the existing restaurants. No doubt they will also want an alcohol license, which will increase the noise and disturb residents even more.

As a disabled person working from home, I find it extremely exhausting not able to have rest at night, Screams and noise of drunk people every night, The Landlord WCC does not want to change the windows to a double glazing nor allow tenants to pay privately for windows to be upgraded. Noise at home, lack of sleep, and concentration in the day time. I have a hand held noise monitor, I recorded noise levels of 97db outside the pub at the corner of Broadwick and Berwick Streets.

More consideration needs to be given to residents from councillors, people visiting the area and local businesses in particular those who serve alcohol and have late night licences. Decisions such as granting planning and licence applications should not be made by people who do not live in the area and are therefore not impacted by the decision making.

Very difficult to get the local authority to understand and take complaints seriously. Officers often helpful but then the case goes to committee and they always seem to rule in favour of the commercial premises rather than residents.

There is supposed to be a presumption to refuse new licences but in practice the council still lets new things through until after Midnight, which is far too late and has made a nonsense of the policy.

There should be a quiet window of 11pm to 8am every day. 7am deliveries are far too early for a lot of people if they are noisy or use cages or refrigeration.

I live in Marshall St and overlook it. Regularly now (most nights) there are traffic jams in the street at 3am in the morning with cars picking up people leaving clubs. The cars frequently are using their horns. Last night they had their door open with music blaring. we have 2 motorbike stands close together. 1 in Broadwick St and 1 in Marshall St. There is always at least one bike revving up at either 3am or really early like 530am This noise has changed and increased over the past 3-4 years. I am woken up most nights at about 3am. And i have double glazing and am on [a high] floor.

Businesses take no responsibility for their customers drinking/eating and mainly shouting outside, including when they are queuing, and particularly when they are leaving. Post al fresco, there is a new attitude that anything goes on the streets and that includes contempt for the community who live here. The Council need to rethink this and put some major resource into enforcement.

I've lived in Soho for 60 years... Born and bred.. It's never been this noisy!

Early hours waste collections (including bottle smashing) also includes the food & beverage businesses putting their waste in the street and bottle bins at anti-social hours ahead of collection times. Our local restaurants are not supposed to put bottles out between the hours of 23:00 and 07:00 but they frequently do. Frequently delivery trucks some with noisy refrigeration units are also delivering early hours.

Also deliveries & pedicabs. Unfortunately my lack of sleep due to noise has caused serious health issues and I now cannot work and suffer anxiety and depression. I'm woken up on average 5 times per night and have considered suicide. Why I'm being denied sleep between the hours of 11pm and 7am astonishes me. The freeholders Shaftesbury Carnaby show a total disrespect to the effects that noise has on the residents of Soho

Annex 1 – Mandatory conditions

1. No supply of alcohol may be made at a time when there is no designated premises supervisor in respect of this licence.
2. No supply of alcohol may be made at a time when the designated premises supervisor does not hold a personal licence or the personal licence is suspended.
3. Every supply of alcohol under this licence must be made or authorised by a person who holds a personal licence.
4.
 - (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to;
 - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
 - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
 - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
5. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
6.
 - (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
 - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
 - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
 - (a) a holographic mark, or
 - (b) an ultraviolet feature.
7. The responsible person must ensure that—

- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
 - (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

A responsible person in relation to a licensed premises means the holder of the premise licence in respect of the premises, the designated premises supervisor (if any) or any individual aged 18 or over who is authorised by either the licence holder or designated premises supervisor. For premises with a club premises certificate, any member or officer of the club present on the premises in a capacity that which enables him to prevent the supply of alcohol.

8(i) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

8(ii) For the purposes of the condition set out in paragraph 8(i) above -

(a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;

(b) "permitted price" is the price found by applying the formula -

$$P = D + (D \times V)$$

Where -

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

(c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -

- (i) the holder of the premises licence,
- (ii) the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

(d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

(e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

8(iii). Where the permitted price given by Paragraph 8(ii)(b) above would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

8(iv). (1) Sub-paragraph 8(iv)(2) below applies where the permitted price given by Paragraph 8(ii)(b) above on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Conditions which reproduce the effect of any restriction imposed on the use of the premises by specified enactment

Conditions related to the Sale of Alcohol

9. Alcohol shall not be sold, supplied, consumed in or taken from the premises except during permitted hours.

In this condition, permitted hours means:

- (a) On weekdays, other than Christmas Day, Good Friday or New Year's Eve, 10:00 to 23:00;
- (b) On Sundays, other than Christmas Day or New Year's Eve, 12:00 to 22:30;
- (c) On Good Friday, 12:00 to 22:30;
- (d) On Christmas Day, 12:00 to 15:00 and 19:00 to 22:30;
- (e) On New Year's Eve, except on a Sunday, 10:00 to 23:00;
- (f) On New Year's Eve on a Sunday, 12:00 to 22:30;
- (g) On New Year's Eve from the end of permitted hours on New Year's Eve to the start of permitted hours on the following day (or, if there are no permitted hours on the following day, midnight on 31st December).

NOTE - The above restrictions do not prohibit:

- (a) during the first twenty minutes after the above hours the consumption of the alcohol on the premises;
- (b) during the first twenty minutes after the above hours, the taking of the alcohol from the premises unless the alcohol is supplied or taken in an open vessel;
- (c) during the first thirty minutes after the above hours the consumption of the alcohol on the premises by persons taking table meals there if the alcohol was supplied for consumption as ancillary to the meals;
- (d) the sale or supply of alcohol to or the consumption of alcohol by any person residing in the licensed premises;
- (e) the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;
- (f) the sale of alcohol to a trader or registered club for the purposes of the trade or club;
- (g) the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces;
- (h) the taking of alcohol from the premises by a person residing there;
- (i) the supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied;
- (j) the supply of alcohol for consumption on the premises to persons employed there for the purposes of the business carried on by the holder of the licence, or the consumption of liquor so supplied, if the liquor is supplied at the expense of their employer or of the person carrying on or in charge of the business on the premises.

In this condition, any reference to a person residing in the premises shall be construed as including a person not residing there but carrying on or in charge of the business on the premises.

10. No person under fourteen shall be in the bar of the licensed premises during the permitted hours unless one of the following applies:
- (a) He is the child of the holder of the premises licence.
 - (b) He resides in the premises, but is not employed there.
 - (c) He is in the bar solely for the purpose of passing to or from some part of the premises which is not a bar and to or from which there is no other convenient means of access or egress.
 - (d) The bar is in railway refreshment rooms or other premises constructed, fitted and intended to be used bona fide for any purpose to which the holding of the licence is ancillary.

In this condition "bar" includes any place exclusively or mainly used for the consumption of intoxicating liquor. But an area is not a bar when it is usual for it to be, and it is, set apart for the service of table meals and alcohol is only sold or supplied to persons as an ancillary to their table meals.

11. The terminal hour for late night refreshment on New Year's Eve is extended to 05.00 on New Year's Day.

Application to vary a Premises Licence

Red Lion, 14 Kingly Street, London W1B 5PR (the “Premises”)

Applicant’s Written Submissions

This statement is made in support of an application to vary a premises licence with the intention of outlining the Applicant’s case and seeking to address the concerns of those maintaining representations.

Amplification of the points made below, together with further submissions, will be made orally at the licensing sub-committee hearing if all representations are not withdrawn.

Background & Layout

The Applicant is a longstanding independent brewery which takes a long-term view. It is unique in that it only stocks it owns products (including soft drinks and snacks) and has a staunchly traditional approach to its pubs in that they do not play any music, nor have televisions, nor permit laptops to be used. The whole ethos is that local communities can enjoy spending time together without unwanted distractions. By not playing music and showing television, the pubs do not attract trouble. Current food and drinks menus are at **appendix 1**.

Whilst the Premises was refurbished in 2013, the current layout plans have not changed for decades. The Premises is over five floors with the layout as follows:

- Basement - Back of house storage
- Ground - A small snug bar with fixed and loose furniture at the front with a public bar at the back with loose furniture with a single bar serving both. Gents’ toilets.
- First Floor- A lounge bar/dining room with another bar servery and ladies’ toilets.
- Second Floor - Kitchen, storage and staff studio flat

Third Floor - Two bedroom staff flat.

The trading space is small – 625 sq. ft on the ground floor and 718 sq. ft. on the first floor and, unusually for central London, there is spacious staff accommodation. Pictures of the public areas are at **appendix 2**.

The Application

This is a relatively simple application to extend the hours for opening and apply for late night refreshment until the Core Hours (as defined in the Statement of Licensing Policy) and the sale by retail to 30 minutes before on Friday and Saturday nights. A very limited extension of 30 minutes. The Applicant rarely seeks to amend its licences. However, with the country's current economic issues and patrons attending the Premises less often, but wishing to stay later, it considers that it necessary to seek to extend the hours from the old on-licence hours prescribed by the Licensing Act 1964.

Given that the existing licence conditions are virtually non-existent, new model conditions have been proffered to ensure that the premises licence better uphold the four licensing objectives.

Representations from the Licensing Authority and [REDACTED]

The concerns raised by the Licensing Authority and the [REDACTED] and the Applicant's comments are as follows:

General Concerns with crime rates and noise disturbance in Soho

The Applicant accepts that there is anti-social behaviour in Soho. However, it does not accept that its patrons are adding to it. The Applicant's offer is simply not attractive to a 'party going' crowd that could be a focus for drug dealers and pedicabs. Instead, it is one of the few traditional pubs left in Soho where friends and family can go for a drink or a meal in a comfortable, quiet, environment which is conducive to conversation. In other words, a moderating influence on the large number of late-night, vertical drinking establishments which offer loud music and drinks promotions. Tellingly, for as long as management can remember, there has been no reason to call the Metropolitan Police in respect of any patrons behaving badly, nor have there been any visits from other WCC officers.

The new conditions proffered will ensure that this remains the case and the Applicant has developed a Dispersal Policy (a draft of which is at **appendix 3**). The Applicant is happy to adopt the appropriate model condition, namely:

- **A copy of the premises' dispersal policy shall be made readily available at the premises for inspection by a police officer and/or an authorised officer of Westminster City Council.**

Cumulative Impact

Before making this application, the Statement of Licensing Policy was considered. There is no policy to refuse applications to vary the existing licensed hours for public houses within the Core Hours, as is being proposed. It goes on to say that such applications 'will generally be granted' subject to meeting the policies relating to the four licensing objectives, the delivery of alcohol policy (which is not relevant to this application) and to meeting the definition of a public house (which is not in question).

Regarding the four licensing objectives, the Applicant suggests that public safety is not a relevant concern and, with no adult entertainment, nor evidence of underage sales, neither is the protection of children from harm objective. This leaves the prevention of crime and disorder and public nuisance.

The risk of crime and disorder has been addressed above. Put simply, there is no suggestion that the Premises is currently adding to the crime and disorder issues in Soho, nor is there any evidence that a modest increase in hours within Core will see this change. Regarding the prevention of public nuisance, there is no representation from the 'independent experts', namely Environmental Health. This is not surprising as, with no music and modern extraction there have been no complaints in respect of noise, vibration or smells. Furthermore, the Applicant is seeking to reduce the hours patrons are permitted to drink outside.

The Applicant would therefore submit that the requirements of the Statement of Licensing Policy are met.

Financial Considerations

Whilst the Applicant has a long history, it is not immune to financial pressures. Whilst Soho might appear busy, especially in the last two months, takings are down considerably and patrons are coming out later. Utility and staffing costs have also increased significantly, whilst the move to hybrid working for most offices in the area, means that volumes of trade on Fridays have decreased. These economic factors can properly be considered in a licensing determination. In *R (o/a/o Hope and Glory Public House Ltd) v City of Westminster Magistrates' Court and Others* [2011] EWCA Civ 31, the Court of Appeal (per Toulson LJ) observed that [at 42]:

*'Licensing decisions often involve weighing a variety of competing considerations: the demand for licensed establishments, **the economic benefit to the proprietor and to the locality by drawing in visitors and stimulating the demand**, the effect on law and order, the impact on the lives of those who live and work in the vicinity, and so on.'*

Conclusion

The Premises is one of relatively few pubs in the West End which has not already got a premises licence with Core Hours. Nevertheless, it has an excellent reputation and, with its commitment to traditional values, this is not set to change. There are no issues raised with the operation of the Premises itself. It is noted that no further conditions have been suggested but the Applicant would, of course, consider any suggestions made. At 10.55pm all patrons standing outside shall be told that they must return inside immediately.

Every 15 minutes after 11pm a Team Member will ensure that no patrons are standing outside. Any that are will be told that they must return inside immediately.

At 11.20pm the bell will be rung to indicate that any last orders are to be placed at the bar.

At 11.30pm the bell will be rung again to indicate that the bar is now closed.

At 11.40pm all customers will be informed that they need to finish their drinks as soon as possible.

At 11.50pm any remaining customers will be told to leave immediately.

At midnight the doors will be locked.

CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE AND CONDITIONS PROPOSED BY A PARTY TO THE HEARING

When determining an application for a new premises licence under the provisions of the Licensing Act 2003, the licensing authority must, unless it decides to reject the application, grant the licence subject to the conditions which are indicated as mandatory in this schedule.

At a hearing the licensing authority may, in addition, and having regard to any representations received, grant the licence subject to such conditions which are consistent with the operating schedule submitted by the applicant as part of their application, or alter or omit these conditions, or add any new condition to such extent as the licensing authority considers appropriate for the promotion of the licensing objectives.

This schedule lists those conditions which are consistent with the operating schedule, or proposed as appropriate for the promotion of the licensing objectives by a responsible authority or an interested party as indicated. These conditions have not been submitted by the licensing service but reflect the positions of the applicant, responsible authority or interested party and have not necessarily been agreed

Conditions: On Current Licence -

Mandatory:

1. No supply of alcohol may be made at a time when there is no designated premises supervisor in respect of this licence.
2. No supply of alcohol may be made at a time when the designated premises supervisor does not hold a personal licence or the personal licence is suspended.
3. Every supply of alcohol under this licence must be made or authorised by a person who holds a personal licence.
4.
 - (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to;
 - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;

- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
 - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
 - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
5. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
6. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
- (a) a holographic mark, or
 - (b) an ultraviolet feature.
7. The responsible person must ensure that—
- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
 - (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml;
 - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
 - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

A responsible person in relation to a licensed premises means the holder of the premise licence in respect of the premises, the designated premises supervisor (if any) or any individual aged 18 or over who is authorised by either the licence holder or designated premises supervisor.

For premises with a club premises certificate, any member or officer of the club present on the premises in a capacity that which enables him to prevent the supply of alcohol.

8(i) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

8(ii) For the purposes of the condition set out in paragraph 8(i) above -

(a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;

(b) "permitted price" is the price found by applying the formula -

$$P = D+(D \times V)$$

Where -

(i) P is the permitted price,

(ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and

(iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

(c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -

(i) the holder of the premises licence,

(ii) the designated premises supervisor (if any) in respect of such a licence, or

(iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

(d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

(e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

8(iii). Where the permitted price given by Paragraph 8(ii)(b) above would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

8(iv). (1) Sub-paragraph 8(iv)(2) below applies where the permitted price given by Paragraph 8(ii)(b) above on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

The applicant has proposed to delete condition 9 to condition 11 (as shown below) from the operating schedule of the licence.

Conditions which reproduce the effect of any restriction imposed on the use of the premises by specified enactment.

Conditions related to the Sale of Alcohol:

9. Alcohol shall not be sold, supplied, consumed in or taken from the premises except during permitted hours.

In this condition, permitted hours means:

- (a) On weekdays, other than Christmas Day, Good Friday or New Year's Eve, 10:00 to 23:00
- (b) On Sundays, other than Christmas Day or New Year's Eve, 12:00 to 22:30
- (c) On Good Friday, 12:00 to 22:30
- (d) On Christmas Day, 12:00 to 15:00 and 19:00 to 22.30
- (e) On New Year's Eve, except on a Sunday, 10:00 to 23:00
- (f) On New Year's Eve on a Sunday, 12:00 to 22:30
- (g) On New Year's Eve from the end of permitted hours on New Year's Eve to the start of permitted hours on the following day (or, if there are no permitted hours on the following day, midnight on 31st December).

NOTE - The above restrictions do not prohibit:

- (a) during the first twenty minutes after the above hours the consumption of the alcohol on the premises;
- (b) during the first twenty minutes after the above hours, the taking of the alcohol from the premises unless the alcohol is supplied or taken in an open vessel;
- (c) during the first thirty minutes after the above hours the consumption of the alcohol on the premises by persons taking table meals there if the alcohol was supplied for consumption as ancillary to the meals;
- (d) the sale or supply of alcohol to or the consumption of alcohol by any person residing in the licensed premises;
- (e) the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;
- (f) the sale of alcohol to a trader or registered club for the purposes of the trade or club;
- (g) the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces;
- (h) the taking of alcohol from the premises by a person residing there;
- (i) the supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied;
- (j) the supply of alcohol for consumption on the premises to persons employed there for the purposes of the business carried on by the holder of the licence, or the consumption of liquor so supplied, if the liquor is supplied at the expense of their employer or of the person carrying on or in charge of the business on the premises.

In this condition, any reference to a person residing in the premises shall be construed as including a person not residing there but carrying on or in charge of the business on the premises.

10. No person under fourteen shall be in the bar of the licensed premises during the permitted hours unless one of the following applies:
- (a) He is the child of the holder of the premises licence.
 - (b) He resides in the premises, but is not employed there.
 - (c) He is in the bar solely for the purpose of passing to or from some part of the premises which is not a bar and to or from which there is no other convenient means of access or egress.
 - (d) The bar is in railway refreshment rooms or other premises constructed, fitted and intended to be used bona fide for any purpose to which the holding of the licence is ancillary.

In this condition "bar" includes any place exclusively or mainly used for the consumption of intoxicating liquor. But an area is not a bar when it is usual for it to be, and it is, set apart for the service of table meals and alcohol is only sold or supplied to persons as an ancillary to their table meals.

11. The terminal hour for late night refreshment on New Year's Eve is extended to 05:00 on New Year's Day.

The Applicant proposes to add the conditions below to the operating schedule:

12. (a) The premises shall install and maintain a comprehensive CCTV system as per the minimum requirements of the Westminster Police Licensing Team.
- (b) All entry and exit points will be covered enabling frontal identification of every person entering in any light condition.
- (c) The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises and will include the external area immediately outside the premises entrance.
- (d) All recordings shall be stored for a minimum period of 31 days with date and time stamping.
- (e) Viewing of recordings shall be made available immediately upon the request of Police or authorised officer throughout the entire 31-day period.
13. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises is open. This staff member must be able to provide a Police or authorised council officer copies of recent CCTV images or data with the absolute minimum of delay when requested.
14. No noise generated on the premises, or by its associated plant or equipment, shall emanate from the premises nor vibration be transmitted through the structure of the premises which gives rise to a nuisance.
15. No drinks to be taken outside after 23.00 hours.
16. All outside tables and chairs shall be rendered unusable by 23.00 hours each day.
17. Notices shall be prominently displayed at all exits requesting patrons to respect the needs of local residents and businesses and leave the area quietly.

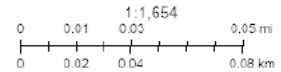
18. All waste shall be properly presented and placed out for collection no earlier than 30 minutes before the scheduled collection times.
19. No waste or recyclable materials, including bottles, shall be moved, removed from or placed in outside areas between 23.00 hours and 08.00 hours on the following day.
20. Substantial food and non-intoxicating beverages, including drinking water, shall be available in all parts of the premises where alcohol is sold or supplied for consumption on the premises.
21. A Challenge 21 or Challenge 25 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram.
22. An incident log shall be kept at the premises, and made available on request to an authorised officer of the City Council or the Police. It must be completed within 24 hours of the incident and will record the following:
 - (a) all crimes reported to the venue
 - (b) all ejections of patrons
 - (c) any complaints received concerning crime and disorder
 - (d) any incidents of disorder
 - (e) all seizures of drugs or offensive weapons
 - (f) any faults in the CCTV system, searching equipment or scanning equipment
 - (g) any refusal of the sale of alcohol
 - (h) any visit by a relevant authority or emergency service.
23. No deliveries to the premises shall take place between 23.00 and 08.00 hours on the following day.
24. The premises licence holder shall ensure that any patrons drinking and/or smoking outside the premises do so in an orderly manner and are properly supervised by staff so as to ensure that there is no public nuisance or obstruction of the public highway.
25. A copy of the premises' dispersal policy shall be made readily available at the premises for inspection by a police officer and/or an authorised officer of Westminster City Council.

<p>I object to the application mainly on the grounds that the opening hours will be extended to 1.30am from the current 11.30pm.</p> <p>The fact that this time change is not mentioned at all in the resident notice and is hidden in the appendix of the application is very concerning; one could wonder if not done on purpose.</p> <p>Remaining open until 1.30am is extremely late for a premise that is located in the middle of a residential area and will create significant noise disturbance in addition to the existing ones.</p> <p>Disturbance today is linked to people having drink outdoors but also at closing time when people leave the premise and stand on pavement across the pub talking loudly (while intoxicated) for often more than 15-30minutes.</p> <p>What can be acceptable to some extent at 11pm cannot happen at 1.30am on any day. Please put yourselves in our shoes if you/your children are woken up at 1.30am several times a week.</p> <p>The council should be focused on the well being and mental health of its residents in priority over increasing pub revenues.</p> <p>Separately, how does the premise intend to control the noise pollution from inside the premise until 1.30am given that the windows are not double-glazed? On nights when the pub had a live band, [REDACTED] could hear the sound as [REDACTED] [REDACTED] Why would be different if they are screening movies until 1.30am?</p> <p><i>Further submissions were received from the interested party on 14 June 2023 containing a photograph and 7 videos.</i></p> <p>As a follow-up to my email, I wanted to attach a few videos / pictures that highlight the breach of the current licence by the Coach Makers Arms with regards to noise disturbance. 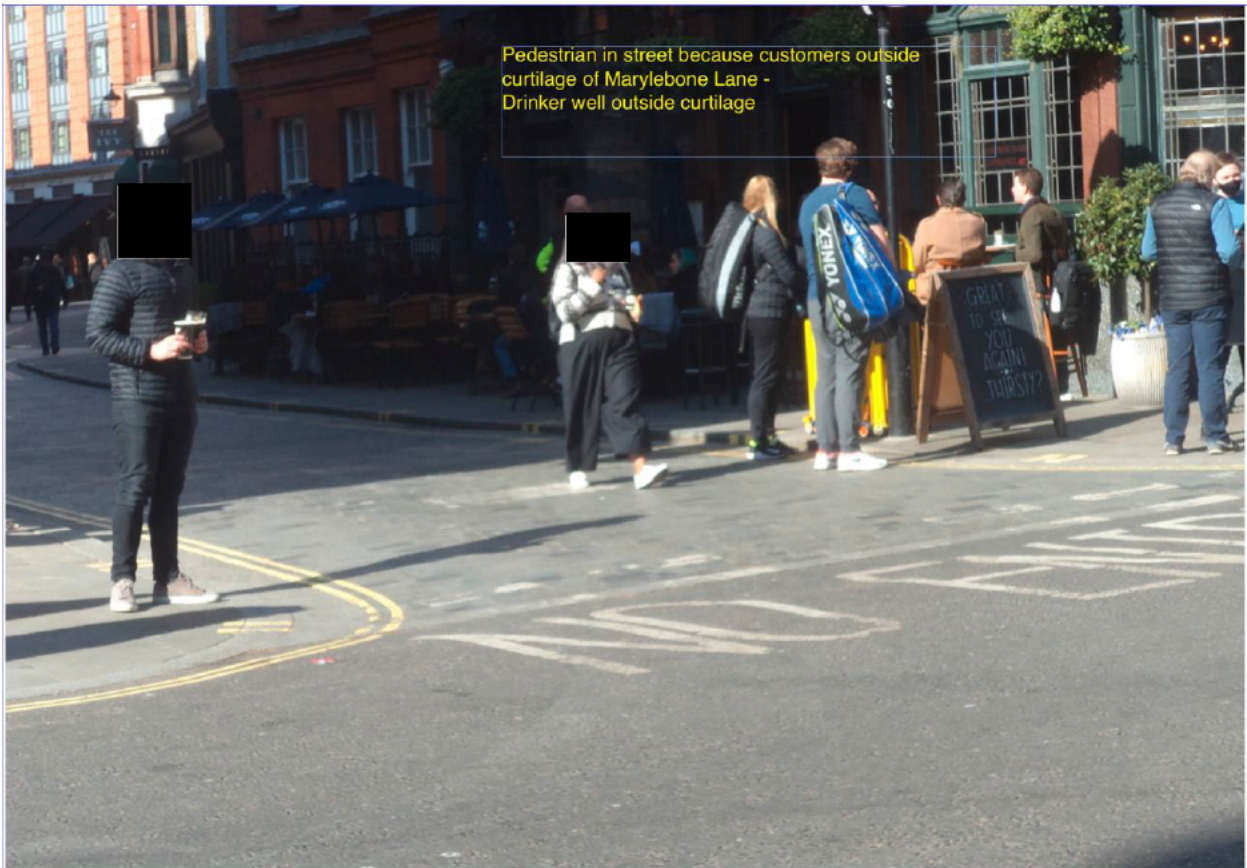

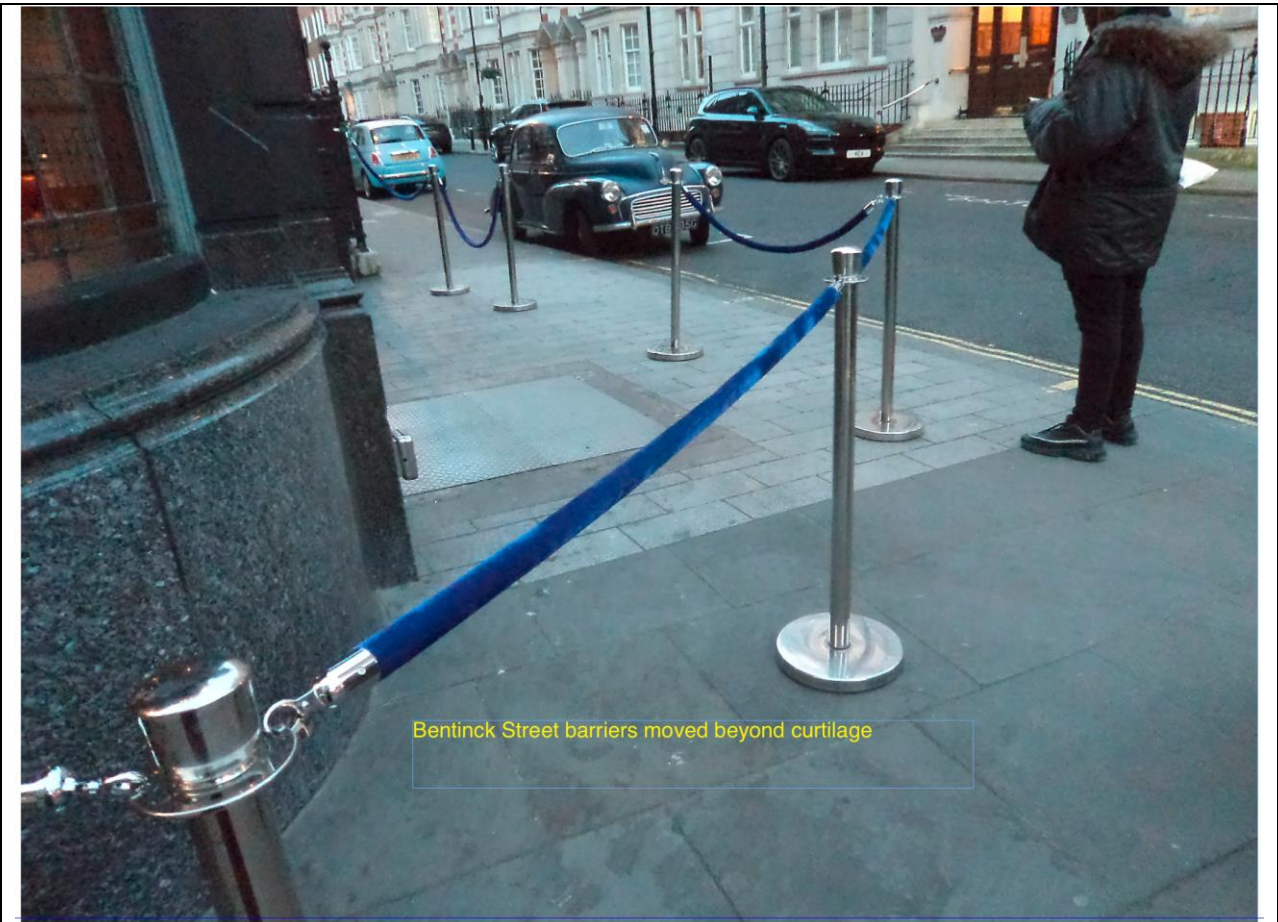

On the basis of **prevention of public nuisance**, I object to:

***Showing films on all (4) floors from 10.00 to 01.30 (12.00 - 01.00 Sundays).** This would compromise the privacy and quiet of [REDACTED]. Despite secondary glazing and shutting our windows, noise penetrates to [REDACTED] affecting conversation, music, etc. Why is permission sought beyond the hours of already-licensed activities?

Noise from customers & films would spread widely, particularly in summer when, contrary to the present licence, windows and external doors are often open after 20.00.

Customers exiting onto the street in the small hours would be no less noisy and disruptive than they already are at closing times (e.g. at midnight on May 22nd 2023 we were woken by a fight – possibly a “mock” fight – between a group of young men outside the door to the pub on [REDACTED]).

***Removal of the restriction on numbers – currently 30 - of outside drinkers.** Outside drinkers and eaters are noisy: they shout, cheer, scream down their mobiles, sing etc. Even with a door supervisor 30 is quite often exceeded. There is not space for more than 30. Drinkers stand and sit well outside the pub's curtilage on Marylebone Lane in particular, and on Bentinck Street, blocking the pavements and so endangering pedestrians who are forced to walk in the street.

***Extension of the time drinkers may take drinks outside from 20.30 to 21.30** This would add to the existing nuisance.

***Employing door supervisors following a risk assessment.** Even current supervision is not fully effective (one supervisor said “well, what can I do? All the other pubs spill out like this one”)

I have not complained recently about the noise from the pub nor about the blocking of pavements and the excessive numbers of outside drinkers, as I am sympathetic to the problems of small businesses trying to survive in these difficult times.

NB The green-hatching on the ground-floor plan shows a possibly inaccurate width of the pub's curtilage on Marylebone Lane. It is 28"/71 cms wide, scarcely enough for people to stand in a single line i.e. unsuitable for convivial drinking.

The plan does not show the tables outside the pub on Marylebone Lane. One small table fits into the curtilage, but two large, four-seater+ tables extend well on to the pavement, blocking pedestrians and forcing them into the street.

The proposed plan omits Main Entrance from the Lane door (given on the current plan).

On the basis of prevention of public nuisance, I object to:

The following is what I would say in objecting to the Coachmakers' proposals:

1: *The showing of films on all floors between 10.00 and 1.30 a.m. Monday - Saturday, and 12.00 to 01.00 on Sundays.*

Such showings would disturb the quiet and privacy of

Noise from customers & films inside the pub would spread widely outside, especially in summer when the pub's windows are usually left open. Customers going out on to the street at 1.30 a.m. are likely to be talking and laughing just as noisily as they already do at midnight.

In we have secondary glazing, but we have to keep our windows shut even in the summer to try to reduce the noise which emanates from inside and outside the pub. It disturbs conversations, watching television and listening to music, while we often hear raucous conversation and laughter well after midnight as groups linger before leaving

2: *Recognising that the licensing trade faces difficulties I have tolerated the existing arrangements, (conditions added following a review) even though customers cause nuisance with their loud talk (especially into mobiles), laughter, shouting, singing, music etc. They also block the pavements on both Bentinck Street and on Marylebone Lane, where large tables and chairs extend well beyond the narrow width of the curtilage. I sympathize; but do not think the pub has a right to continue to create such nuisances.*

I consider hours should not be extended beyond already licensed activities. Extension of the time customers may take drinks outside from 20.30 to 21.30 would only make matters a little worse for residents and the general public, unless properly controlled.

In the interests of protecting the public and residents, the restriction on numbers of outside drinkers (currently 30) should NOT be removed. Supervisors often seem to lack the authority to limit numbers, but do exercise some control, and should be retained as at present.

3: *Particularly since the recent installation of a wooden cover for two large bins outside the pub on Bentinck Street there is scarcely enough room for 30 within the pub's curtilage. This number is often exceeded by customers on Bentinck Street standing outside the barriers, which are movable and consequently are sometimes pushed out into the pavement. Customers on Marylebone Lane can hardly fit into the very narrow (71 cms) curtilage, and two large tables extend well into the pavement, dangerously causing many pedestrians to step into the street. These tables, and a smaller one which does fit into the curtilage, are not shown on the proposed plan.*

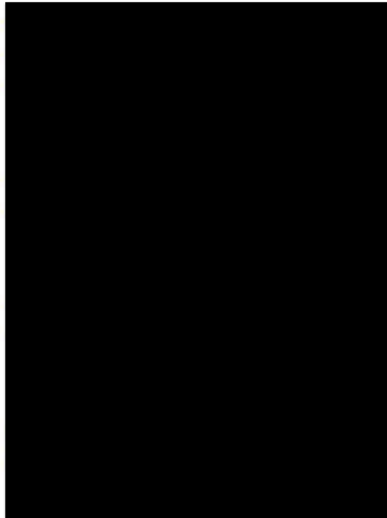

The people listed on this email are [redacted] and we are all directly affected by the Coachmakers Arms application to extend their hours and street numbers.

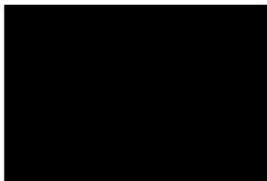

(3) remove and replace conditions relating to door supervisors and the outside drinking area as follows:

to remove from annex 3 condition 20 and replace with the following wording: (*Annex 3 condition 20 limits the number of outside drinkers to 30. The proposed new wording places no limit on the numbers*)

1. Door supervisors shall be employed at the premises based upon a risk assessment carried out taking into account expected audience, time of year and whether there are any special occasions/holidays. All door supervisors will correctly display their SIA licence so as to be visible when on duty at the premises. (*Currently there is regular door supervision*)

to remove from annex 3 condition 27 and replace with the following wording:

On the basis of prevention of public nuisance, I object to:

*Showing films on 4 floors from 10.00 to 01.30 (12.00 - 01.00 Sundays). This would compromise the privacy and quiet of [REDACTED] Despite secondary glazing and shutting our windows, noise penetrates to [REDACTED] affecting conversation, music, etc. Why is permission sought beyond the hours of already-licensed activities?

Noise from customers & films would spread widely, particularly in summer when, contrary to the present licence, windows and external doors are often open after 20.00.

Customers exiting onto the street in the small hours would be no less noisy and disruptive than they already are at closing times.

*Removal of the restriction on numbers – currently 30 - of outside drinkers. Outside drinkers and eaters shout, cheer, scream down their mobiles, sing etc. Even with a door supervisor 30 is quite often exceeded. There is not space for more than 30. Drinkers stand outside the pub's curtilage on [REDACTED] blocking the pavements.

Comments: 23/05/2023 5:25 PM [REDACTED] objects to this licence variation as we believe there will be an increase in public nuisance contrary to policy PN1.

This establishment was subject to a review in 2010 and the resulting licence conditions were acceptable to all locals concerned including the ability for drinkers to imbibe outside the premises up until 20:30. The pandemic then caused numerous changes to many pubs including this one and on a 'temporary basis' licencing conditions were relaxed to try and support the hospitality industry. This support came at the cost to many local residents in terms of increased evening-time noise nuisance from outside dining and drinking. We can see no reason why the conditions should not revert back to the pre-covid post 2010 ones.

In addition, we have local residents reporting to us that the time limit and numbers limit are frequently exceeded in the recent past so we do not agree to the withdrawal of SIA personel at the whim of the licensee. Given that the pavement in Marylebone Lane is rather narrow it is inevitable that pedestrians will be forced into the road so we believe outside control is important. The balance between the desire of the business and the wellbeing of the residents will be enhanced with continued external security personel.

Applicant's Written Submissions

This statement is made in support of an application to vary the premises licence with the intention of outlining the Applicant's case and seeking to address the concerns of those maintaining representations.

Amplification of the points made below, together with further submissions, will be made orally at the licensing sub-committee hearing.

Background

The Applicant acquired the Premises, then a busy bar, in 2017. The Premises was refurbished and the menu changed to reflect the standards of the Applicant's sister pubs and boutique hotels in Belgravia, Knightsbridge, Pimlico, Mayfair, Notting Hill, the West End and the west side of Marylebone. Please see <http://cubitthouse.co.uk/>. Pictures of the Premises are at **exhibit 1** with indicative food and drinks menus at **exhibit 2**. The Premises is divided into a cocktail bar/function room in the basement, a bar and dining room on the ground floor with a small outside area for vertical drinkers on Bentinck Street, a seated outside area (by virtue of a Pavement Licence) on Marylebone Lane and a more formal dining room on the first floor.

Before making this application, formal pre-app advice was sought from Mr Dave Nevitt of Environmental Health (now retired) and letters were posted to the residents of [REDACTED]

Reasons for the Application

The reason for seeking this variation, as per the formal pre-app and as detailed in the application, is threefold:

To vary the approved plan to delineate an outside drinking area and vary times for outside drinking

The current conditions relating to outside drinking are vague, overly restrictive and probably unenforceable. The condition attempting to limit numbers reads:

“Throughout licensable hours no more than 30 patrons shall be permitted to take drinks from the premises in open containers and/or smoke outside at any one time.”

At the pre-app meeting both the writer and Mr Dave Nevitt were unsure as to what this condition means. For example, can any number of patrons be outside with drinks provided only 30 move away from the Premises? Can one patron take numerous drinks for friends already outside and they do not add to the number? Or does it mean that once 30 patrons have stepped outside has the limit been reached even though some patrons have moved back inside? Mr Nevitt was of the view that it would be more sensible to have a delineated outside drinking area which would aid enforcement and ensure that patrons cannot leave the immediate environs of the Premises and, for example, drink on the steps of Bentinck Block opposite the Premises. Hence the application to remove this condition and lodge a plan with a hatched outside area.

Mr Nevitt was also in agreement that an amendment to the permitted outside drinking area was reasonable. When the 21.00 hrs curfew was applied the Premises was a wet-led pub with a high proportion of alcohol sales. Under the supervision of Ben Tish (critically acclaimed chef and author) the upstairs is purely a restaurant and food is becoming far more of a feature on the ground floor. The clientele has also changed with less of a focus on afterwork vertical drinking customers.

To add the provision of films

Whilst there are currently no firm plans in place the Applicant has toyed with the idea of showing films in the basement on quieter nights to create a themed event. For example, you could show a James Bond film with accompanying drinks such as Vespers, Champagne, Vodka Martinis etc.

To remove the requirement to have door supervisors

The requirement to have door supervisors is another hangover from when the Premises was a wet-led operation. No other site in the Cubitt House Group has a door supervisor requirement and there is no such requirement to have door supervisors on other similar establishments in the area. Not only are they very expensive but they give the wrong impression to potential patrons walking past. Nevertheless, the condition proffered does require that the need to have door supervisors is risk assessed and it might be appropriate to employ them at certain times of the year and, for example, when the basement is open late.

The Representations

After reading the comments below, if any interested party wishes to discuss any of the points raised, have remaining concerns or wish to suggest further conditions, they are urged to contact the writer, Niall McCann, at niall.mccann@keystonelaw.co.uk. In these difficult times the Applicant wishes to ensure a good relationship with all more than ever and will happily implement any further measures which are operationally viable.

The Applicant's comments on the representations are as follows:

Environmental Health

Unfortunately, Mr Nevitt retired before the end of the statutory consultation period. Ms Kudzaishe Mondhlani took over the application and has raised a representation. However, following a site visit on 25 May 2023, the Applicant understands that her concerns have been largely alleviated, albeit her representation remains in order to advise the Licensing Sub-Committee.

Local Residents

To avoid duplication, rather than commenting on each representation in turn, the Applicant's comments on the general concerns raised are as follows:

- Noise from the showing of films

As explained above, the wish to show films is merely an idea at present. Any films shown on the ground and first floors are likely to be when these spaces are hired for corporate training days (which is very rare). Any films shown for informative or education purposes are not licensable. Given this, the Applicant is happy to restrict the showing of any films to the basement and proffers the following condition:

“Exhibition of Film as a licensable activity is to be restricted to the basement”

The hours sought for the exhibition of films reflect the current permitted opening hours.

- Concerns in respect of removing the current conditions restricting numbers outside

The rationale behind seeking to remove this condition is explained above. At present there is no restriction on drinking standing well outside the Premises’ curtilage and the proposed variation will directly address the residents’ concerns. By ensuring that outside drinking is kept to the hatched areas there will be an effective limit on numbers in any event.

- Width of the Hatching and the Plan

If this application is granted as sought, the intention is to apply for a pavement licence on Bentinck Street and have standing drinkers on Marylebone Lane, thus reducing the number of patrons facing the residents which have raised representations. The proposed plan shows both doors onto Marylebone Lane.

- Extension of hours

A modest extension to the permitted hours outside is sought. Other pubs in the area (most of which are far more drinks led) are situated close to residential properties and yet do not have such early terminal hours for the use of outside space. Given the markedly different operation of

the Premises to previous guises the Applicant believes that slightly later hours will not have an adverse impact on the public nuisance objective. Also, by having patrons seated immediately facing the main residential block (and by extension often dining) there should be less noise than generated by patrons standing (see above).

For the avoidance of doubt, no application has been made to extend the hours of the Premises. Occasionally the basement of the Premises opens until later than the City of Westminster's Core Hours but only when there is a Temporary Event Notice in place.

- Requirement to have a door supervisor

Most pubs in the City of Westminster, even those that are wet led, do not have a requirement to have a door supervisor on prescribed days. Those that do tend to attract a boisterous crowd and are open late or show Premiership football. This is not the case with the Premises. The Applicant has no knowledge of the alleged fight on 23 May 2023.

In any event, the current door supervisor condition is not fit for purpose with it being restricted to calendar dates and seemingly arbitrary times. Having a risk assessed approach means that the Premises' budget can be better deployed employing door supervisors when they are required. It should be noted that the Metropolitan Police, the 'independent experts' in respect of crime and disorder, have not raised a representation opposing this amendment.

- Pictures in support of the objections

Pictures taken of the outside of licensed premises are often damning, being a mere 'snapshot' rather than an accurate portrayal of an operation over a long period of time. However, in this case, the Applicant does not believe they are incriminating. The pictures that are dated state 2021 and the first undated picture was taken during the City of Westminster's Al Fresco scheme as the yellow barrier closing the street to traffic is visible. This was a time when the country was still in the grip of Covid-19 with many patrons still wanting to eat and drink outside. Whole streets were closed and full of people eating and drinking. Nevertheless, the pictures show a well natured

crowd of both sexes and all ages, seating and standing in small groups chatting. There is no sign of anti-social behaviour.

Westminster City Council's Statement of Licensing Policy (the "Policy") and Case Law

There is no representation from the Licensing Authority – effectively the gatekeeper of the Policy. The Premises is not located within West End Cumulative Impact Area. Therefore, there is no rebuttable presumption to refuse the Application and that the application should be granted if the criteria in CD1, PS1, PN1 and CH1 are met.

As is well documented, it is currently a difficult time for the hospitality industry. At the same time as costs are rising due to inflation there is a cost of living crisis which is reducing patrons' spending power. Whilst a relevant argument Pre-Covid, the consideration of economic factors is now even more important. The Applicant wishes to remind the licensing sub-committee of the case of R (o/a/o Hope and Glory Public House Ltd) v City of Westminster Magistrates' Court and Others [2011] EWCA Civ 31, and the observation of Toulson LJ that:

*"Licensing decisions often involve weighing a variety of competing considerations: the demand for licensed establishments, **the economic benefit to the proprietor and to the locality by drawing in visitors and stimulating the demand**, the effect on law and order, the impact on the lives of those who live and work in the vicinity, and so on."*

Conclusion

This has been a carefully thought-out application where formal pre-app advice was sought and residents warned in advance. The Post-Covid world dictates that operators must avoid unnecessary expenditure and look to maximise what assets they have. The Applicant believes that the current burdens can be eased whilst still upholding the licensing objectives. The operation of the Premises is a world away from what it was in 2010 when the premises licence was reviewed and the Applicant respectfully asks to be permitted to trade in a similar fashion to other comparable venues in Marylebone.

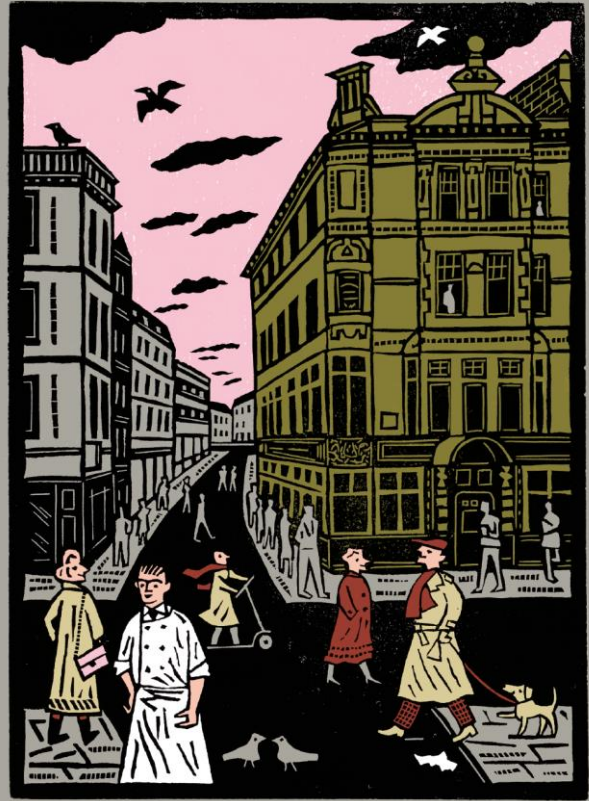

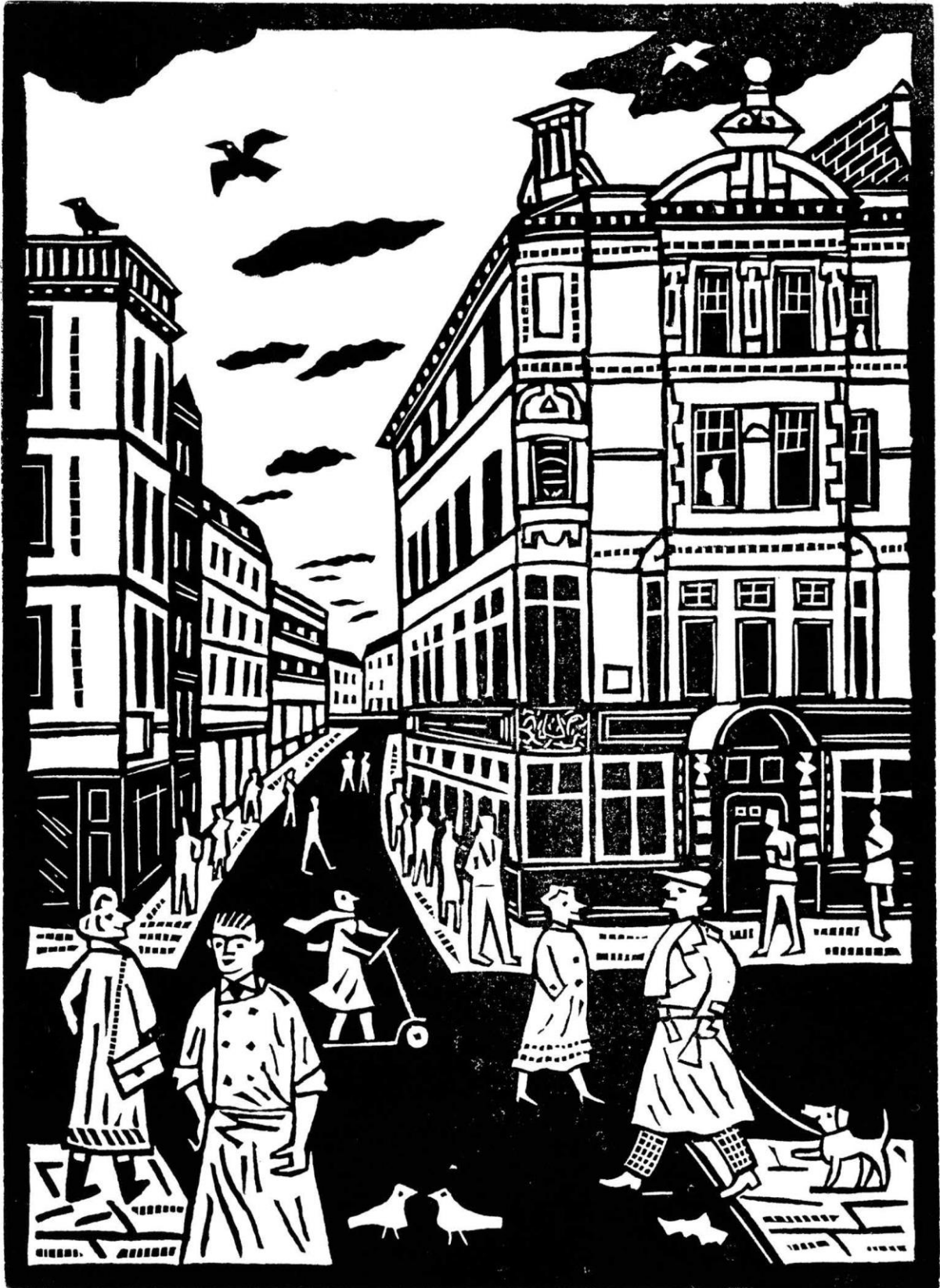

Annex 1 – Mandatory conditions

1. No supply of alcohol may be made at a time when there is no designated premises supervisor in respect of this licence.
2. No supply of alcohol may be made at a time when the designated premises supervisor does not hold a personal licence or the personal licence is suspended.
3. Every supply of alcohol under this licence must be made or authorised by a person who holds a personal licence.
4.
 - (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to;
 - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
 - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
 - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
5. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
6.
 - (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
 - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
 - (a) a holographic mark, or
 - (b) an ultraviolet feature.

7. The responsible person must ensure that—

- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
 - (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

A responsible person in relation to a licensed premises means the holder of the premise licence in respect of the premises, the designated premises supervisor (if any) or any individual aged 18 or over who is authorised by either the licence holder or designated premises supervisor. For premises with a club premises certificate, any member or officer of the club present on the premises in a capacity that which enables him to prevent the supply of alcohol.

8(i) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

8(ii) For the purposes of the condition set out in paragraph 8(i) above -

- (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- (b) "permitted price" is the price found by applying the formula -

$$P = D + (D \times V)$$

Where -

- (i) P is the permitted price,
 - (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
 - (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -

- (i) the holder of the premises licence,
 - (ii) the designated premises supervisor (if any) in respect of such a licence, or
 - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 8(iii). Where the permitted price given by Paragraph 8(ii)(b) above would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 8(iv). (1) Sub-paragraph 8(iv)(2) below applies where the permitted price given by Paragraph 8(ii)(b) above on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.
9. All persons guarding premises against unauthorised access or occupation or against outbreaks of disorder or against damage (door supervisors) must be licensed by the Security Industry Authority.

Conditions reproducing the effect of conditions subject to which the relevant existing licences have effect

10. The terminal hour for late night refreshment on New Year's Eve is extended to 05:00 on New Year's Day.

Annex 2 – Conditions consistent with the operating Schedule

11. The premises shall install and maintain a comprehensive CCTV system as per the minimum requirements of the Westminster Police Licensing Team. All entry and exit points will be covered enabling frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Viewing of recordings shall be made available immediately upon the request of Police or authorised officer throughout the entire 31 day period.
12. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises is open. This staff member must be able to provide a Police or authorised council officer copies of recent CCTV images or data with the absolute minimum of delay when requested
13. A Challenge 21 or Challenge 25 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram
14. An incident log shall be kept at the premises, and made available on request to an authorised officer of the City Council or the Police. It must be completed within 24 hours of the incident and will record the following: (a) all crimes reported to the venue (b) all ejections of patrons (c) any complaints received concerning crime and disorder (d) any incidents of disorder (e) all seizures of drugs or offensive weapons (f) any faults in the CCTV system, searching equipment or scanning equipment (g) any refusal of the sale of alcohol (h) any visit by a relevant authority or emergency service.
15. Substantial food and non-intoxicating beverages, including drinking water, shall be available in all parts of the premises where alcohol is sold or supplied for consumption on the premises.
16. (i) Alcohol may be sold or supplied:
 - (a) Monday to Thursday 10:00 - 23:30
 - (b) Friday to Saturday 10:00 - 00:00
 - (c) Sundays 12:00 - 22:30
 - (d) Bank Holiday Sundays 10:00 - 00:00
 - (e) On New Year's Eve from the end of permitted hours on New Year's Eve to the start of permitted hours on the following day (or, if there are no permitted hours on the following day, midnight on 31st December).
- (ii). Notwithstanding the usual hours for the sale of alcohol and the provision of late night refreshment, in respect of the basement and first floors only, at anytime when the basement and/or first floor are set aside for the provision of table meals to which the sale or supply of alcohol and the consumption of alcohol is an ancillary a table meal, then the terminal hour for the sale of supply of alcohol in such areas shall be 11.30pm on Sundays and midnight on Mondays to Saturdays with an additional 30 minutes drinking up time in each case and the terminal hour for late night refreshment shall be midnight on Sundays and 00.30am on the day following on Mondays to Saturdays.

NOTE - The above restrictions do not prohibit:

- (a) the sale or supply of alcohol to or the consumption of alcohol by any person residing in the licensed premises;

- (b) the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;
- (c) the sale of alcohol to a trader or registered club for the purposes of the trade or club;
- (d) the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces;
- (e) the taking of alcohol from the premises by a person residing there;
- (f) the supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied;
- (g) the supply of alcohol for consumption on the premises to persons employed there for the purposes of the business carried on by the holder of the licence, or the consumption of liquor so supplied, if the liquor is supplied at the expense of their employer or of the person carrying on or in charge of the business on the premises.

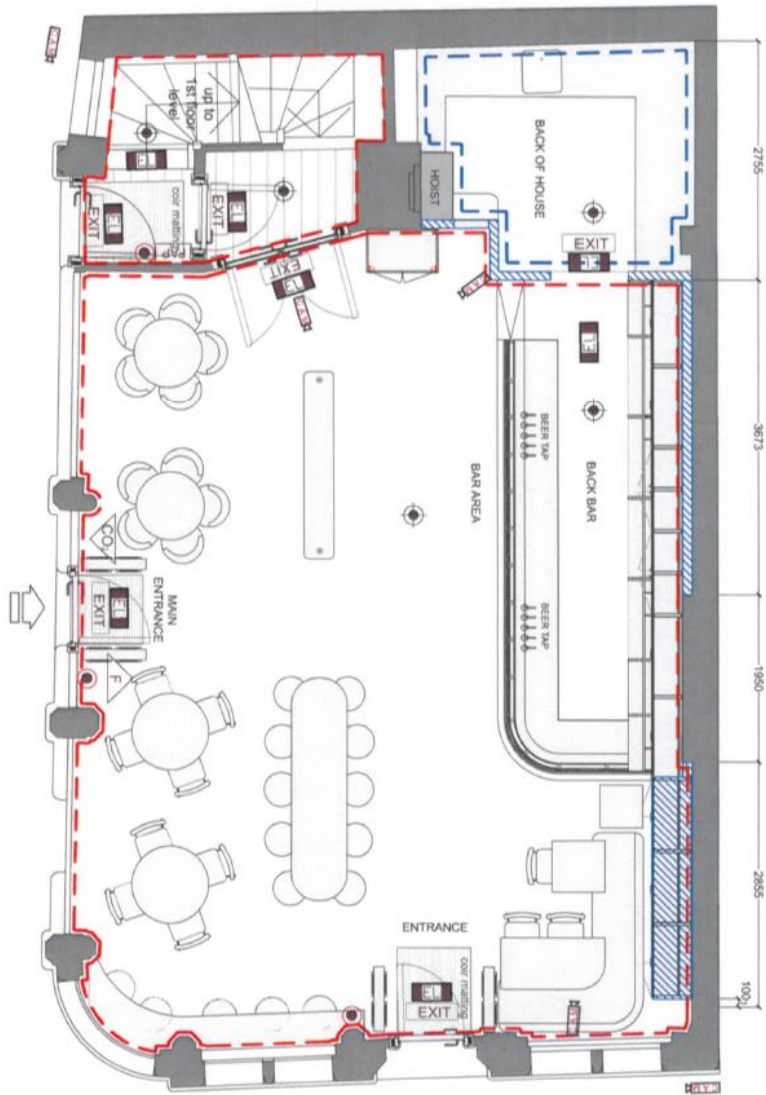
In this condition, any reference to a person residing in the premises shall be construed as including a person not residing there but carrying on or in charge of the business on the premises.

Annex 3 – Conditions attached after a hearing by the licensing authority

17. No noise shall emanate from the premises nor vibration be transmitted through the structure of the premises which gives rise to a nuisance.
18. All windows and external doors shall be kept closed after 20.00 hours, or at any time when regulated entertainment takes place on either the ground or first floor, except for the immediate access and egress of persons.
19. Notices shall be prominently displayed at all exits requesting patrons to respect the needs of local residents and leave the area quietly.
20. From 1st May to 30th September on Thursdays and Fridays, from 5pm to 10pm, there shall be 1 SIA registered door supervisor employed at the premises whose sole responsibility shall be to monitor the use of the outside areas. Outside of those dates and times the premises licence holder shall employ an SIA registered door supervisor where it thinks it is appropriate to do so.
21. The staff at all times shall monitor the activity of persons leaving the premises and when necessary remind them to respect the needs of local residents.
22. No customers shall be permitted to take drinks from the premises in an open container after 20.30 hours and any existing customer drinking in that area shall be cleared by 21.00, this includes those patrons smoking.
23. A sufficient number of clearly marked receptacles shall be provided outside the premises for the disposal of cigarette butts.
24. The pavement from the building line to the kerb edge immediately outside the premises, including gutter/channel at its junction with the kerb edge, shall be swept and or washed, and litter and sweepings collected and stored in accordance with the approved refuse storage arrangements.
25. The highway and other land in the vicinity must be monitored regularly throughout licensable hours to ensure that drinking containers/vessels are removed and best endeavours will be used to prevent public nuisance or obstruction to the public highway.
26. A direct telephone number for the manager at the premises shall be publicly available at all times the premises is open. This telephone number is to be made available to residents in the vicinity.
27. Throughout licensable hours no more than 30 patrons shall be permitted to take drinks from the premises in open containers and/or smoke outside at any one time.

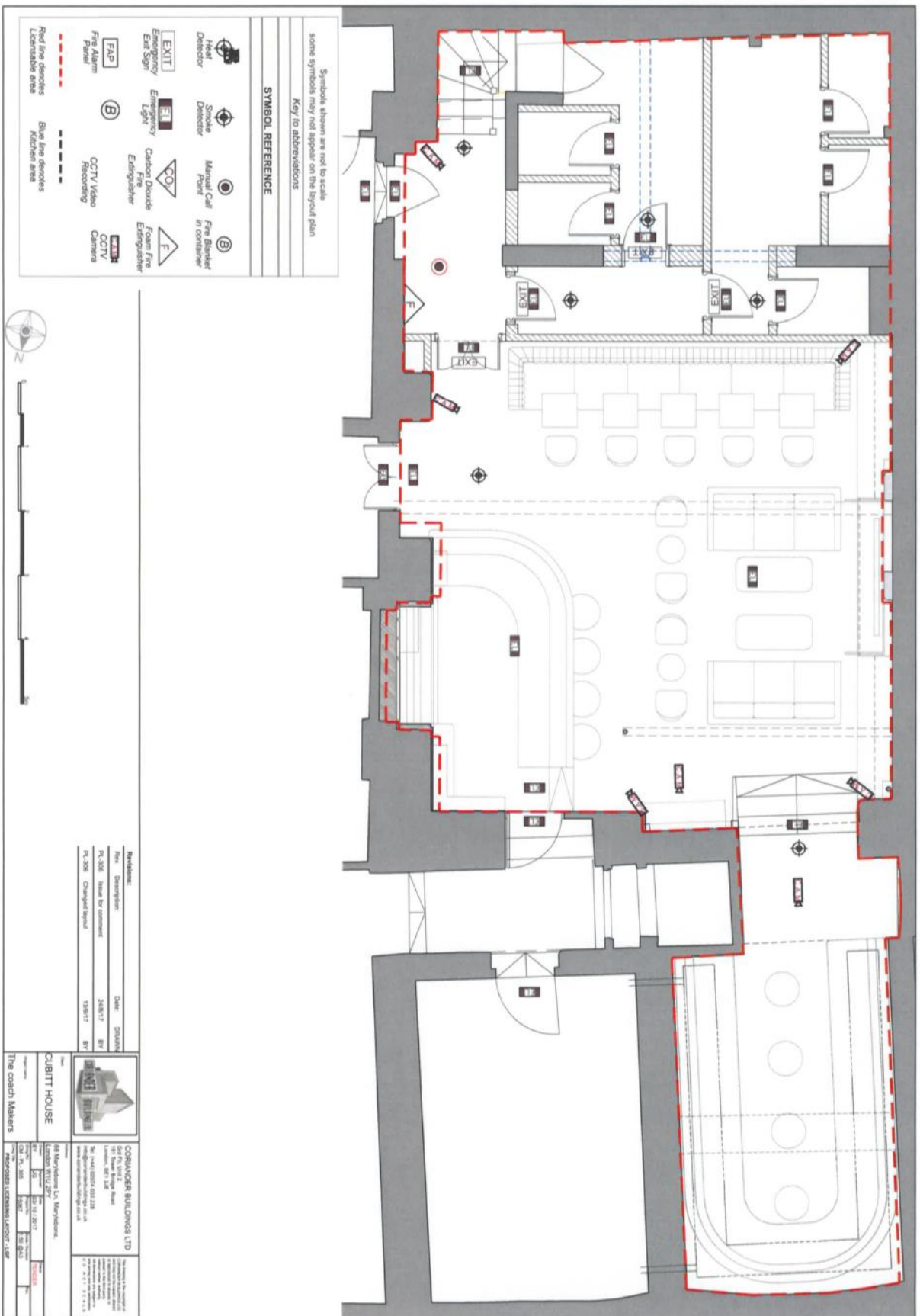

CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE AND CONDITIONS PROPOSED BY A PARTY TO THE HEARING

When determining an application for a new premises licence under the provisions of the Licensing Act 2003, the licensing authority must, unless it decides to reject the application, grant the licence subject to the conditions which are indicated as mandatory in this schedule.

At a hearing the licensing authority may, in addition, and having regard to any representations received, grant the licence subject to such conditions which are consistent with the operating schedule submitted by the applicant as part of their application, or alter or omit these conditions, or add any new condition to such extent as the licensing authority considers appropriate for the promotion of the licensing objectives.

This schedule lists those conditions which are consistent with the operating schedule, or proposed as appropriate for the promotion of the licensing objectives by a responsible authority or an interested party as indicated. These conditions have not been submitted by the licensing service but reflect the positions of the applicant, responsible authority or interested party and have not necessarily been agreed

Conditions: On Current Licence -

Mandatory:

1. No supply of alcohol may be made at a time when there is no designated premises supervisor in respect of this licence.
2. No supply of alcohol may be made at a time when the designated premises supervisor does not hold a personal licence or the personal licence is suspended.
3. Every supply of alcohol under this licence must be made or authorised by a person who holds a personal licence.
4.
 - (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to;
 - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage

or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;

- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
 - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
5. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
6. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
- (a) a holographic mark, or
 - (b) an ultraviolet feature.
7. The responsible person must ensure that—
- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
 - (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml;
 - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
 - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

A responsible person in relation to a licensed premises means the holder of the premise licence in respect of the premises, the designated premises supervisor (if any) or any individual aged 18 or over who is authorised by either the licence holder or designated premises supervisor. For premises with a club premises certificate, any member or officer of the club present on the

premises in a capacity that which enables him to prevent the supply of alcohol.

8(i) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

8(ii) For the purposes of the condition set out in paragraph 8(i) above -

(a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;

(b) "permitted price" is the price found by applying the formula -

$$P = D + (D \times V)$$

Where -

(i) P is the permitted price,

(ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and

(iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

(c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -

(i) the holder of the premises licence,

(ii) the designated premises supervisor (if any) in respect of such a licence, or

(iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

(d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

(e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

8(iii). Where the permitted price given by Paragraph 8(ii)(b) above would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

8(iv). (1) Sub-paragraph 8(iv)(2) below applies where the permitted price given by Paragraph 8(ii)(b) above on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

9. All persons guarding premises against unauthorised access or occupation or against outbreaks of disorder or against damage (door supervisors) must be licensed by the Security Industry Authority.

Conditions reproducing the effect of conditions subject to which the relevant existing licences have effect

10. The terminal hour for late night refreshment on New Year's Eve is extended to 05:00 on New Year's Day.

Annex 2 – Conditions consistent with the operating Schedule

11. The premises shall install and maintain a comprehensive CCTV system as per the minimum requirements of the Westminster Police Licensing Team. All entry and exit points will be covered enabling frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Viewing of recordings shall be made available immediately upon the request of Police or authorised officer throughout the entire 31 day period.
12. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises is open. This staff member must be able to provide a Police or authorised council officer copies of recent CCTV images or data with the absolute minimum of delay when requested
13. A Challenge 21 or Challenge 25 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram
14. An incident log shall be kept at the premises, and made available on request to an authorised officer of the City Council or the Police. It must be completed within 24 hours of the incident and will record the following: (a) all crimes reported to the venue (b) all ejections of patrons (c) any complaints received concerning crime and disorder (d) any incidents of disorder (e) all seizures of drugs or offensive weapons (f) any faults in the CCTV system, searching equipment or scanning equipment (g) any refusal of the sale of alcohol (h) any visit by a relevant authority or emergency service.
15. Substantial food and non-intoxicating beverages, including drinking water, shall be available in all parts of the premises where alcohol is sold or supplied for consumption on the premises.
16. (i) Alcohol may be sold or supplied:
 - (a) Monday to Thursday 10:00 - 23:30
 - (b) Friday to Saturday 10:00 - 00:00
 - (c) Sundays 12:00 - 22:30
 - (d) Bank Holiday Sundays 10:00 - 00:00
 - (e) On New Year's Eve from the end of permitted hours on New Year's Eve to the start of permitted hours on the following day (or, if there are no permitted hours on the following day, midnight on 31st December).
- (ii). Notwithstanding the usual hours for the sale of alcohol and the provision of late night refreshment, in respect of the basement and first floors only, at anytime when the basement and/or first floor are set aside for the provision of table meals to which the sale or supply of alcohol and the consumption of alcohol is an ancillary a table meal, then the terminal hour for the sale of supply of alcohol in such areas shall be 11.30pm on Sundays and midnight on Mondays to Saturdays with an additional 30 minutes

drinking up time in each case and the terminal hour for late night refreshment shall be midnight on Sundays and 00.30am on the day following on Mondays to Saturdays.

NOTE - The above restrictions do not prohibit:

- (a) the sale or supply of alcohol to or the consumption of alcohol by any person residing in the licensed premises;
- (b) the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;
- (c) the sale of alcohol to a trader or registered club for the purposes of the trade or club;
- (d) the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces;
- (e) the taking of alcohol from the premises by a person residing there;
- (f) the supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied;
- (g) the supply of alcohol for consumption on the premises to persons employed there for the purposes of the business carried on by the holder of the licence, or the consumption of liquor so supplied, if the liquor is supplied at the expense of their employer or of the person carrying on or in charge of the business on the premises.

In this condition, any reference to a person residing in the premises shall be construed as including a person not residing there but carrying on or in charge of the business on the premises.

Annex 3 – Conditions attached after a hearing by the licensing authority

- 17. No noise shall emanate from the premises nor vibration be transmitted through the structure of the premises which gives rise to a nuisance.
- 18. All windows and external doors shall be kept closed after 20.00 hours, or at any time when regulated entertainment takes place on either the ground or first floor, except for the immediate access and egress of persons.
- 19. Notices shall be prominently displayed at all exits requesting patrons to respect the needs of local residents and leave the area quietly.
- 20. From 1st May to 30th September on Thursdays and Fridays, from 5pm to 10pm, there shall be 1 SIA registered door supervisor employed at the premises whose sole responsibility shall be to monitor the use of the outside areas. Outside of those dates and times the premises licence holder shall employ an SIA registered door supervisor where it thinks it is appropriate to do so.

Condition 20 is proposed to be varied by the applicant as follows:

- 20. Door supervisors shall be employed at the premises based upon a risk assessment carried out taking into account expected audience, time of year and whether there are any special occasions/holidays. All door supervisors will correctly display their SIA licence so as to be visible when on duty at the premises.
- 21. The staff at all times shall monitor the activity of persons leaving the premises and when necessary remind them to respect the needs of local residents.

22. No customers shall be permitted to take drinks from the premises in an open container after 20.30 hours and any existing customer drinking in that area shall be cleared by 21.00, this includes those patrons smoking.

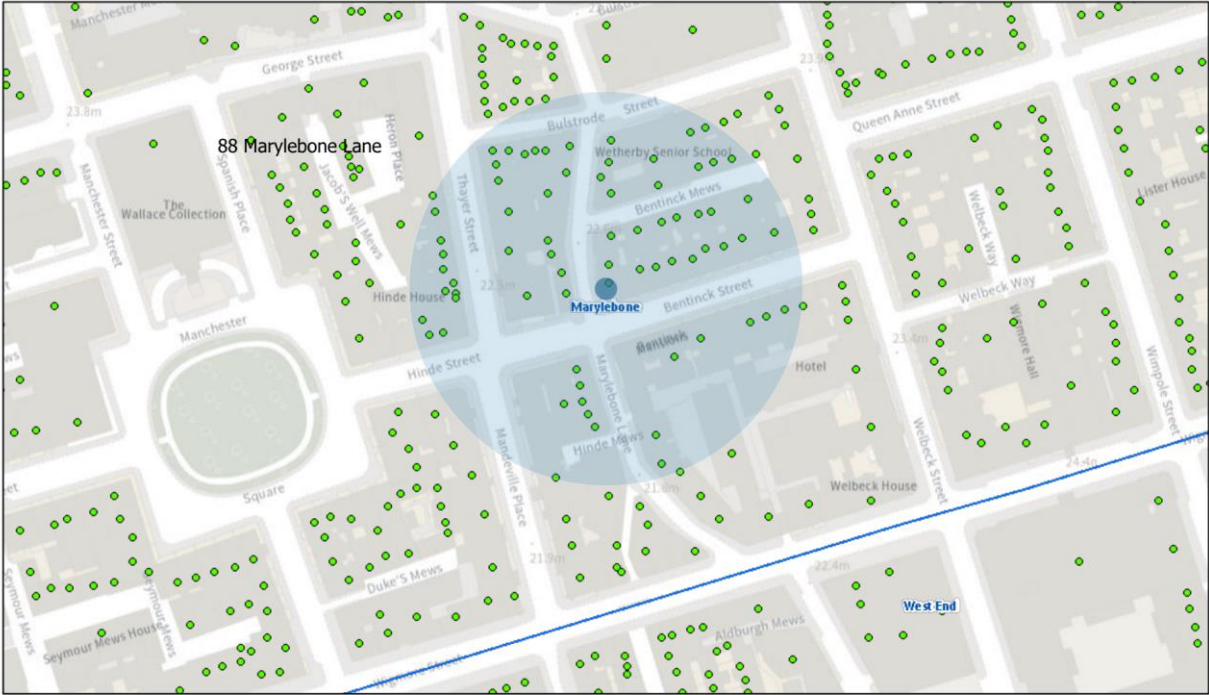
Condition 22 is proposed to be varied by the applicant as follows:

22. No customers shall be permitted to take drinks from the premises in an open container after 21.30 hours and any existing customer drinking in that area shall be cleared by 22.00.
23. A sufficient number of clearly marked receptacles shall be provided outside the premises for the disposal of cigarette butts.
24. The pavement from the building line to the kerb edge immediately outside the premises, including gutter/channel at its junction with the kerb edge, shall be swept and or washed, and litter and sweepings collected and stored in accordance with the approved refuse storage arrangements.
25. The highway and other land in the vicinity must be monitored regularly throughout licensable hours to ensure that drinking containers/vessels are removed and best endeavours will be used to prevent public nuisance or obstruction to the public highway.
26. A direct telephone number for the manager at the premises shall be publicly available at all times the premises is open. This telephone number is to be made available to residents in the vicinity.
27. Throughout licensable hours no more than 30 patrons shall be permitted to take drinks from the premises in open containers and/or smoke outside at any one time.

Condition 27 is proposed to be varied by the applicant as follows:

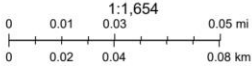
