Hi Karyn & Sally

Thanks for your time today.

Please see attached suggested marked up final set of conditions following the meeting and hatched plan.

The applicant is also willing to amend the regulated entertainment hours (currently unrestricted) in line with the recorded music hours.

Karyn, the applicant submits that the application is policy compliant and can be granted under delegated authority because:

- 1. Under para 2.4.7 of the policy, the current application effectively seeks to *substitute what is authorised* under the existing licence (which is still active) with licensable activities which would have less impact on the area and would be more likely to further the licensing objectives, because:
 - a. The existing licence appears to permit bar use throughout. The current application now proposes a limited bar area with MC38 compliant restaurant use in the majority of the premises.
 - b. There is no real increase in capacity since the existing licence has unrestricted capacity and the new customers in the basement will be set off by the associated reduction on the ground floor.
 - c. The new model licence conditions attached are more likely to promote the licensing objectives than the existing conditions.
 - d. The existing licensed footprint and existing hours means that there can be no additional impact.
 - e. The applicant has proposed to reduce the currently permitted hours for regulated entertainment, again having a positive impact and more likely to promote the licensing objectives.
- 2. Para 2.4.8 recognises a possible policy exception where a licence has lapsed, again because there is effectively no new licensed premises being proposed. The existing licence is still active but it is at threat of it lapsing due to a current proposal to strike off the existing premises licence holder from the Companies House register.
- 3. The original application proposed a licence on the same terms as the existing licence. In the same scenario, a shadow licence application would ordinarily be policy compliant and GDA'd, again because there is no new licensed premises being proposed.
- 4. There are no resident objections.

I would be most grateful for your comments. Hopefully a hearing can be avoided.


