With reference to the above application I am writing to inform you that the Police, as a Responsible Authority, object to your application for a New Premises Licence as it is our belief that if granted the application would undermine the Crime Prevention Objective.

There is insufficient detail in the operating schedule to address the Crime Prevention Objective The hours sought for Alcohol and Late Night Refreshment exceed westminsters core hours policy.

The premises is located within the Notting Hill carnival Footprint, a locality where there is traditionally high crime and disorder. We have concerns that this application could cause further policing problems.

It is for this reason that we are objecting to the application

I refer to the application for a new Premises Licence for the above premises. This representation is based on the Operating Schedule and the ground floor plan of the premises, which is titled with the address and drawing number 2009/07-01.

The applicant is seeking the following on the ground floor:

- 1. To allow the Supply of Alcohol 'off' the premises Monday to Saturday 07:00-00:00 hours and Sunday 08:00-23:00 hours.
- 2. The provision of Late Night Refreshment Monday to Saturday 23:00-00:00 hours. To also allow this on Notting Hill Carnival weekend

I wish to make the following representation in relation to the above application:

- 1. The provision of the Supply of Alcohol may cause an increase in Public Nuisance in the area.
- 2. The provision of Late Night Refreshment may cause an increase in Public Nuisance in the area.

The applicant has proposed conditions within the operating schedule which are being considered. Further conditions may be proposed by Environmental Health in order to help prevent Public Nuisance.

The granting of the new Premises Licence as presented would have the likely effect of causing an increase in Public Nuisance in the area.

Extending the licence to sell alcohol beyond 11 pm is likely to increase the risk of anti-social behaviour in and around the Brunel Estate, with a significant number of young people and vulnerable adults in the immediate vicinity.

I strongly object the extension of license, on the basis of potential late night anti social behaviour which may occur. The supermarket is surrounded by the Brunel estate, which is home to many upstanding citizens, but also home for many people with drink, drug and mental problems. I feel a supermarket that is providing alcohol until 12am to pose a serious risk to the safety of local residents, passers-by and themselves. It will place increased burden on already pressured police and health services.

I have no problem with the sale of Grocery past their usual close time (which I believe to be 11pm at the moment) but the sale of alcohol should not be allowed. This condition should be on the basis that no rubbish depositing outside the premises will be conducted after 11pm - and general respect for neighbours is exercised by being aware about noise.

In summary, I object profusely to this application.

We have no objection to an 'off sales' licence on these premises provided following conditions are on licence:

Hours within WCC 'Core Hours' for 'Off Sales' or less if requested by police as application is for much longer hours on all days

No beer / cider over 5.5% APV.

No miniatures of spirits (whisky / vodka etc) to be sold

All off sales in sealed containers

No 'self service ' of alcohol.

All alcohol stored behind counter.

If wine & beer to be displayed in store we would wish them to be displayed in lockable cabinets that are locked outside hours permitted for sale of alcohol as premises open more than WCC 'Core Hours'

Challenge 25 to be in operation at all times.

Delivery times & refuse & recycling collections to premises not to be between (2000 & 0800 with Sundays & Bank Holidays 1800 & 0100).

We are concerned as to 'off sales' during the Notting Hill Carnival over the August Bank Holiday. We will guided by police on this matter but we would want no 'off sales' over the Carnival and also security guards at entrance to premises may be required

More details on type of 'off sales' and assume no delivery from phone order as concerned as to minors ordering alcohol.

4. Equality Implications

CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE AND CONDITIONS PROPOSED BY A PARTY TO THE HEARING

When determining an application for a new premises licence under the provisions of the Licensing Act 2003, the licensing authority must, unless it decides to reject the application, grant the licence subject to the conditions which are indicated as mandatory in this schedule.

At a hearing the licensing authority may, in addition, and having regard to any representations received, grant the licence subject to such conditions which are consistent with the operating schedule submitted by the applicant as part of their application, or alter or omit these conditions, or add any new condition to such extent as the licensing authority considers necessary for the promotion of the licensing objectives.

This schedule lists those conditions which are consistent with the operating schedule, or proposed as necessary for the promotion of the licensing objectives by a responsible authority or an interested party as indicated. These conditions have not been submitted by the licensing service but reflect the positions of the applicant, responsible authority or interested party and have not necessarily been agreed

Mandatory Conditions

- 1. No supply of alcohol may be made at a time when there is no designated premises supervisor in respect of this licence.
- 2. No supply of alcohol may be made at a time when the designated premises supervisor does not hold a personal licence or the personal licence is suspended.
- 3. Every supply of alcohol under this licence must be made or authorised by a person who holds a personal licence.
- 4. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
 - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
 - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
 - (a) a holographic mark, or
 - (b) an ultraviolet feature.
- 5(i) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 5(ii) For the purposes of the condition set out in paragraph 5(i) above -

- (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- (b) "permitted price" is the price found by applying the formula -

P = D+(DxV)

Where -

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
 - (i) the holder of the premises licence,
 - (ii) the designated premises supervisor (if any) in respect of such a licence, or
 - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 5(iii). Where the permitted price given by Paragraph 5(ii)(b) above would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 5(iv). (1) Sub-paragraph 5(iv)(2) below applies where the permitted price given by Paragraph 5(ii)(b) above on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
 - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Conditions proposed by the Police and agreed by the applicant so as to form part of the operating schedule

- 6. On the Sunday and Monday of the Notting Hill Carnival:
 - a) There will be no sale of alcohol in glass vessels from the premises; and
 - b) There will be no external advertisement of alcohol promotions at the premises.
 - c) There shall be no sale of alcohol from the premises after 20:00 hours.

Conditions proposed by the Environmental Health and agreed by the applicant so as to form part of the operating schedule

- 7. The licensable activities authorised by this licence and provided at the premises shall be ancillary to the main function of the *premises* as newsagents/convenience store.
- 8. There shall be a personal licence holder on duty on the premises at all times when the premises are authorised to sell alcohol.
- 9. There shall be no consumption of hot food or hot drink on the premises between the hours of 23:00-05:00 hours.
- 10. All sales of alcohol for consumption off the premises shall be in sealed containers only, and shall not be consumed on the premises.
- 11. No more than 15 % of the sales area to be used at any one time for the sale, exposure for sale, or display of alcohol.
- 12. No super-strength beer, lagers or ciders of 5.5% ABV (alcohol by volume) or above shall be sold at the premises except for premium beers, lagers or ciders, sold in glass bottles.
- 13. There shall be no self service of spirits on the premises except for spirit mixtures below 5.5% Alcohol by Volume.
- 14. Prominent signage indicating the permitted hours for the sale of alcohol shall be displayed so as to be visible before entering the premises, where alcohol is on public display, and at the point of sale.
- 15. Outside of the hours authorised for the sale of alcohol and whilst the premises are open to the public, the licence holder shall ensure that all alcohol within the premises (including alcohol behind the counter) is secured in a locked store room or behind locked grilles, locked screens or locked cabinet doors so as to prevent access to the alcohol by both customers and staff.
- 16. A Challenge 25 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram.
- 17. All tills shall automatically prompt staff to ask for age verification identification when presented with an alcohol sale.
- 18. A log shall be kept detailing all refused sales of alcohol. The log should include the date and time of the refused sale and the name of the member of staff who refused the sale. The log shall be available for inspection at the premises by the police or an authorised officer of the City Council at all times whilst the premises is open.
- 19. No noise generated on the premises, or by its associated plant or equipment, shall emanate from the premises nor vibration be transmitted through the structure of the premises which gives rise to a nuisance.
- 20. All waste shall be properly presented and placed out for collection no earlier than 30 minutes before the scheduled collection times.
- 21. No waste or recyclable materials, including bottles, shall be moved, removed or placed in outside areas between 23.00 hours and 07.00 hours.

- 22. Deliveries to the premises shall only take place between 0700 and 2300 hours.
- 23. During the hours of operation of the premises, the licence holder shall ensure sufficient measures are in place to remove and prevent litter or waste arising or accumulating from customers in the area immediately outside the premises, and that this area shall be swept and or washed, and litter and sweepings collected and stored in accordance with the approved refuse storage arrangements by close of business.
- 24. The Licence will have no effect until the premises have been assessed as satisfactory by the Environmental Health Consultation Team and this condition has been removed from the Licence.

- 25. No beer / cider over 5.5% APV
- 26. No miniatures of spirits (whisky / vodka etc) to be sold
- 27. All off sales in sealed containers
- 28. No 'self service ' of alcohol.
- 29. All alcohol stored behind counter.
- 30. If wine & beer to be displayed in store we would wish them to be displayed in lockable cabinets that are locked outside hours permitted for sale of alcohol as premises open beyond WCC 'Core Hours'
- 31. Challenge 25 to be in operation at all times.
- 32. Delivery times & refuse & recycling collections to premises not to be between (2000 & 0800 with Sundays & Bank Holidays 1800 & 0100).
