I am happy with the amended list of conditions. However I would point out that condition 8 is

ambiguous. My suggestion is that as ANY event continuing after 23:00 is by definition major this is amended to read as follows:

For all major events no music noise shall be audible within noise sensitive premises with windows open in a typical manner for ventilation after 23:00 (save for the Summer Ball where this will apply after 00:00).

The current wording suggests that for any event which continues after 23:00 the condition applies at all times, which is, I assume, not the intention.

With this small amendment the CGCA will withdraw its Representation.
