I write in relation to the application submitted for a new premises licence for Unit 1, Basement And Ground Floor, Ilona Rose House, Manette Street, London, W1D 4AL

As a responsible authority under section 13 (4) of the Licensing Act 2003 as amended under the Police and Social Responsibility Act 2011, the Licensing Authority have considered your application in full. The Licensing Authority has concerns in relation to this application and how the premises would promote the four Licensing Objectives:

- Public Nuisance
- Prevention of Crime & Disorder
- Public Safety
- Protection of children from harm

The application seeks the following:

• Late Night Refreshment

Monday to Saturday 23:00 to 01:00 Sunday 23:00 to 23:30

Non-Standard Timings: These hours to be extended from the end of permitted hours on New Year's Eve to the start of permitted hours of New Year's Day.

• Supply of Alcohol On and Off Premises

Monday to Saturday 10:00 to 01:00 Sunday 12:00 to 23:30

Non-Standard Timings: These hours to be extended from the end of permitted hours on New Year's Eve to the start of permitted hours of New Year's Day.

• Opening Hours to Public

Monday to Saturday 08:00 to 01:00 Sunday 00:00 to 23:30

Non-Standard Timings: These hours to be extended from the end of permitted hours on New Year's Eve to the start of permitted hours of New Year's Day.

The premises is located within the West End Cumulative Impact Area and as such various policy points must be considered, namely CIP1, HRS1 and PB1.

The Licensing Authority notes that Ilona Rose House comprises of four units which all currently benefit from premises licences. The applicant is proposing to amalgamate part of Unit 4 (basement) into Unit 1 with the same hours and conditions that were granted at Licensing Sub-Committee on the 2^{nd of} December 2021. The applicant has proposed MC61 within the operating schedule so both licences will be surrendered if this application is granted.

MC61 - No licensable activities shall take place at the premises until premises licence 21/07023/LIPN and 21/07004/LIPN (or such other number subsequently issued for the premises) has been surrendered and is incapable of resurrection.

The proposed operating hours applied for licensable activities currently fall outside of Westminster's core hours. For premises for the supply of alcohol for consumption on and off the premises and other licensable activities, the Licensing Authority encourage that the applicant reduce the hours to be within Westminster's Core hours under HRS1 Policy.

The applicant has proposed within the operating schedule a varied version of MC66;

After 21:00 the premises shall only operate as a restaurant:

in which customers are shown to their table or the customer will select a table themselves,

- a. where the supply of alcohol is by waiter or waitress service only,
- b. which provide food in the form of substantial table meals that are prepared on the premises and are served and consumed at the table,
- c. which do not provide any takeaway service of food or drink for immediate consumption off the premises,
- d. where alcohol shall not be sold or supplied, otherwise than for consumption by persons who are seated in the premises and bona fide taking substantial table meals there and provided always that the consumption of alcohol by such persons is ancillary to taking such meals.

- e. For the purpose of this condition 'Substantial Table Meal' means a meal such as might be expected to be served as the main midday or main evening meal, or as a main course at either such meal and is eaten by a person seated at a table, or at a counter or other structure which serves the purposes of a table and is not used for the service of refreshments for consumption by persons not seated at a table or structure servicing the purposes of a table.
- f. Notwithstanding this condition customers are permitted to take from the premises part consumed and resealed bottles of wine supplied ancillary to their meal.
- g. Before 21:00, alcohol may only be sold to persons seated and served by waiter/waitress service and restricted to no more than 50 customers at any time, as specified.

Westminster's PB1 Policy states that a premises would be considered as a bar under the policy if it is providing alcohol as its primary function and has the general presumption to refuse applications within the Cumulative Impact Zone. The Licensing Authority cannot consider this application to be that of a restaurant as the applicant has only proposed model condition 66 after 9pm. Before 9pm the applicant has proposed part g or MC 66 for persons to be seated, served by waiter/waitress service and restricted to no more than 50 persons but the as the hours are significantly greater than those proposed with the Sale of Alcohol with a table meal the applicant will need to demonstrate exceptional circumstances to depart from this policy.

The Licensing Authority encourages the applicant to provide further submissions as to how the premises will not add to cumulative impact in the West End cumulative impact area, in accordance with policy CIP1.

The Licensing Authority looks forward to receiving further submissions from the applicant in due course to be able to assess any further relevant policy considerations.

The Soho Society's Position

We object to this application for a new 1am restaurant with a capacity of 431 which includes 90 customers where before 9pm alcohol may be sold to patrons seated, on the grounds of prevention of crime and disorder, prevention of public nuisance, and cumulative impact in the West End Cumulative Impact Zone.

The Soho Society was unaware of the 4 applications granted for these premises in 2021, had we been aware we would have submitted representations against all four applications presenting a robust case for refusal. The reason for this omission is the Society relies on Licensing News for the list of applications within the West End Ward, reviewing the 2021 editions we were surprised to find these applications appeared under the ward heading of N/A and not West End unlike all other applications relating to Ilona Rose House. We now present different evidence to that before the Licensing Sub-Committee in 2021 and therefore look afresh at these new applications.

As background the Sub-Committee will be aware that four 2017 provisional statement licences were granted with a terminal hour of 1am, and on the understanding that the restaurant condition MC66 would always operate throughout all four premises. However, in 2021 four new licences were granted again until 1am, but MC66 was replaced with after 9pm the premises will only operate as a restaurant, before 9pm alcohol may be sold to person seated. Overall this scheme is huge, with a capacity of 837, 601 being internal seating and 236 external, the number where alcohol maybe sold until 9pm (without a substantial table meal) being 200. It is against this backdrop this application and that of Unit 2 22/03404/LIPN needs to be considered not only as standalone applications, but also within the context of the whole scheme and its impact on cumulative impact and the licensing objectives.

Of importance is the publication of the Cumulative Impact Assessment in 2020 which highlighted the rise in cumulative impact between 2017 - 2019 resulting in the West End being identified as being the only area suffering from cumulative impact. The assessment presents overwhelming evidence of the year on year increase in cumulative impact in the West End Zone 1, it highlights the rate of crime as 10 - 13 times higher between 6pm - 6am compared to the borough average.

The evidence presented in the Cumulative Impact Assessment is not surprising considering Soho has a large concentration of licensed premises, **466** with a large proportion (25%) being late night licences, **118** licensed between the hours of 1am - 6am, with a capacity of over **22,480.** There are over 200 restaurants, 39 bars, 46 pubs, 31 clubs (including members clubs) and entertainment premises. The area is densely populated at night with people drinking on the streets, creating loud levels of noise, causing disturbance and anti-social behaviour, the area has the highest level of cumulative impact in Westminster.

These premises are situated next to Greek Street which is at the heart of the evening and night time economy, alongside Old Compton Street, Frith Street and Dean Street this area has the highest concentration of licensed premises in Soho, a total **of 110 from 12am - 3.30am with a capacity of over 10,002**. Greek Street has 13 licences post 1am, and 6 with a terminal hour of 3am, patrons from these premises will be attracted to continue their night out and will find a number of late night establishments on this street and those that surround it. Theres's also a high probability they will become victims of crime as Greek Street has the highest recorded level of crime and is a known robbery hotspot late at night. (See Prevention of Crime and Disorder).

It is our position that the licences granted in 2021 and the application proposed today will fail to promote the licensing objectives and increase cumulative impact in Soho.

Statement of Licensing Policy

This application fails a number of policy tests which includes the Cumulative Impact Policy CIP1, Hours Policy HRS1, Restaurant Policy RNT1 and Pubs and Bars Policy PB1.

This area has been identified by the Westminster City Council as under stress because the cumulative effect of the concentration of late night and drink led premises and night cafes has led to serious problems of disorder and/or public nuisance affecting residents, visitors and other businesses. The evidence presented in the Cumulative Impact Assessment 2020 is overwhelming, it describes the high level of cumulative impact in the West End Zone between 2017-2019, the subsequent Statement of Licensing Policy 2021 Cumulative Impact Policy CIP1 states.

'The West End Cumulative Impact Zone has been identified because the cumulative effect of the concentration of late night and drink led premises and/or night cafés has led to serious problems of disorder and/or public nuisance affecting residents, visitors and other businesses. The extent of crime and disorder and public nuisance in the West End Cumulative Impact Zone arises from the number of people there late at night; a considerable number of them being intoxicated (our emphasis). Public services, including police, health and emergency, transport, environmental services (cleansing and refuse services) are placed under chronic strain by existing levels of activity, as are civic amenities and the quality of residential life. The urban infrastructure cannot sustain any further growth in licensed premises that provide a significant risk of a variety of harmful outcomes. Over a period of three years (2017 - 2019) 45% of violent crimes, as well as over half of all robberies, thefts and drug offences in the city were recorded within West End Cumulative Impact Zone. Additionally, 43% of ambulance callouts between that same period to the locations of licensed premises feel within this zone.' (D4)

This evidence supported further policy restrictions in the West End, however, the impact of COVID-19 resulted in the Licensing Authority deciding not to implement greater restrictions at this stage, but it may in the lifetime of the policy if footfall moves toward pre-March 2020 levels

(D1). Soho is fully open for business and thriving, there are more people on the streets in the evening now that at pre-COVID times, in our view we have already reached pre-March 2020 levels and this is further supported by recent crimes statistics which show an increase in serious crime (see the Prevention of Crime and Disorder).

The policy test for this new late night restaurant is that it will not add to commutative impact,

'Applicants for licences for premises uses that do not have a presumption to refuse must provide evidence that they will not add to cumulative impact zone the West End Impact Zone. The applicant must provide significant mitigation within the operation schedule and the rationale on how their operation will not add to cumulative impact.' (D2)

'Applicants that fail to add sufficient information within their operating scheduled and don't adequately demonstrate how they will not add to cumulative impact may have all or part of they application refused, if representations are received.' (D2)

Furthermore, the applicant also proposes bar use until 21:00 for no more than 90 customers at any one time, in relation to this the Cumulative Impact Policy states,

'The 2020 Cumulative Impact Assessment identified that incident rates associated with cumulative impact increased rapidly from 9pm. Although there is a general presumption to refuse applications for music and dance venues and pubs and bars within the West End Cumulative Impact Zone under this policy, an exception may be permitted to applications that have a terminal hours of no later than 9pm and meet other policies within this statement.' (D13)

We have seen a number of these types of applications in 2021 where a 9pm licence for bar use has been granted for restaurants which then stay open for much later. Our understanding of this policy is that it is not intended for restaurants to have bar use until 9pm, the relevant sections of the RNT policy still apply to this type of application, i.e. that the Licensing Authority is not in general minded to relax conditions permitting bar use. Therefore, the applicant needs to demonstrate a genuine exception to policy.

The Restaurant Policy RNT1 is clear in raising concerns regarding restaurants turning into bars, it states,

'The Licensing Authority is particularly concerned that restaurant premises within the West End Cumulative Impact Zone do not, even in part, come to operate as bars and particularly not as 'vertical drinking' premises where customers consume alcohol throughout the evening.' (F112)

However, it continues, 'Submission has been made that not every individual in a group may wish to eat but should not be prevented from accompanying diners and having a drink. The Licensing Authority, however, is not minded to relax the conditions for restaurants where alcohol may only be consumed by persons as an ancillary to their substantial table meal.'

Section C; defines restaurants as,

- **4.** 'Where alcohol shall not be sold, supplied, or consumed on the premises otherwise than to persons who are bona fide taking substantial table meals and provided always that the consumption of alcohol by such persons is ancillary to taking such meals.'
- **5.** 'The sale of alcohol prior to such meals may be in a bar area but must also be ancillary to the taking of such meal.'

This application proposes to strip away the restaurant condition, changing the operation in part by creating the opportunity for 90 customers (not an insignificant number) to drink all day without taking a substantial table meal, everything the Statement of Licensing Policy aims to prevent.

The Cumulative Impact Assessment clearly states cumulative impact exists from 6pm - 6am and with a rapid increase from 9pm; however the fact that it exists from 6pm and continues to build is an important point, that it increases from 9pm is no justification to grant such an application

when the evidence against it is so overwhelming. What is forgotten is this is an increase of 90 'new' people in Soho drinking until 9pm, adding to cumulative impact as the hours go by and they will without doubt go on to continue drinking in the large number of bars in the area, in short this policy just adds to cumulative impact. The applicant needs to demonstrate there is an genuine exception to policy and that they will not add to cumulative impact, this is an impossible task.

It goes without saying that an additional 431 people in Soho, including 90 who have been drinking until 9pm will add to cumulative impact, we find no reason for an exception in this case.

The Licensing Objectives

The Statement of Licensing Policy 2021 or Section 182 Guidance does not provide for any circumstance, including exceptional or otherwise, which would permit an application to be granted if the licensing objectives were harmed. We now consider the impact of this application on these objectives.

Prevention of Crime and Disorder - CD1

Under this Policy the criteria applied is, 'whether the premises make or will make a significant contribution to levels of crime and disorder, and whether the operating schedule is based on an adequate risk assessment, undertaken by the applicant, which takes account of all the relevant considerations below to reduce the likelihood of crime and disorder occurring as a result of the grant of the application.'

The Cumulative Impact Assessment 2020 presents overwhelming evidence of the year on year increase in cumulative impact in the West End Zone 1, *it highlights the rate of crime as 10 - 13 times higher between 6pm - 6am compared to the borough average.* It goes on to detail the number and types of crimes in the West End,

• Public realm crimes: (serious violence, robberies, theft and drug offences), alcohol-related callouts incidents, anti-social behaviour and demands on services were prevalent in Westminster between 2017 and 2019, among the highest in London and the country. All incidents observed concentrated in the West End many occurring in the evening and at night as well as weekends.

Total incident type 2017-2019:

- Drug Offences Night: **1529** (proportion of Borough's incidents **40%**)
- Robberies Night: 2237 (33%)
- Theft and Handling Night: 24,407 (33%)
- Serious violent crimes Night: 795 (31%)
- Ambulance call outs to locations of licensed premises: 5353 (22%)
- Noise Complaints Night: 1389 (16%)
- Anti-Social behaviour MPS: 9662 (16%)
- Anti-Social behaviour on transport Night: 592 (13%)
- Reactive Waste Management: 6630 (10%)

Total = 52,594

- Data description of incidents in 2017-2019 found all incident categories observed varied both in space and time. Many occurred in the evening and at night and on weekends when alcohol related activities typically peak. Incidents where primarily concentrated in the West End where licensed premises are disproportionally concentrated.
- **Robberies:** clustered within the West End, Charing Cross, Oxford Street in the evening and night.
- Serious violent crimes: recorded between 6pm and 6am concentrated overwhelmingly in the West End.

- **Drug related crimes**: Westminster recorded the highest volume of drug offences of any borough between 2017-2019. Half of crimes were reported (48%) in the evening and night time. Drug related crimes between **6pm 6am** were significantly clustered in and around the West End to varying degrees.
- **Theft and Handling:** the most common crime type in the borough and in the evening and night this is particularly concentrated in the West End and along Oxford Street.

These premises are situated in the heart of the food and beverage / entertainment area, the area is a known hotspot for crime and disorder, the current statistics for the *top crime streets in Soho shows a total of 1,827 crimes; Greek Street 1st on the list with 239 and Old Compton

Comparing the top reported crimes from *November 2021 - February 2022 to pre- COVID times highlights the number of serious and violent crimes are on the increase;

Violence against the person serious wounding: 32 up 78% (18 pre - COVID)

Violence against the person assault with injury: 59 up 31% (45 pre-COVID)

Violence against the person common assault: 70 up 18% (59 pre-COVID)

Drugs possession: 115 up 79% (64 pre-COVID)

Sexual offences: 34 up 70% (20 pre-COVID) * Data provided by the Metropolitan Police

For residents living in this area the findings of the Cumulative Impact Assessment and the recent crime figures are unsurprising. Soho transforms in the evening and night-time into an area which feels very unsafe and where levels of crime and disorder are high. As evidenced above, criminal activity associated with the large number of venues and the numbers of people on the streets at night results in high levels of serious crime.

The crime figures highlighted above provides the evidence that this area has the highest level of crime in Soho. The majority of robberies take place at night and these take place on Greek Street, it being a known robbery hotspot where people are targeted as they leave venues. Alongside this is drug dealing, which is a real problem with groups of dealers congregating to sell drugs and specifically targeting people as they leave premises. There are more dealers in the area at night than during the day, this is directly linked to the large number of venues and people out on the streets which creates the drugs market.

Intoxicated people become victims of crime, adding a further 431 intoxicated people in this area at night will without doubt increase crime and disorder and fail to promote this licensing objective.

Public Safety Policy PS1

Under Criteria number 1, the applicant needs to,

"...demonstrate that the public will be safe within and in the vicinity of the premises"

Drunk and highly intoxicated people on the streets late at night are very vulnerable requiring support and to prevent them from becoming victims of crime. To help people who become vulnerable on a night out the Council with the LGBT Foundation has established the Soho Angels. As the Committee will know, these are groups of volunteers who work on Friday and Saturday nights between 10pm and 5am helping vulnerable or distressed people people on a night out. They work with St. John Ambulance who provide medical assistance at a eight bedded night hub at St. Anne's Church on Dean Street.

In their first year of operation they helped over 1,200 people, with medical assistance being given to 230 cases of which 80 were classed as serious incidents, and 40 crimes were reported. This is further evidence of the impact of the large number of late night premises and people out on the streets that a dedicated team of volunteers are required to help keep them safe from harm.

Prevention of Public Nuisance Policy PN1

Under this Policy the criteria applied states, 'the potential for nuisance associated with the style, characteristics and activities of the business to be carried on at the premises and the potential steps which could be taken to reduce the risk of a nuisance occurring. This will particularly apply in areas of residential accommodation and where there is residential accommodation in the proximity of the premises.'

The Sub-Committee will beware this scheme contains 8 affordable housing units at 12-14 Greek Street, these being two bedded units with dual aspect onto Greek Street and the inner courtyard which contains the outdoor seating. All homes also have an external balcony space which overlooks the courtyard. We are therefore very concerned that these residents will be disturbed by 116 patrons eating and drinking on the external tables and chairs until 11pm and also by the 315 patrons as they leave these premises at 1am. Add to this the two other restaurants in the courtyard and the total figure is 834 (598 internal, external 236) including 200 drinking until 9pm, it creates an environment where noise nuisance and disturbance is inevitable. We all know patrons do not leave premises quietly, they hang around outside speaking in loud voices, some waiting for taxi's others just chatting, at night noise travels and these residents will be disturbed by it.

Patrons will also be attracted to continue their night out in Soho, going into Greek St and the streets that surround it. Residents live all the way along these streets and during the evening and night time the area changes, it attracts large numbers of people on a night out, either eating or drinking in the numerous restaurants, bars and clubs, entertainment establishments, or those arriving from elsewhere to continue their evening, people just walking through and others hanging around and loitering. Coupled with its narrow streets it creates the perfect environment

where large numbers of intoxicated people create noise and disturbance, criminals wait to prey on the vulnerable alongside drugs dealers and where pedicabs seize the opportunity to park up blaring out amplified music waiting for an unsuspecting victim, anti-social behaviour of street fouling, including doors ways and entrances to flats. It is therefore unsurprising that residents constantly experience noise nuisance and disturbed sleep.

In summary

The application proposes a new late night restaurant, with an overall capacity of 431 and where 90 patrons can consume alcohol until 9pm without taking a substantial meal. We have presented evidence of an area with increasing levels of serious crime and noise nuisance, this application will increase cumulative impact and fail to support the licensing objectives, it should therefore be rejected.

This Representation is being made on behalf of the Covent Garden Community Association. Although the premises are not situated in the CGCA's area the route away from the premises along Manette Street will bring customers onto Charing Cross Road close to residential accommodation on the East side of the road in the CGCA's area of concern.

The CGCA was not aware of the original applications for this site. We usually review West End applications in order to be aware of ones in the vicinity but it appears that these were not published in Licensing List as West End applications. We would ask that the Licensing Authority reviews its process for this.

We would ask that, as we were unable to comment on the original application, that the Licensing Authority considers, when discussing this application for a New Licence, whether a large restaurant/bar operation until 01:00 is appropriate for this location.

At a minimum we would ask that you note the following:

The application seeks to join 2 existing licences which allow the premises to operate until 01:00 as a restaurant, with bar use for up to 90 people (all seated). The total capacity appears to be in excess of 430.

Given the large capacity and late hour of operation we believe it is appropriate that the premises has a dispersal policy which requires that the premises encourage customers leaving the premises after 23:00 depart via Manette Street to Charing Cross Road (as this has the greatest availability of public transport and have staff on Charing Cross road to encourage customers to disperse without causing a nuisance by way of noise.

The wording of the condition we propose should be:

The premises will have a Dispersal Policy and all relevant staff will be trained in its implementation. The Policy will be reviewed regularly and whenever the Licence Holder becomes aware of an issue associated with dispersal. At a minimum it will include the requirement that customers are encouraged to disperse to the East after 23:00 and that staff will encourage them to do so quietly and without giving rise to a nuisance.

3. Policy & Guidance

- **2.** If the application is located within a Special Consideration Zone they have demonstrated that they have taken account of the issues identified in that area and provided adequate mitigation.
- **3.** Whether there is residential accommodation in the proximity of the premises that would likely be adversely affected by premises being open or carrying out operations at the hours proposed.
- **4.** The proposed hours of the licensable activities and when customers will be permitted to remain on the premises.
- **5.** The proposed hours when any music, including incidental music, will be played.
- **6.** The hours when customers will be allowed to take food or drink outside the premises or be within open areas which form part of the premises.
- **7.** The existing hours of licensable activities and the past operation of the premises (if any) and hours of licensable premises in the vicinity.
- **8.** Whether customers and staff have adequate access to public transport when arriving at and leaving the premises, especially at night.
- **9.** The capacity of the premises.
- **10.** The type of use, recognising that some venues are more likely to impact the licensing objectives than others; for example, pubs and bars are higher risk than theatres, cinemas and other cultural and sporting venues due to the nature of the operation.
- **11**. The Licensing Authority will take into account the active measures proposed for a 'winding down' period including arrangements for people to be collected from the premises to travel home safely.
- **12**. Conditions on hours may be attached that require that the supply of alcohol for consumption on the premises ceases a suitable period of time

before customers are required to leave the premises.

- **13.** The council, acting as the Licensing Authority, may reduce hours if, after review, it is necessary to impose conditions specifying shorter hours in order to promote the licensing objectives.
- **14.** Specific days for non-standard hours should be identified and justified as part of the application to allow responsible authorities and interested parties to evaluate the impact that these licensable activities may have, and to plan accordingly. The consideration of applications for later hours for Bank Holiday Mondays will take into account that later hours are generally granted for preceding Sundays and that the next day is a working day. - **4. Off licences:** Monday to Saturday: 8am to 11pm. Sunday: 9am to 10.30pm.
- **5. Outdoor Spaces:** Monday to Thursday: 9am to 11.30pm. Friday and Saturday: 9am to 12am. Sunday: 9am to 10.30pm. Sundays immediately prior to a bank holiday: 9am to 12am.
- 6. Pubs and bars, Fast Food and Music and Dance venues: Monday to Thursday: 10am to 11.30pm. Friday and Saturday: 10am to 12am. Sunday: 9am to 10.30pm. Sundays immediately prior to a bank holiday: 12pm to 12am.
- **7. Qualifying Clubs:** Monday to Thursday: 9am to 12am. Friday and Saturday: 9am to 12am. Sunday: 9am to 10.30pm. Sundays immediately prior to a bank holiday: 9am to 12am.
- **8. Restaurants:** Monday to Thursday: 9am to 11.30pm. Friday and Saturday: 9am to 12am. Sunday: 9am to 10.30pm. Sundays immediately prior to a bank holiday: 9am to 12am.
- **9. Sexual Entertainment Venues and Sex Cinemas**: Monday to Thursday: 9am to 11.30pm. Friday and Saturday: 9am to 12am. Sunday: 9am to 10.30pm. Sundays immediately prior to a bank holiday: 9am to 12am.
- **D.** Core hours are when customers are permitted to be on the premises and therefore the maximum opening hours permitted will be to the same start and terminal hours for each of the days where licensable activity is permitted.
- **E.** For the purposes of this policy, 'premises uses' are defined within the relevant premises use policies within this statement.

Restaurant Policy RNT1(B) applies

B. Applications inside the West End Cumulative Impact Zone will generally be granted subject to:

- 1. The application meeting the requirements of policies CD1, PS1, PN1 and CH1.
- 2. The hours for licensable activities are within the council's Core Hours Policy HRS1.
- The operation of any delivery services for alcohol and/or latenight refreshment meeting the council's Ancillary Delivery of Alcohol and/or

Late-Night Refreshment Policy DEL1.

- 4. The applicant has demonstrated that they will not add to cumulative impact within the Cumulative Impact Zone.
- 5. The application and operation of the venue meeting the definition of a restaurant as per Clause C.

C. For the purposes of this policy a restaurant is defined as:

- 1. A premises in which customers are shown to their table or the customer will select a table themselves to which food is either served to them or they have collected themselves.
- 2. Which provide food in the form of substantial table meals that are prepared on the premises and are served and consumed at a table.
- 3. Which do not provide any takeaway service of food and/or drink for immediate consumption, except if provided via an ancillary delivery service to customers at their residential or workplace address.
- 4. Where alcohol shall not be sold, supplied, or consumed on the premises otherwise than to persons who are bona fide taking substantial table meals and provided always that the consumption of alcohol by such persons is ancillary to taking such meals.
- 5. The sale and consumption of alcohol prior to such meals may be in a bar area but must also be ancillary to the taking of such meal.

4. Equality Implications

The Council in its capacity as Licensing Authority has a duty to have regard to its public sector equality duty under section 149 of the Equality Act 2010. In summary, section 149 provides that a Public Authority must, in the exercise of its functions, have due regard to the need to:

- (a) eliminate discrimination harassment, victimisation and any other conduct that is prohibited by or under this Act;
- (b) advance equality of opportunity between persons who share a relevant protected characteristic and persons who do not share it; and
- (c) foster good relations between persons who share a relevant protected characteristics and persons who do not share it.



Introduction

- 1. The applications for determination relate to units 1 and 2 Ilona Rose House ("the Applications").
- 2. The applicant currently holds four premises licence in the Ilona Rose House purpose-built development granted in December 2021 ("the Existing Licences"). Unit 3 does not form part of the Applications. The licence for unit 3 will not change as a result of the Applications, nor is it included in any of the calculations set out in these submissions

Unit 1	21/07023/LIPM

Unit 3	21/07006/LIPN*
Unit 4	21/07004/LIPN

- 3. The intention is for units 1 and 2 to subsume the whole of existing unit 4; the corresponding licences will be surrendered prior to the completion of works. The Applications mirror the terms and conditions of the Existing Licences. Whilst the internal capacity figures for existing units 1 and 2 will change to reflect the proportion of unit 4 gained, there is no change to the external capacity set out in the Existing Licences as unit 4 had no external seating and indeed a marginal overall decrease. The redistribution of capacities is set out in the table at the end of these submissions.
- 4. The Applications follow original pre-application advice with the Licensing Authority, Environmental Health and District Surveyor (ref: 21/04583/PREAPM) and the Existing Licences granted for the units in December 2021.

The Application

5. The following licensable activities and hours have been applied for in line with the timings of the Existing Licences:

The Applicant

- The applicant is Soho Estates Portfolio Limited. Soho Estates is a long-standing and wellrespected local business with experience of developing and restoring properties across its portfolio.
- 7. The development site is wholly owned by Soho Estates. This affords particular safeguarding elements to the units as part of the development site, including:
 - on site CCTV;
 - private security arrangements;
 - carefully selected and curated tenant occupiers and operators;
 - additional street and façade lighting;
 - urban greening and upgrading; &
 - additional private cleansing.

The Location

- 8. The location is perfectly situated so customers and staff will have excellent access to public transport when arriving and leaving the premises especially at night and with such close proximity to the Cross Rail site and Tottenham Court Road for tube and buses. There has been a long stakeholder engagement, particularly through the planning process.
- 9. The location of the site is just along from the new Crossrail site at Tottenham Court Road, as such when work on that is complete, footfall in the area is expected to rise significantly with 100,000 alighting daily at Tottenham Court Road. Regeneration is therefore needed in the area and this extract from the planning sub-committee report states how important and welcome the development is:

"A new pedestrian route is proposed between Greek Street and Manette Street, via the new courtyard. The aim is to provide an additional pedestrian route into Soho given the increase in footfall in the area expected as a consequence of Crossrail. The route is welcomed."

10. A Dispersal Policy is attached. The following additional Model Condition (MC99) could apply if deemed necessary:

"A copy of the premises' dispersal policy shall be made readily available at the premises for inspection by a police officer and/or an authorised officer of Westminster City Council."

Representations

11. Each application has a representation from the Licensing Department as a responsible authority, EH, the CGCA, The Soho Society and a local resident.

- 12. No representation has been made by the Police. There are no changes to the hours, overall capacity, use or conditions.
- 13. The floor space sought in the Applications is identical to that currently licenced, whilst the resulting internal capacity of unit 1 and 2 is <u>less</u> than existing. The capacity is redistributed as follows, with <u>no change to the external area</u>:

1 Introduction

- 1.1 This document is submitted in respect of Premises Licences for Units 1 and 2 Ilona Rose House, Manette Street, London W1D 4AL ("the Premises").
- 1.2 The development scheme in which the Premises are located is mixed-use, with a substantial retail store fronting Charing Cross Road and a new walkway providing cafés and 3 restaurants, linking Manette Street to Greek Street within a new courtyard.
- 1.3 The location of the site is just along from the new Crossrail site at Tottenham Court Road, with excellent transport link benefits.
- 1.4 The applicant is committed to securing tenants with high standards of professional and responsible management at the Premises. This Policy is indicative of the procedures the applicant will expect from incoming tenants. The implemented management systems envisaged will ensure that the Premises are operated successfully and sympathetically to local residents.
- 1.5 The Policy will be reviewed regularly and whenever the Licensee becomes aware of issues associated with dispersal of customers.
- 1.6 The standard operating hours sought are as follows:

Non-standard timings: These hours to be extended from the end of permitted hours on New Year's Eve to the start of permitted hours of New Year's Day.

The external seating is not used after 23:00.



2 Planned Management Measures for Control of Noise

Executive Summary

- 2.1 The main entrance/exit points for customers shall be Manette Street and Greek Street.
- 2.2 After 23:00 guests can and as necessary will be encouraged to depart the Premises via Manette Street towards Charing Cross Road and the transport hubs.
- 2.3 The departure of customers will be managed in accordance with a Dispersal Policy, such as that at section 4 of this document. The management controls set out in the Dispersal Policy are designed to ensure all customers leave the area as quickly and as quietly as possible.

Noise Criteria

Noise and Vibration

- 2.4 Management controls are included in the Dispersal Policy at section 4 and the Deliveries, Collection and Servicing Procedures at section 5 of this document. The objective of these procedures is to ensure local residents are not disturbed by noise from the Premises in accordance with Policy PN1.
- 2.5 The following conditions are proposed:
- 2.5.1 "No noise generated on the premises, or by its associated plant or equipment, shall emanate from the premises nor vibration be transmitted through the structure of the premises which gives rise to a nuisance."
- 2.5.2 "Notices shall be prominently displayed at all exits requesting patrons to respect the needs of local residents and businesses and leave the area quietly."
- 2.5.3 "A direct telephone number for the manager at the premises shall be publicly available at all times the premises is open. This telephone number and/or is to be made available to residents and businesses in the vicinity."

Eating, Drinking and Smoking Outside Premises

- 2.6 The external areas are located in James Court.
- 2.7 The external areas will be carefully managed by staff.
- 2.8 Gates are provided to the boundaries of the external areas shared with the adopted highway to allow James Court to be closed off in accordance with permitted hours of operation.



- 2.9 The following conditions are from the existing premises licences:
- 2.9.1 "There shall be no sales of alcohol for consumption off the premises after 23.00."
- 2.9.2 "There shall be no sales of hot food or hot drink for consumption off the premises after 23.00."
- 2.9.3 "Notices shall be prominently displayed at any area used for smoking requesting patrons to respect the needs of local residents and use the area quietly."
- 2.9.4 "The external tables and chairs shall only be used between 08:00 and 23:00 each day and be rendered unusable at 23:00."
- 2.9.5 "Any alcohol supplied for consumption off the premises must be in a sealed container unless consumed by persons who are seated in an area appropriately authorised for the use of tables and chairs on the highway."



3 General Operational Controls

- 3.1 Management controls shall include:
- 3.1.1 Extensive employee induction and on-going refresher training, including:
 - 3.1.1.1 Responsibilities in the local area and towards local residents.
 - 3.1.1.2 Customer care and hospitality.
 - 3.1.1.3 Complaint handling.
 - 3.1.1.4 Food Safety.
 - 3.1.1.5 Health and Safety.
 - 3.1.1.6 Fire Safety.
 - 3.1.1.7 Obligations under the Licensing Act 2003.
- 3.2 Operational procedures to mitigate nuisance in the local area, including:
 - 3.2.1 External tables and chairs rendered unusable after 23:00.
 - 3.2.2 No sale of alcohol, hot food or hot drink for consumption off the Premises after 23:00.
 - 3.2.3 Controlled management of the arrival and departure of customers, including encouragement of customers to disperse quickly and quietly to their onwards direction of travel, utilising Manette Street for access to Charing Cross Road after 23:00.
 - 3.2.4 Sympathetic servicing of the Premises, with deliveries kept to a minimum wherever possible and no deliveries to the Premises between 23:00 and 07:00.
 - 3.2.5 Internal CCTV coverage including full frontal imaging of anyone entering the Premises. At any given time, there will be at least one member of staff on duty who is fully trained to operate the CCTV system.
- 3.3 24 hour sitewide security will ensure that the 23:00 external area curfew is adhered to by operators as well as providing additional security provisions in the immediate vicinity. Ilona Rose House will have:
 - 3.3.1 2 x day guard from 07:00 to 19:00;
 - 3.3.2 1 x day/evening guard from 10:00 to 22:00; &
 - 3.3.3 2 x night guards from 19:00 to 07:00



4 People Arriving, Departing & in the Vicinity

Dispersal Policy

- 4.1 The objective of the Dispersal Policy is to ensure a quiet, controlled and swift dispersal of the Premises' customers.
- 4.2 The Dispersal Policy promotes a professional and responsible management of customers as they leave the Premises to ensure they make their journey home without any adverse impact on local residents.
- 4.3 Despite the Premises' central location, employees will be made aware that local residents live close by.
- 4.4 This Dispersal Policy will be followed throughout the opening hours, although particular attention will be paid to customers leaving at night.

Entrances and Exits

- 4.5 The entrance/exits of the Premises are located off Manette Street and Greek Street. These areas will be monitored by staff inside the Premises during busy periods where deemed necessary.
- 4.6 In the event of an emergency, a full fire evacuation plan will be in place.

Dispersal

- 4.7 Given the staggering of sittings in a restaurant environment there is envisaged a natural, gradual dispersal of patrons throughout the evening. Customers are expected to depart the Premises in a gradual and controlled manner until close.
- 4.8 Notices shall be prominently displayed at all exits requesting patrons to respect the needs of local residents and businesses and leave the area quietly.
- 4.9 Where appropriate, customers will be directed to nearby transport links and requested to leave quietly.
- 4.10 Customers leaving the premises after 23:00 can be encouraged to depart via Manette Street towards Charing Cross Road.

Transport

- 4.11 Customers arrive and depart by various modes of transport, including by foot and private car.
- 4.12 The Premises are serviced by various public transport options, as set out below, including excellent proximity to Tottenham Court Road with the benefits of Crossrail/Elizabeth Line. All staff will be familiar with the transport links so they can advise customers when required.

Tube

- 4.13 The Premises are ideally located for tube services, including:
 - Tottenham Court Road / 0.1 mile / Central and Northern Line;
 - Leicester Square / 0.3 mile / Piccadilly and Northern Line;






