The Metropolitan Police Service (MPS) objects to this application as it is likely that if the application where to be granted, the premise would undermine the following licensing objective/s: **the Prevention of Crime and Disorder**.

The reasons for this objection are as follows:

- The premises is located within the West End cumulative impact are. This is not addressed at all within the application. The applicant should demonstrate that they have taken account of the issues particular to the Zone, in question as identified within the 2020 Cumulative Impact Assessment and should set out any proposed mitigation measures in relation to those issues within their operating schedule.
- The conditions offered within the operating schedule do not sufficiently demonstrate how the premise intends to promote the licensing objectives.
- The hours applied for are not within the councils' core hours for a premises of this type (Restaurant)
- Having met the owner and suggested DPS it was clear they had no knowledge of the licensing act and no knowledge that the area was a CIA.
- The venue suggests the premise is a restaurant, at the location there are 2 chairs, the model of operation is quite clearly to operate as a takeaway and should be treated as such for the purpose of any application.
- Crime levels across the West End and Soho in particular are some of the highest in the country, adding a venue with late night refreshment will clearly do nothing but add to this.

I have discussed this application with the applicant's agent and the applicant, I advised both that I would be objecting, although I am happy to discuss further conditions it is my view that this application should still be for the committee to consider and decide

- 2. The hours requested for the Supply of Alcohol will have the likely effect of causing an increase in Public Nuisance within the area and may impact on Public Safety.

The granting of the application as presented would have the likely effect of causing an increase in Public Nuisance and may impact on Public Safety within the West End CIZ.

**Dear Sirs** 

I write in relation to the application submitted for a new premises licence for Lebaneats, 13 Moor Street, London, W1D 5AP.

As a responsible authority under section 13 (4) of the Licensing Act 2003 as amended under the Police and Social Responsibility Act 2011, the Licensing Authority have considered your application in full. The Licensing Authority has concerns in relation to this application and how the premises would promote the four Licensing Objectives:

- Public Nuisance
- Prevention of Crime & Disorder
- Public Safety
- Protection of children from harm

The application seeks the following:

#### **Late Night Refreshment**

Monday to Sundays 23:00 to 02:00

Retail Sale of Alcohol (On and Off sales)

Monday to Sunday 11:00 to 23:00

Hours premises are open to the public

Monday to Sunday 09:00 to 02:00

The premises is located within the West End Cumulative Impact Area and as such various policy points must be considered, namely CIP1, HRS1 & RNT1.

Policy RNT1 (B) states

- B. Applications inside the West End Cumulative Impact Zone will generally be granted subject to:
- 1. The application meeting the requirements of policies CD1, PS1, PN1 and CH1.
- 2. The hours for licensable activities are within the council's Core Hours Policy HRS1.
- 3. The operation of any delivery services for alcohol and/or latenight refreshment meeting the council's Ancillary Delivery of Alcohol and/or Late-Night Refreshment Policy DEL1.
- 4. The applicant has demonstrated that they will not add to cumulative impact within the Cumulative Impact Zone.
- 5. The application and operation of the venue meeting the definition of a restaurant as per Clause C.
- C. For the purposes of this policy a restaurant is defined as:
- 1. A premises in which customers are shown to their table or the customer will select a table themselves to which food is either served to them or they have collected themselves.
- 2. Which provide food in the form of substantial table meals that are prepared on the premises and are served and consumed at a table.
- 3. Which do not provide any takeaway service of food and/or drink for immediate consumption, except if provided via an ancillary delivery service to customers at their residential or workplace address.
- 4. Where alcohol shall not be sold, supplied, or consumed on the premises otherwise than to persons who are bona fide taking substantial table meals and provided always that the consumption of alcohol by such persons is ancillary to taking such meals.
- 5. The sale and consumption of alcohol prior to such meals may be in a bar area but must also be ancillary to the taking of such meal.

The Licensing Authority note that the application falls outside of Westminster's core hours for a restaurant. The Licensing Authority encourages the applicant to reduce the hours to fall within Westminster's Core hours.

The Core hours for restaurants are: Monday to Thursday: 9am to 11.30pm.

Friday and Saturday: 9am to 12am.

Sunday: 9am to 10.30pm.

Sundays immediately prior to a bank holiday: 9am to 12am.

The Licensing Authority note that the applicant has proposed an amended version of Westminster's model condition 38 in their operating schedule:

'The supply of alcohol on the premises shall only be to persons seated taking a table meal there and for consumption by such persons as ancillary to their meal.'

Can the applicant confirm if they are willing to consider replacing the amended MC38 with the full model condition 38.

MC38: The supply of alcohol at the premises shall only be to a person seated taking a substantial table meal there and for consumption by such a person as ancillary to their meal.

For the purpose of this condition a 'Substantial Table Meal' means – a meal such as might be expected to be served as the main midday or main evening meal, or as a main course at either such meal and is eaten by a person seated at a table, or at a counter or other structure which serves the purposes of a table and is not used for the service of refreshments for consumption by persons not seated at a table or structure servicing the purposes of a table.

The Licensing Authority would encourage the applicant to consider Westminster's model condition 39 as below:

MC39: The supply of alcohol shall be by waiter or waitress service only.

The Licensing Authority also note that the applicant has proposed the following condition in their operating schedule:

'Any alcohol sold for consumption off the premises shall be ancillary to food order for delivery or take away.'

Can the applicant confirm if they are willing to consider replacing the above condition with an amended version of Westminster's model condition 17 as follows:

All sales of alcohol for consumption off the premises shall be in sealed containers only and shall be ancillary to a food order for delivery or take away.

The Licensing Authority require the applicant to provide submissions as to how the operation of the premises will not add to cumulative impact in the West End cumulative impact zone, in accordance with policy CIP1.

The Licensing Authority looks forward to receiving further submissions from the applicant in due course.

A late license being granted will add to noise pollution and antisocial behaviour. Late night foods will attract drunk people after attending local bars. The premises are very small- resulting in customers gathering outside the property creating late night noise and antisocial behaviour.

I would wish to object on behalf of the Soho Ward Panel to this application for late night refreshment between the hours of 11 pm and 2 am, The area is within the Cumulative Impact Zone, and already heavily saturated with late night licensed premises, leading to large numbers of people on the street after 11 pm. These are very small premises (with space for no more than two people inside) which would mean that there is the potential for large numbers of people creating a nuisance on the street. This particular part of of Soho has the highest crime in the area, so an additional premises could only lead to more antisocial behaviour and crime on the streets. I would ask that this application be refused.

#### On 4 October 2022 the interested party submitted the following additional comments:

I recently objected on behalf of the Soho Ward Panel to the granting of a late night refreshment licence at the above premises on the grounds of crime and disorder, this being an area with very high crime, particularly after 11 pm.

In case it wasn't clear, I would also oppose an alcohol licence being granted. This is a very small premises and can seat no more than 2 people, so any alcohol sold would almost certainly be drunk on the streets, thus adding to the problems in an already problematic error. Sorry if this wasn't clear in my previous representation.

We write to make a relevant representation to the above application on behalf of The Soho Society.

The Soho Society objects to this application as currently presented on the grounds of the prevention of crime and disorder, prevention of public nuisance, and cumulative impact in the West End Cumulative Impact Area.

#### **About The Soho Society**

The Soho Society is a charitable company limited by guarantee established in 1972. The Society is a recognised amenity group and was formed to make Soho a better place to live, work or visit by preserving and enhancing the area's existing diversity of character and uses, and by improving its facilities, amenities and environment.

#### The Soho Society's Concerns

The Soho Society objects to this application for a new alcohol licence on and off the premises until 11pm and late night refreshment to 2am, seven days a week. These newly opened premises consists of a long takeaway service counter and a small counter top with two seats, the focus is on fast food and a delivery

service. These premises fall under the Fast Food Policy FFP1 where there is a presumption to refuse such applications in the West End Cumulative Impact Zone.

This application if granted will increase the number of people on the streets consuming takeaway food and drinking alcohol, we are concerned as this will be another new alcohol and late night refreshment licence in Soho in an area already saturated with food and beverage uses. These types of premises attract large numbers of people late at night eating outside causing noise nuisance and attract pedicabs all causing disturbance to residents living nearby. At night the aim is for a rapid dispersal of people from the area and not giving them the opportunity to hang around any longer than necessary. The application will fail to promote the licensing objectives and increase cumulative impact in the West End Cumulative Impact Zone.

As the Committee are aware Soho has the highest concentration of licensed premises in Westminster, **475** with a large proportion (25%) being late night licences. There are over 200 restaurants, 39 bars, 46 pubs, 31 clubs (including members clubs) and entertainment premises. The area is densely populated at night and has the highest level of cumulative impact and crime and disorder in Westminster.

Moor Street and the streets that surround it, Old Compton Street, Frith Street, Greek Street and Dean Street are at the heart of the evening and night time economy, it has the highest concentration of licences in Soho a total of 110 from 12am - 3.30am with a capacity of over 10,072.

Greek Street and Old Compton Street are of particular importance due the the number of late night licences and proximity to Moor Street; Greek Street has **27** licences between 12am to 3am which includes 7 with a terminal hour of 3am, capacity where known **3,512** (21 premises). Old Compton Street has **31** premises, 12am - 3am, capacity where known **2,063** (18 premises).

If the Committee are minded to grant this application we request the following condition be adopted,

'Licence intended for use by XXX and to be surrendered when they leave the premises.'

#### Statement of Licensing Policy 2021

We review this applications against the following policies, Fast Food Premises Policy FFP1,

Restaurant RNT1 and the Cumulative Impact Policy CIP1.

#### **Fast Food Premises Policy FFP1**

It is policy to refuse such applications in the West End CIZ, F.56. states premises,

'... open after 11pm can attract large groups of customers, many of whom have been consuming alcohol in pubs, bars and nightclubs sometimes some distance away. The congregation of people around these premises leads to additional noise and disturbance ...'

The Licensing Authority and Met Police are also concerned with the levels of crime and disorder outside such premises (F.57). The applicant will need to demonstrate why they are an exception to policy.

#### **Cumulative Impact Policy CIP1**

The

growth in the number of licensed premises in Soho has led to a marked deterioration in the quality of life and wellbeing of local residents and it has jeopardised the sustainability of the community. Soho has a substantial residential community and many of these residents suffer from problems such as, but not limited to, high levels of noise nuisance, problems with waste, urinating and defecating in the streets, threats to public safety, anti-social behaviour, crime and disorder and the change in character of this historic area.

This area has been identified by the Westminster City Council as under stress because the cumulative effect of the concentration of late night and drink led premises and night cafes has led to serious problems of disorder and/or public nuisance affecting residents, visitors and other businesses. The evidence presented in the Cumulative Impact Assessment 2020 is overwhelming, it describes the high level of cumulative impact in the West End Zone between 2017-2019, the subsequent Statement of Licensing Policy 2021 Cumulative Impact Policy CIP1 states,

The West End Cumulative Impact Zone has been identified because the cumulative effect of the concentration of late night and drink led premises and/or **night cafés (our emphasis)** has led to serious problems of disorder and/or public nuisance affecting residents, visitors and other businesses. The extent of crime and disorder and public nuisance in the West End Cumulative Impact Zone arises from the number of people there late at night; a considerable number of them being intoxicated. Public services, including police, health and emergency, transport, environmental services (cleansing and refuse services) are placed under chronic strain by existing levels of activity, as are civic amenities and the quality of residential life. The urban infrastructure cannot sustain any further growth in licensed premises that provide a significant risk of a variety of harmful outcomes. Over a period of three years (2017 - 2019) 45% of violent crimes, as well as over half of all robberies, thefts and drug offences in the city were recorded within West End Cumulative Impact Zone. Additionally, 43% of ambulance callouts between that same period to the locations of licensed premises feel within this zone.' (D4)

D5 states, 'The retention of people late at night contributes to the cumulative impact.'

This evidence supported further policy restrictions in the West End, however, the impact of COVID-19 resulted in the Licensing Authority deciding not to implement greater restrictions at this stage, but it may in the lifetime of the policy if footfall moves toward pre-March 2020 levels (D1). Soho is fully open for business and thriving, there are more people on the streets in the evening now that at pre-COVID times, in our view we have already reached pre-March 2020 levels and this is further supported by recent crimes statistics which show an increase in serious crime (see the Prevention of Crime and Disorder below).

The policies in relation to the cumulative impact zone are directed at the global and cumulative effects of licences on the area as a whole (D16. of the policy). Residential accommodation is also an important factor,

D23. 'The proximity of residential accommodation is a general consideration with regard to the

prevention of public nuisance. It goes on, 'The nature of cumulative impact is that it is cumulative and affects not only the immediate vicinity of the premises, but the wider area; thus the number of people visiting the premises, the nature of licensable activities and the lateness of operations have an impact on an area as a whole, irrespective of whether or not there is residential accommodation in proximity to the premises.'

The applicant has to demonstrate these premises will not add to cumulative impact, they have failed to do so.

#### **The Licensing Objectives**

The

Statement of Licensing Policy 2021 or Section 182 Guidance does not provide for any circumstance, including exceptional or otherwise, which would permit an application to be granted if the licensing objectives were harmed. We now consider the impact of this application on these objectives.

#### **Prevention of Crime and Disorder - CD1**

Under this Policy the criteria applied is, 'whether the premises make or will make a significant contribution to levels of crime and disorder, and whether the operating schedule is based on an adequate risk assessment, undertaken by the applicant, which takes account of all the relevant considerations below to reduce the likelihood of crime and disorder occurring as a result of the grant of the application.'

The recently published Cumulative Impact Assessment 2020 presents overwhelming evidence of the year on year increase in cumulative impact in the West End Zone 1, it highlights the rate of crime as 10 - 13 times higher between 6pm - 6am compared to the borough average. It goes on to detail the number and types of crimes in the West End,

• Public realm crimes: (serious violence, robberies, theft and drug offences), alcohol-related callouts incidents, anti-social behaviour and demands on services were prevalent in Westminster between 2017 and 2019, among the highest in London and the country. All incidents observed concentrated in the West End many occurring in the evening and at night as well as weekends.

#### Total incident type 2017-2019:

- Drug Offences Night: **1529** (proportion of Borough's incidents **40%**)
- Robberies Night: 2237 (33%)
- Theft and Handling Night: 24,407 (33%)
- Serious violent crimes Night: 795 (31%)
- Ambulance call outs to locations of licensed premises: 5353 (22%)
- Noise Complaints Night: 1389 (16%)
- Anti-Social behaviour MPS: 9662 (16%)
- Anti-Social behaviour on transport Night: 592 (13%)
- Reactive Waste Management: 6630 (10%)

#### Total = 52,594

- Data description of incidents in 2017-2019 found all incident categories observed varied both in space and time. Many occurred in the evening and at night and on weekends when alcohol related activities typically peak. Incidents where primarily concentrated in the West End where licensed premises are disproportionally concentrated.
- **Robberies:** clustered within the West End, Charing Cross, Oxford Street in the evening and night.
- Serious violent crimes: recorded between 6pm and 6am concentrated overwhelmingly in the West End.
- **Drug related crimes**: Westminster recorded the highest volume of drug offences of any borough between 2017-2019. Half of crimes were reported (48%) in the evening and night

time. Drug related crimes between **6pm - 6am** were significantly clustered in and around the West End to varying degrees.

• **Theft and Handling:** the most common crime type in the borough and in the evening and night this is particularly concentrated in the West End and along Oxford Street.

These premises are situated in the heart of the food and beverage / entertainment area, the area is a known hotspot for crime and disorder, the current statistics for the \*top crime streets in Soho shows a total of 1,827 crimes; Greek Street being 1st on the list with 239 followed by Old Compton Street with 231.

Comparing the top reported crimes from \*November 2021 - February 2022 to pre- COVID times highlights the number of serious and violent crimes are on the increase;

Violence against the person serious wounding: 32 up 78% (18 pre - COVID)

Violence against the person assault with injury: 59 up 31% (45 pre-COVID)

Violence against the person common assault: 70 up 18% (59 pre-COVID)

**Drugs possession: 115 up 79%** (64 pre-COVID)

Sexual offences: 34 up 70% (20 pre-COVID)

\* Data provided by the Metropolitan Police Soho Neighbourhood Ward Panel, March 2022, to support this information in Appendix 1 we present detailed crime figures submitted by the Westminster Police Licensing Team at a licensing hearing in July 2022.

For residents living in this area the findings of the Cumulative Impact Assessment and the recent crime figures are unsurprising. Soho transforms in the evening and night time into an area which feels very unsafe and where levels of crime and disorder are high. As evidenced above, criminal activity associated with the large number of venues and the numbers of people on the streets at night results in high levels of serious crime.

In Soho the majority of robberies take place at night, Greek Street being a particular hotspot, having the highest rate where people are targeted as they leave venues. Alongside this is drug dealing, it is a real problem with groups of dealers congregating to sell drugs and specifically targeting people as they leave premises. There are more dealers in the area at night than during the day, this is directly linked to the large number of venues and people on the streets which creates the drugs market.

This area has the highest reported level of crime in Soho, people leaving these premises will be at high risk of becoming victims of crime.

#### **Prevention of Public Nuisance Policy PN1**

Under this Policy the criteria applied states, 'the potential for nuisance associated with the style, characteristics and activities of the business to be carried on at the premises and the potential steps which could be taken to reduce the risk of a nuisance occurring. This will particularly apply in areas of residential accommodation and where there is residential accommodation in the proximity of the premises.'

Long term residents live along Moor Street and Old Compton Street and already suffer from significant noise and disturbance. During the evening and night time this area completely changes in nature, it attracts large numbers of people on a night out, either eating or drinking in the numerous restaurants, bars and clubs, entertainment establishments, or those arriving from elsewhere to continue their evening, or people just walking through and others just loitering. Coupled with its narrow streets it creates the perfect environment where large numbers of intoxicated people create noise and disturbance, it is therefore unsurprising that residents constantly experience noise nuisance and disturbed sleep.

The addition of a fast food premises selling alcohol off the premises until 11pm and remains open until 2am seven days a week, will result in people eating and drinking on the street, attract pedicabs and taxis creating even more nuisance and disturbance to residents.

#### In summary

These fast food premises will fail to promote the licensing objectives and increase cumulative impact.

#### Introduction

I write to make a 'relevant representation' objecting to the grant of a premises licence for 13 Moor Street ("the premises").

There is already a lot of excess waste and litter generated from the existing licenced premises.

#### **Background**

I am concerned that the addition of yet another licensed premises (whether for sale of alcohol or provision of late night refreshment or both) will further worsen an already unacceptable situation.

Not to forget the October 2020 review of the Cumulative Impact and I quote "After consideration of the cumulative impact assessment it is the Licensing Authority's view that the number of premises licences in the West End are such that the granting of new types of licences or varying existing licences would be inconsistent with the Licencing Authority's duty to promote the licencing objectives" This was based on Pre Covid data but we are now back to full swing after covid if not a greater influx of party goers following the "al Fresco" party atmosphere generated during the covid years.

#### The application

The premises is described as 'SMALL FOOD OUTLET OFFERING FRESHLY MADE MIDDLE EASTERN CUISINE TO EAT IN OR ON THE GO. SMALL SELECTION OF ALCOHOL WILL BE SOLD WITH MEALS ONLY. ALCOHOL TO BE CONSUMED ON, OFF OR BY DELIVERY'.

The premises was most recently a tea shop and café called Yi Fang, which did not sell alcohol or provide late night refreshment.

The present application seeks sale of alcohol for consumption on and off the premises to 11pm each night; and late night refreshment (hot food and hot drinks) to 2am each night.

As a non licenced tea shop there was no impact on local amenity

The proposed operation will facilitate activities which are of a much greater impact, in an area already saturated with such activities and impacts. Anything which adds to this is contrary to the City Council's policy of refusing applications which add to this 'cumulative impact'.

It will be yet another premises selling alcohol and there will increased noise waste and crime . The corner of Soho in which we live is becoming the main hub for cheap late night after parties after leaving the Greek Street clubs and bars.

There will be increased noise from pedicabs and ubers and yet more people will be retained in the area later at night waking residents. Deliveries of food will mean more vehicles and noise. It is unclear whether late night refreshment will be for consumption on the premises only; for delivery; for takeaway for immediate consumption; or a combination of some or all of the above. In each case, a late night refreshment licence to 2am will undoubtedly have an adverse impact on the licensing objectives.

People consuming late night refreshment on the premises will be attracted to the premises after they have left the late night bars in the vicinity, and be retained in the cumulative impact zone for longer and later. People purchasing hot food and drink to takeaway will consume it outside on the streets outside our homes, and be retained in the CIZ for longer and later. People ordering food for delivery will result in delivery drivers and their vehicles hanging around underneath residential flats adding to the noise of pedicabs etc.

In addition it is currently impossible to push a buggy with a four year old and a three year old child along the pavements because of the hoards of people who are coming to and from, smoking outside, or waiting in queues for licenced premises. The buggy with the small children has to be pushed into the road and in the way of oncoming traffic - the licensing objective "the protection of children from harm" CANNOT BE MET. There are FOUR HUNDRED AND SEVENTY licenced premises in Soho. The area is saturated and this licence should be refused. The licencing authority CANNOT adequately PROTECT CHILDREN FROM HARM as buggies have to be pushed into oncoming traffic. Should an accident occur this would be as a direct result of more and more licences being granted.

These premises are applying for LNR 23:00-02:00 and the sale of alcohol until 23:00. The premises plan shows a very small unit with space for only 2 people to eat within the premises. The premises propose to offer a delivery service and to sell alcohol to accompany a takeaway meal and deliveries.

The premises are not situated with the CGCA's area but just across the boundary in Soho. We believe that the application, if granted, will fail to support the Licensing Objectives, especially related to Public Nuisance and Crime and Disorder. This will both be from the operation of the premises and from their impact on the Cumulative Impact Zone (CIZ).

The premises are located on Moor Street which is the main route between New Compton Street and Cambridge Circus. This area has a very high footfall, especially in the late evening, and a very high level of crime and ASB. We have attached a heat map for the 12 months to July 22

which show that there were over 16.000 recorded incidents within ¼ mile of this location. This is 23% of the incidents for the whole of Westminster over the same period. For comparison if this area was a single Ward it would have the 3rd highest rate of crime in London, higher than any WCC Ward other than West End (23,004) and St. James (17, 074). The ¼ mile radius includes part of both of these wards. This is a higher amount of crime than in the entire London Borough of Merton1 It is data of this type which supports the designation of this part of the West End as a Cumulative Impact Zone.

The premises are primarily a fast food premises and are subject to Policy FFP1. The reasons for FFP1 are stated in the Policy. The CGCA agrees with these. Premises selling hot food and drink after 23:00, and especially after the end of Core Hours, attract people who have been drinking and are therefore flashpoints for crime and disorder and generate public nuisance in the immediate vicinity. The public nuisance extends across a wider area as people sit on doorsteps to consume their food, causing noise for residents and also discard litter. This is already apparent in this area and the addition of another premises will add to the existing issues, which is the text book definition of Cumulative Impact. To take the licensable activities in turn.

#### LNR

The provision of LNR will retain people within the CIZ who would otherwise have left. Given the size of the premises they will be eating on the street in the vicinity which will also add to noise and disturbance. Any grant would be contrary to policy FFP1.

#### Sale of Alcohol

The sale of alcohol is during limited hours, during which LNR is not required. We do not object to the sale of alcohol for consumption on the premises by (both) seated customers (condition 13) However the sale of alcohol to accompany takeaway food will serve to increase the number of people drinking in the street within the vicinity of the premises and this will harm the licensing objectives.

We do not have an objection to the sale of alcohol in sealed containers to accompany a meal which is delivered to a customer under the proposed conditions as this ceases at 23:00. However we do object to the sale of alcohol to accompany a takeaway meal for the reasons outlined above and therefore ask that Condition 24 is amended to remove "and takeaway") so that the sale of alcohol can only be made by delivery to a residential or business address.

We hope that this representation is clear and ask that you advise us well in advance of any meeting at which this application will be discussed.

As one of the local ward councillors I object to this application for a new alcohol licence. The alcohol licence would permit the sale of alcohol for use on and off the premises until 11pm as well as late night refreshment to 2am. The applicant seeks permission for seven days a week. The premises sit within the Cumulative Impact Zone where there is a presumption against the grant of new alcohol licenses. It is for the applicant to rebut that presumption.

Soho has reached a point of saturation - which is exactly why the Cumulative Impact Assessment was commissioned. Fast Food Premises Policy FFP1 recognises the problems associated with outlets such as this: '... open after 11pm can attract large groups of customers, many of whom have been consuming alcohol in pubs, bars and nightclubs sometimes some

distance away. The congregation of people around these premises leads to additional noise and disturbance ...'. Although there cannot be a complete bar to such premises licenses, it is for the applicant to recognise these negative externalities and identify how it will address them.

The conditions that the applicant attaches to the application are insufficient to deal with the expected problems arising from the grant of such a licence. For example, one would expect SIA-registered personnel for most applications outside the CIZ. The applicant has not identified how it intends to address the specific cumulative impact arising from this anticipated licence. It does not give proper weight to the additional burden placed on applications made in the CIZ.

Any new venue serving will not reduce crime it will without doubt increase it.

Across Soho 1135 crimes were reported here in July 2022

Over half of them on nearby streets within 500 yards of Moor Street in July 2022.

Shockingly 24 of these in July 2022 ie almost one a day were violent or sexual and took place nearby.

As a councillor for West End its clear that drunk people are a nuisance and the amount of fouling on the street in alleys, is utterly disgusting. Some streets where residents live smell of urine 7 days a week.

Alcohol is well known to play a large role in criminal activities and violence. Excessive drinking

has the ability to lower inhibitions, impair a person's judgement and increase the risk of aggressive behaviours. Because of this, alcohol-related violence and crime rates are on the rise throughout the country.

40% of inmates who are incarcerated for violent offenses were under the influence of alcohol during the time of their crime.

Alcohol abuse is at epidemic proportions.

Soho has thousands of residents, a primary school not far from Moor Street (on Archer Street) and the children are already exposed to asb on nearby streets. This applicant wants to serve alcohol during the school day ie from 11am!

Residents endure these problems day and night. Many have sleep disrupted by drunk people shouting and screaming.

Pedicabs ply the area playing loud music to attached revellers to their extortionate services.

Deliveroo and Uber eats drivers are regularly breaking traffic conventions in Soho, and groups of drivers gather talking loudly into the night. A venue serving alcohol will simply be another magnet for riders to hang about waiting for orders/

I believe the presumption in this Cumulative Impact Zone is against new licenses. I suggest that this committee use this assumption to reject this applicatio as it can bring no good to for people who live work or visit Soho.

The West End is one of the top wards for alcoholic related crime. The community needs protecting from the ever increasing number of places to buy alcohol.

Thank you for your patience and for taking the time to read my letter and I hope this application will be denied.

#### 3. Policy & Guidance

The following policies within the City Of Westminster Statement of Licensing Policy apply:

#### Policy HRS1 applies

- A. Applications within the core hours set out below in this policy will generally be granted for the relevant premises uses, subject to not being contrary to other policies in the Statement of Licensing Policy.

  B. Applications for hours outside the core hours set out in Clause C will be considered on their merits, subject to other relevant policies, and with particular regard to the following:
- 1. The demonstration of compliance in the requirements of policies CD1, PS1, PN1 and CH1 associated with the likelihood of the effect of the grant of a licence for later or earlier hours on crime and disorder, public safety, public nuisance and the protection of children from harm.
- 2. If the application is located within a Special Consideration Zone they have demonstrated that they have taken account of the issues identified in that area and provided adequate mitigation.
- 3. Whether there is residential accommodation in the proximity of the premises that would likely be adversely affected by premises being open or carrying out operations at the hours proposed.
- 4. The proposed hours of the licensable activities and when customers will be permitted to remain on the premises.

- 5. The proposed hours when any music, including incidental music, will be played.
- 6. The hours when customers will be allowed to take food or drink outside the premises or be within open areas which form part of the premises.
- 7. The existing hours of licensable activities and the past operation of the premises (if any) and hours of licensable premises in the vicinity.
- 8. Whether customers and staff have adequate access to public transport when arriving at and leaving the premises, especially at night.
- 9. The capacity of the premises.
- 10. The type of use, recognising that some venues are more likely to impact the licensing objectives than others; for example, pubs and bars are higher risk than theatres, cinemas and other cultural and sporting venues due to the nature of the operation.
- 11. The Licensing Authority will take into account the active measures proposed for a 'winding down' period including arrangements for people to be collected from the premises to travel home safely.
- 12. Conditions on hours may be attached that require that the supply of alcohol for consumption on the premises ceases a suitable period of time before customers are required to leave the premises.
- 13. The council, acting as the Licensing Authority, may reduce hours if, after review, it is necessary to impose conditions specifying shorter hours in order to promote the licensing objectives.
- 14. Specific days for non-standard hours should be identified and justified as part of the application to allow responsible authorities and interested parties to evaluate the impact that these licensable activities may have, and to plan accordingly. The consideration of applications for later hours for Bank Holiday Mondays will take into account that later hours are generally granted for preceding Sundays and that the next day is a working day. Non-specific days are expected to be covered by Temporary Event Notices or variation applications.

#### Policy FFP1 (B) applies

- B. It is the Licensing Authority's policy to refuse applications within the West End Cumulative Impact Zone other than:
- 1. Applications to vary the existing licence hours within the council's Core Hours Policy HRS1, and/or,
- 2. Applications that seek to vary the existing licence so as to reduce the overall capacity of the premises.
- C. The applications referred to in Clause B1 and B2 will generally be granted subject to:
- 1. The application meeting the requirements of policies CD1, PS1, PN1 and CH1.
- 2. The operation of any delivery services for alcohol and/or latenight refreshment meeting the council's Ancillary Delivery of Alcohol and/or Late-Night Refreshment Policy DEL1.
- 3. The application and operation of the venue continuing to meet the definition of a Fast Food Premises in Clause D.
- D. For the purposes of this policy a Fast Food Premises is defined as:
- 1. A premises that provides late night refreshment, either by way of fast food over a counter, via a self-seating basis or take away for immediate consumption.
- 2. Food and drink are:
- a. Available on the premises for self-selection.

b. Prepared on the premises.
c. Cooked or produced off the premises but brought to that premises
in advance of its sale to customers.
<ul><li>3. The food and drink are provided in pre-sealed or open disposable packaging which is intended for immediate consumption.</li><li>4. A fast-food premises can provide a delivery service as part of its operation, however that service must be ancillary to the main</li></ul>
function of the premises as defined within sub-clauses D,1 to D,3 above.

#### 4. Equality Implications

The Council in its capacity as Licensing Authority has a duty to have regard to its public sector equality duty under section 149 of the Equality Act 2010. In summary, section 149 provides that a Public Authority must, in the exercise of its functions, have due regard to the need to:

- (a) eliminate discrimination harassment, victimisation and any other conduct that is prohibited by or under this Act;
- (b) advance equality of opportunity between persons who share a relevant protected characteristic and persons who do not share it; and
- (c) foster good relations between persons who share a relevant protected characteristics and persons who do not share it.

Section 149 (7) of the Equality Act 2010 defines the relevant protected characteristics as age, disability, gender reassignment, marriage and civil partnership, pregnancy and maternity, race, religion or belief, sex, and sexual orientation.







The number of crimes committed within the West End have increased sharply following the removal of Coronavirus regulations. Levels of crime are now back to pre-Covid levels, and in some cases (Assaults, Sexual Assaults and Robbery) are higher than pre-Covid levels.


Below are the West End crime figures for the month of September 2022, compared to August 2022 and September last year. This also shows a crime total for the year and compares this to last year.




















The above figures demonstrates that crime in the West End is rising. This impacts directly on Police resources, as well as other emergency services. The granting of this application will only add to this. Officers in the West End are struggling to cope with the volume of crime and anti-social behaviour that there is currently, adding a further premises with alcohol (including delivery of alcohol) and late night refreshment would simply create more pressure.









The applicant's venue is situated in Soho which is in the West End ward, the venue is located on Moor St which is located at the bottom right hand side of Soho as you look at the maps. The maps clearly show a large heat-spot in the immediate area the applicant's venue is located. The heat-spot is a spot created when crimes or calls involving anti-social behaviour are mapped out. The important one in this point to look at is the map with total notifiable offences, this map includes all crime.

The Police do not believe that the applicant has provided exceptional reasons as to why the application should be granted. The Police request that the application is refused on this basis.

I am PC Matt CARR, dedicated ward officer (DWO) for Soho Ward. The Soho area 'footprint' extends west to east from Regent Street to Charing Cross Road, and north to south from Oxford Street to Shaftesbury Avenue. This statement is regarding the proposed changes to licencing conditions, namely extending food services until 0200hrs, and having an alcoholicense until 2300hrs, to the restaurant at 13 MOOR STREET, W1. I object to the proposed changes to their licenced hours based on the following grounds.	51
Moor Street is a thoroughfare for people entering and leaving Soho. Moor street leads onto Charing Cross Road approximately 300 metres from the entrance to Leicester Square tube station making it a popular route to and from the station. Within the Soho footprint, Moor Street connects to some main roads that are hotspot areas for Violence and Robber offences. From January until August 2022; 1567 theft offences, 552 Violence against the Person offences, 281 robbery offences, and 85 sex offences were recorded. All of these offences occurred in the Soho footprint, with the vast majority of them occurring in the Eastern most streets of Soho, which Moor Street leads to and from. Most of the offences listed occur between 2100hrs and 0500hrs. The victims of these offences primarily have been out in Soho enjoying the Night Time Economy.	у
A total of 500 crimes were recorded between January and August 2022 on or in the immediate area of MOOR STREET. The top six offences were Theft other, Theft from person, Violent and Sexual, Robbery, Drugs, and Public Order respectively Due to this, having another venue in the area providing alcohol and food until the early hours of the morning would likely contribute to increasing the levels of violent offences in Soho. The venue would encourage people enjoying a night out to stay in Soho after other venues have closed, instead of carrying on home via Leicester Square tube station. There is a high likelihood that these people would be intoxicated and therefore vulnerable. This in turn could lead to more potential victims of night time robberies, assaults, and sexual assaults. If serving food and alcohol later than they currently are, the venue at 1 MOOR STREET could also become an attractive spot for robbery nominals and thieves to congregate and observe vulnerable members of public and subsequently target them. Soho also deals with lots of alcohol related disorder, making th jobs of officer's specifically on the night duty, very difficult and draws them away from being able to deal with more seriou offences that occur. Having another venue serving alcohol until late would only add to the disorder already experienced on a nightly basis.	3 ne

When determining an application for a new premises licence under the provisions of the Licensing Act 2003, the licensing authority must, unless it decides to reject the application, grant the licence subject to the conditions which are indicated as mandatory in this schedule.

At a hearing the licensing authority may, in addition, and having regard to any representations received, grant the licence subject to such conditions which are consistent with the operating schedule submitted by the applicant as part of their application, or alter or omit these conditions, or add any new condition to such extent as the licensing authority considers necessary for the promotion of the licensing objectives.

This schedule lists those conditions which are consistent with the operating schedule, or proposed as necessary for the promotion of the licensing objectives by a responsible authority or an interested party as indicated. These conditions have not been submitted by the licensing service but reflect the positions of the applicant, responsible authority or interested party and have not necessarily been agreed

#### **Mandatory Conditions**

- 1. No supply of alcohol may be made at a time when there is no designated premises supervisor in respect of this licence.
- 2. No supply of alcohol may be made at a time when the designated premises supervisor does not hold a personal licence or the personal licence is suspended.
- 3. Every supply of alcohol under this licence must be made or authorised by a person who holds a personal licence.
- 4. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
  - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
  - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to;
    - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
    - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
  - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
  - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or

less in a manner which carries a significant risk of undermining a licensing objective;

- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 5. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 6. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
  - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
  - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
    - (a) a holographic mark, or
    - (b) an ultraviolet feature.
- 7. The responsible person must ensure that—
  - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
    - (i) beer or cider: ½ pint;
    - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
    - (iii) still wine in a glass: 125 ml;
  - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
  - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

A responsible person in relation to a licensed premises means the holder of the premise licence in respect of the premises, the designated premises supervisor (if any) or any individual aged 18 or over who is authorised by either the licence holder or designated premises supervisor. For premises with a club premises certificate, any member or officer of the club present on the premises in a capacity that which enables him to prevent the supply of alcohol.

- 8(i) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 8(ii) For the purposes of the condition set out in paragraph 8(i) above -
  - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
  - (b) "permitted price" is the price found by applying the formula -

P = D+(DxV)

Where -

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol:
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
  - (i) the holder of the premises licence,
  - (ii) the designated premises supervisor (if any) in respect of such a licence, or
  - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 8(iii). Where the permitted price given by Paragraph 8(ii)(b) above would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 8(iv). (1) Sub-paragraph 8(iv)(2) below applies where the permitted price given by Paragraph 8(ii)(b) above on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
  - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.
- 9. All persons guarding premises against unauthorised access or occupation or against outbreaks of disorder or against damage (door supervisors) must be licensed by the Security Industry Authority.

#### Conditions consistent with the operating schedule

- 10. The premises shall install and maintain a comprehensive CCTV system. All entry and exit points must be covered enabling frontal identification of every person entering in a light condition. The system shall also provide full coverage of any exterior part of the premises accessible to the public. The CCTV system shall continually record whilst the premises are open. All recordings shall be stored for a minimum period of 28 days with date and time stamping. Viewing of recordings shall be made available immediately upon the request of Police or authorised officer of The Council.
- 11. A staff member from the premises who is conversant with the operation of the CCTV system shall be in the premises at all times when the premises is open. This staff member must be able to provide a Police or authorised council officer copies of recent CCTV images or data with the absolute minimum of delay when requested and within a maximum of 24 hours of the initial request.
- 12. Subject to Data Protection guidance and legislation, the management of the premises will ensure that key staff are fully trained in the operation of the CCTV and will be able to download selected footage onto a disk/USB Stick for the Police or authorised officers of the Local Authority without difficulty, delay or charge.
- 13. Any CCTV breakdown or system failure will be notified to the Police and Local Authority immediately & remedied as soon as practicable. Repair records shall be kept on site for at least 12 months and be readily available to be viewed by all authorised persons upon request.
- 14. Notices shall be prominently displayed within the premises stating that CCTV is in operation.
- 15. A Challenge 25 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram.
- 16. Signage advertising the aforementioned proof of age scheme shall be prominently displayed throughout the premises with a particular emphasis on the devices used by staff to serve customers.
- 17. All staff members engaged, or to be engaged, in selling alcohol on the premises shall receive full training pertinent to the Licensing Act, specifically in regard to age-restricted sales, and the refusal of sales to persons believed to be under the influence of alcohol or drugs. This shall take place every 6 months.
- 18. All such training is to be fully documented and signed by not only the employee but the person delivering the training. Training records shall be kept at the premises and made available upon request to either Police Officers or an authorised officer of The Council.
- 19. An incident log shall be kept at the premises and made available on request to an authorised officer of the The Council or the Police. It must be completed within 24 hours of the incident and will record the following:
  - a) all crimes reported to the venue
  - b) any complaints received concerning crime and disorder
  - c) any incidents of disorder
  - d) any faults in the CCTV system, searching equipment or scanning equipment
  - e) any refusal of the sale of alcohol including date, time and name of staff member
  - f) any visit by a relevant authority or emergency service.

- 20. A record shall be kept detailing all refused sales of alcohol. The record should include the date and time of the refused sale and the name of the member of staff who refused the sale. The record shall be available for inspection at the premises by the police or an authorised officer of The Council at all times whilst the premises is open.
- 21. There shall be a personal licence holder on duty on the premises at all times when the premises are authorised to sell alcohol
- 22. The supply of alcohol on the premises shall only be to persons seated taking a table meal there and for consumption by such persons as ancillary to their meal
- 23. Notices shall be prominently displayed at all exits requesting patrons to respect the needs of local residents and businesses and leave the area quietly.
- 24. Any person or automated system taking an order for the supply of alcohol on behalf of the premises licence holder will inform customers that proof of age by way of photographic driving licence, passport or a form of identification with the PASS hologram may be required before alcohol is supplied in accordance with the Challenge 25 age verification scheme.
- 25. No high strength beers, lagers, and ciders above 5.5% ABV shall be stocked or sold at the premises.
- 26. An electronic till prompt should be used for all alcohol sales.
- 27. A clear and unobstructed view into the premises shall be maintained at all times.
- 28. Invoices are to be produced to Police, a member of an appropriate authority or council officers upon request to evidence payment of duty on goods.
- 29. The premises licence holder shall ensure that any third party deliver/courier company is instructed to comply with the following: a. Any refusals will be logged by the delivery driver. Records of all refusals will be obtained from the delivery company and provided to the relevant authorities upon request; and b. Couriers will be trained on relevant aspects of the Licensing Act 2003 including underage sales, sales to a person who is drunk, obtaining alcohol for a child or a person who is drunk and delivering alcohol to someone under the age of 18.
- 30. The minimum age of delivery drivers shall be 18.
- 31. All delivery orders shall be to a registered residential or business address. There shall be no deliveries to public/communal areas or open spaces.
- 32. For all orders taken over the phone or via the internet, customers should be informed of Challenge 25 and the requirement to have ID ready for inspection should the need arise before receipt of alcoholic beverages.
- 33. Any alcohol sold for consumption off the premises shall be ancillary to food order for delivery or take away.
- 34. All deliveries to the site shall take place during the normal working day, i.e., 09:00 to 18:00 daily.
- 35. A suitable intruder alarm and panic button shall be fitted and maintained.
- 36. There shall be a personal licence holder on duty on the premises at all times when the premises are authorised to sell alcohol.

- 37. There shall be no vertical drinking.
- 38. A minimum of two members of staff shall be present throughout the permitted hours for the sale of alcohol.
- 39. There shall be no promotions that encourage illegal, irresponsible or immoderate consumption of alcohol.
- 40. Outside of the hours authorised for the sale of alcohol, all alcohol within the trading area is to be secured behind locked grills, locked screens or locked cabinet doors so as to prevent access to the alcohol by customers or staff.
- 41. SIA registered door staff shall be employed at the premises, in accordance with a risk assessment, to be carried out by the licence holder/DPS. When employed, door staff will wear high visibility armbands and assist with the dispersal of patrons from the premises.
- 42. All SIA staff must sign a register detailing the information stated below. This register must be kept on the premises and made available immediately upon the request of Police or authorised officer of The Council. (a)start and end of shift times (b)SIA badge registered number (c)Full name
