With reference to the above, I am writing to inform you that the Metropolitan Police Service as a Responsible Authority are **objecting** to this application on the basis that if granted, it would undermine the Licensing Objectives, namely The Prevention of Crime and Disorder.

Your client is seeking Late Night Refreshment (indoors & outdoors):

Sunday to Monday: 2300 – 0300 hours.

These hours are beyond Westminster Core Hours policy which are Monday to Thursday 23:00 – 23:30 hours; and Friday – Saturday: 23:00- 00:00 hours

At this stage, there is insufficient detail contained within the operating schedule to promote the

Licensing Objectives and I have concerns that if granted, this application will cause further policing problems in an already demanding area.

I also have concerns with recent events that have allegedly taken place at this venue.

Firstly, there have been complaints from local residents stating that this venue has been trading beyond permitted hours. This is a breach of the current licence which only came into force on the 22/07/2022 (22/01952/LIPN).

Secondly, I have recently been contacted by a Police colleague who stated that the venue failed to supply CCTV for a criminal offence for which he was investigating. Westminster City Inspectors have been made aware of this incident and have written to the venue and continue to monitor the premises. I will supply further information regarding this matter at a later date, but it is again appears to be a breach of the current licence conditions.

With all this in mind, I have legitimate concerns that the applicant will fail to uphold the Licensing Objectives and it is for these reasons that the Metropolitan Police Service are making a representation to this application.

I refer to the application for a variation for the Premises Licence number for the abovementioned premises. I have considered the information that you have provided within and accompanying this application. I have also considered the application in line with the relevant policies within the Councils Statement of Licensing Policy dated October 2021.

Applicant is seeking to extend the hours for the provision of late-night refreshment from core hours (Monday to Thursday 23:00 – 23:30 hours; and Friday – Saturday: 23:00- 00:00 hours) to 03:00 hours Monday to Sunday indoors and outdoors.

Following consideration of the application and how it may affect the Licensing Objectives and meeting the requirements of the Council's Statement of Licensing Policy I wish to make the following representation:

1. The hours requested to provide late-night refreshment may have the likely effect of causing an increase in Public Nuisance and may affect Public Safety within the area

The licence to which this variation seeks to amend came into force on 22/07/2022. On 14/09/2022, a complaint on behalf of 224 apartments in close proximity to the application premises regarding a major breach of the licence (treading beyond permitted hours), was received. That complaint triggered an investigation from the council's City inspection team. The investigation culminated into the issuance of a notice letter and the premises being placed on a regular monitoring.

Under the above circumstance, it is my considered position that as presented, the application would have the likely effect of causing an increase in Public Nuisance and may affect Public Safety within the area.

Dear Westminster Council Colleagues,

I strongly object the application for a late night license by Shawarma N More Limited. The proposed late night food service will result in customers consuming food on the pavement outside the establishment as there is no sizeable indoor seating area at the premises. This would in turn create noise and congestion in the immediate vicinity of the establishment and could spill over into the adjacent streets including Brickenhall Street and York street.

Increased night time traffic would result in cars and bikes blocking Baker Street, Brickenhall Street, York Street, Porter Street and may spill over further into the area. There Marylebone area has a unique mixture of history, culture and residential spaces.

There was and is no night time entertainment provided in the area. I do not see the need for a late night opening of the fast food establishment that could have a negative impact on the unique character of the local community.

I am writing to object to the application by Shawarma for a license variation.

I have lived on since 1997. In recent years, my family has witnessed the detriment to the character of the neighbourhood from late licenses in the area (Crawford St between Gloucester Place and Baker St). Cars park on Crawford St, often playing loud music and reducing flow of traffic, while the owners socialise loudly on the pavements outside the cafes. This is not conducive to a largely residential area. While Baker St itself has less residential property, nevertheless permitting a change in license will continue the extension of late night cafes across Marylebone and the accompanying antisocial behaviour late at night spills over for residents in the densely populated neighbouring blocks (in this case Bickenhall, Portman and Montagu Mansions). I am also concerned that these cafes will continue to proliferate.

In addition, the junction of York St with Baker St has already become a site of antisocial behaviour from food delivery cyclists, and another late license in the vicinity will only add to the high level of loitering that we observe (and suffer) around this block.

I hope the Council will not look at this proposed license change in isolation, and will instead consider the site in the context of the surrounding area which would be negatively impacted by this change.

I am concerned that the variation will cause a nuisance for local residents until the early hours, every day of the week. The provision of late night refreshment will be both indoors and outdoors, causing noise, litter, crime and traffic in the area.

I am particularly concerned about 'the prevention of public nuisance':

- a)The applicant proposes that the variation would be in effect every day, 365 days a year. This will mean the effect of the nuisance would be continuous. Local residents will certainly be adversely affected by this as there will not be a single day when the restaurant will not be open until 3am.
- b)There is an existing issue in the area of large numbers of food delivery riders congregating in the local area (on York Street and on Baker Street) particularly on weekends. They have displayed anti-social behaviour and can be an intimidating presence for some local residents. Extended opening times will mean the food delivery drivers will be a constant presence as customers may order food on apps such as 'Deliveroo' (Shawarma N More currently trades on Deliveroo).
- c)Any business that is proposing to be open until 3am is not appropriate for a residential area and there is a risk of disorderly behaviour, which will of course be a nuisance for local residents. Whilst Baker Street is not solely a residential area, the right balance must be struck between the needs of local business and local residents.
- d) The applicant does not propose measures to mitigate the nuisance. It is unclear whether it simply fails to acknowledge the resulting nuisance e.g. noise of customers, increased litter or congregating delivery drivers, or whether it recognises that no effective mitigation is possible. The applicant simply refers to 'staff trained to deal with situations', which does not recognise the very real impact this would have on residential life.

A late night application has already been refused. All of the reasons for that refusal remain valid and this application should be refused too. The Met Police were against it on the basis of Crime and Disorder. Since the previous application this area has deteriorated more with further problems that could potentially escalate through until 3am if this were were approved. As nearby residents we suffer a lot from the fast food shops. This particular place wants to sit people outside until 3am - what about the noise for residents? We often see queues out of the door which are rowdy and intimidating for others to pass through.

People often purchase takeaways and eat them in quiet adjacent residential streets like ours, sitting on the steps of peoples homes and leaving their litter behind them. This is particularly upsetting for those in flats on lower ground, ground and first.

As this business is already open until after the pubs it also tends to attract people who have been drinking and they are therefore often in large noisy groups. Just yesterday there were large pools of vomit at the end of the street and a further one this morning. We do not want this business to become a destination venue for those who have been out drinking until 3am. This business also appears on some delivery apps so are we now also to have delivery drivers zooming up and down adjacent quiet residential streets?

We understand that this business has already been breaking the terms of their existing licence regularly without any consideration for neighbours (businesses and residents). Should they be rewarded with a further extension to cause even more public nuisance? We strongly object.

This business along with other fast food businesses are now having severe impacts on the residents.

There is increased litter and noise which find its way into our street and we often hearing drunken shouting late at night when this business is open as it attracts people who have been drinking.

We also find that people purchase take aways and eat them outside the shop in groups which is intimidating to walk through. As many of these people have been drinking, they are inconsiderate to neighbours. We do not want this to carry on until 3am or even worse, for this place to establish a reputation as somewhere for people to go after drinking all night. The impacts in the day and evening are bad enough but until 3am would be intolerable.

The mix of commercial and residential is not working here at the moment as there are too many fast food shops. We also have problems with delivery drivers congregating until after dark, we do not want this to continue until 3am. If this business has been breaking the terms of their existing licence they do not seem to be suitably responsible to manage a venue until 3am. The Metropolitan Police and Council are already struggling to cope with the problems in this section of Baker Street, granting a licence until 3am would exacerbate these. Portman Mansions Management Ltd has 120 leaseholders. Portman Mansions is situated on Chiltern Street (parallel with Baker Street) & Porter Street.

In our view this application impacts the stated objectives of preventing public nuisance & crime & disorder.

- A late licence will result in the premises becoming a 'destination' venue, increasing footfall in the wider area & providing encouragement for additional late licence requests
- Closing late will have a significant impact in a wider area due to reduced public transport. Displacing nuisance over a wider area as customers leave the premises and area
- The application does not demonstrate why the licensing authority should depart from its 'core hours' policy. 'Core hours are an essential element to ensure businesses can operate for a reasonable period whilst protecting the impact on the licensing objectives.'
- Portman Mansions is massively impacted by unacceptable noise levels due to out of hours deliveries on Chiltern Street & patrons leaving the Holmes Hotel both having increased considerably due to the road layout changes on Baker Street (Holmes Hotel entrance is now on Chiltern Street). This will only exacerbate the issue.
- Increased footfall will increase street littering. Chiltern / Porter Street already experience constant littering due to take out food outlets which encourage vermin
- Anti-social behaviour with an increased propensity of drug dealing and unsavoury night-time activity is a distinct possibility
- UBER drivers will congregate later for anticipated deliveries.

THIS REPRESENTATION is made by the Marylebone Association, which is recognised by Westminster as the Amenity Society for the Marylebone Area south of Marylebone Road and so

represents the interests of those who live and work in this area.

We are writing to object to application by Shawarma N More, 22/09054/LIPV, 123 Baker Street London W1U 76RZ. We believe that if granted this would lead to the creation of serious public nuisance contrary to Policy PN1 as the applicant is requesting hours well outside Core Hours, Policy HRS1. We also believe that there is a risk to Policy CD1.

The current licence 22/01952/LIPN was granted only on 7<sup>th</sup> July this year on an application originally asking for hours to 5:00am. It is rather irritating that the operator sees fit to re-apply so soon after the grant of their original licence.

This stretch of Baker Street from Marylebone Road to Paddington Street is a rather unpleasant neighbourhood due to its proximity to the major transport hub Baker Street Station. It is populated by numerous fast-food outlets and attracts large numbers of pedestrians looking for food and an increasing number of delivery personnel on bikes who congregate in and around the area creating a severe nuisance. There is a high incidence of drug dealing also.

There are a number of large residential blocks in the adjacent streets – Bickenhall Mansions, Portman Mansions and Montagu Mansions where hundreds of people reside. They are blighted by the litter and noise and are inconvenienced frequently by people eating their take-away food on their steps or environs.

It could be argued that the residents will have known about this problem before buying their flats and this must be true but it is a fact that all the existing food outlets close at or before midnight even on Fridays and Saturdays. Of the 14 fast food outlets in this stretch 6 close at midnight and the rest at 11:30 or earlier. Consequently the residents do currently get some respite.

We have received numerous complaints about the operator who remains open well after its existing permitted hours. The flagrant breaching of their licencing conditions so soon after the grant would suggest that the operator does not care about their neighbour's wellbeing and we worry that any extension of hours will be extremely detrimental to the local residents.

In conclusion we do not believe it is appropriate to grant a licence beyond Core Hours to the early hours of the morning in this location as it would inevitably lead to breaches of PN1 and will do nothing to prevent incidents of crime thereby breaching CD1 as well.

The end of this street is already extremely congested with noise and waste from these types of establishments. Baker Street is plagued by delivery drivers who often congregate until as late as 11.30pm in this area which is already a public nuisance. This impacts both air and noise pollution, putting strain on local services; such as the police & waste services.

Approving the licence will no doubt exacerbate the public nuisance; it will open up the opportunity for late night antisocial behaviour, pollution from littering, noise from customers eating outside/queuing, drunk and disorderly behaviour will no doubt be in play.

Delivery drivers on motorbikes passing throughout the night will cause unwanted disturbances for my children who go to bed early for school as well as dangerous driving on the street. We deserve the right to peaceful living.

We currently accept a level of noise from these establishments; however, the above licence will afford them to magnify this and would severely disrupt peaceful living for all residents.

I see no reason the licence should be extended other than for the businesses personal gain. The density of fast-food shops in this area is already problematic in the daytime and must not be allowed to continue through the night. The council are already struggling to maintain waste in the area and the proposition to extend the opening hours will put a strain on these services.

In light of the above concerns, we urge the Council to recommend that this application is refused.

We are truly blighted by some of the fast food outlets. Not only by the sheer number of them but nowadays by the plethora of delivery drivers hanging around day and night .

Schwarma has posted his application, but not in a prominent position, on his window up high so basically unreadable and a lamppost on the opposite side of the street.

He wants to remain open until 3 am 7 days a week, with eating inside and out! Outside until 3 am! The people who live above his very smelly shop must be dreading this!

Delivery drivers are everywhere, morning non and night? I understand they serve the community but, they smoke and drop their trash everywhere. And where do they urinate? No facilities near by.

On top of their application, another restaurant further down Baker Street want music inside and out until 4 am! And yet another fast food place Döner Shack is due to open at 102 Baker Street, no doubt wanting to open ever later and with 8 outside seats..

The original application was rejected on the grounds of possible antisocial behaviour along with the unsanitary disposal of trash. We live in a residential block of 223 flats, many of which are

occupied by families who feel threatened by this group of men always hanging around. We have seen that Schwarma already does not follow the rules set out on his licence, so why he feels the right to reapply, beats me. I also have photographic evidence of delivery drivers en masse, and trash that is left behind. And Dangerous on Bickenhall street, one resident was left with a broken arm after being struck by a cyclist going the wrong way down Bickenhall Street. This can only get worse!

We act as the managing agents for York Mansions (Baker Street) Limited, the residential building immediately above this commercial premises and we have already reported this establishment to Environmental Health for the obnoxious smells coming into the residential building from cooking on the premises.

The granting of a Late Night Refreshment Licence would most certainly impact directly on the quiet enjoyment of the residents of our building by extending the hours of operation to 3am.

The residents currently have to tolerate noise and smell generated by this establishment and others fast food premises opposite and nearby on Baker Street which at times is invasive and impacts on residents daily.

This application if granted would undoubtedly increase the anti-social behaviour; noise from patrons eating at tables outside as well as queuing & leaving the venue; and the constant noise from delivery drivers scooters etc, which we already experience and have to tolerate due to current licensing, as well as the increase in littering from take-away purchases where these might be consumed outside by patrons before leaving the area. We have certainly noticed and increase in pest activity from Pigeons and other pest feeding of dropped food etc. Which is a further health hazard.

Many late night patrons seeking food at such hours are likely to be intoxicated and will also be a hot spot for trouble which the police will no doubt have to attend bring more noise with sirens and strobing blue lights.

Do the Met Police have the resource on what is an already stretched service to effectively police this area into the early hours? Currently with all other local fast food premises shutting in normal permitted business hours this at least restricts restricts the impact.

On behalf of the Marylebone Councillors I am writing to object to the above application to vary the premises licence for the provision of late night refreshment until 03:00 Monday to Sunday, on the grounds it will not promote the Licensing Objectives; namely the Prevention of Public Nuisance, Crime and Disorder and Protection of Children from Harm.

This premises is in a highly residential area. In addition to this they have not be complying with current hours of opening and have been breaching these times on multiple occasions.

I believe there is record of this which they were warned about but they have continued to ignore.

On another subject but still relevant I feel is the matter of their lack of ventilation and how much the nearby area really smells of the spiced food they are cooking. Even with all the other food companies in the nearby area theirs is so overpowering it is all that you can smell.

It appears they do not have correct ventilation as the harsh smell of heavily spiced cooking can be smelt from really far away.

It is particularly unpleasant for the residents who live in the apartments directly above the shop in York Place Mansions.

Especially in the summer if you open the windows for fresh air or to keep cool the smell is very strong even on the higher up floors.

We did not receive notification about this application but luckily have been told about it last minute.

We are deeply concerned about the disturbance this will cause from many different aspects:

- 1. We already suffer greatly from intense cooking smells inundating our flat and the street surrounding the shop. The extension of opening hours would make the situation unbearable.
- 2. Night-time noise and other public nuisance on the street would greatly increase, from increased activity due to queuing, eating at tables outside, and consumption of takeaway on the street to increase in antisocial behaviour, and resulting increased police activity.
- 3. We expect that there will be increased litter on the street and a public health hazard from dumping of unfinished food and food wrappings.
- 4. We already observe a large number of delivery riders loitering around the area, including on our doorstep, waiting for business. This would intensify under extended hours.
- 5. There is already considerable concern among residents about the character and nature of the classic Baker Street being degraded by the increase number of fastfood outlets on the street.

The extension of licensing hours would make the situation unbearable for all the above reasons and affect the rental and sale price of our property. A similar application was rejected only 6 months ago.

We are instructed to make representations on behalf of the Company in relation to Application Reference 22/09054/LIPV ("the Application").

## **Background**

- The Company is the owner of the freehold property at Bickenhall Mansions, Bickenhall Street, London, WI U 6BW ("Bickenhall Mansions"). Bickenhall Mansions contains 223 flats across two blocks and is situated an Bickenhall Street, which is a side street off of Baker Street leading to Gloucester Place.
- 2. Shawarma N More Limited ("the Applicant") trading as Shawarma & More operates a fast-food restaurant business from 123 Baker Street, London, WI U 6RZ ("the Property").
- 3. The Property is situated one unit from the corner of Baker Street/Bickenhall Street. This area contains a large number of food outlets including:
  - Bills: 119-121 Baker Street;
  - Wok to Walk: 129 Baker Street;
  - Pizza Express: 133 Baker Street;

- Chick'N: 134 Baker Street;
- Itsu: 132 Baker Street;
- KFC: 128 Baker Street;
- Starbucks: 126 Baker Street;
- McDonalds: 122 Baker Street:
- Pret-a-Manger: 120 Baker Street;
- Joe & The Juice: 105 Baker Street;
- Nandos: 133 Baker Street.
- 4. The Applicant is currently licenced to open until 23:30pm on Mondays to Thursdays, and until midnight on Fridays and Saturdays. These hours are pursuant to a Decision of the Licensing Sub-Committee on 07 July 2022 following a previous application for extended hours by the Applicant. The Decision stated in material part:
- "PC Dave Morgan for the Metropolitan Police Service (MPS) had maintained their representation as this application exceeded core hours which caused them concern for the increase of crime and disorder in the area. PC Morgan stated that takeaway premises that are opened late attract people that have been drinking which leads to a risk of violence and assaults."
- "Mr. Anil Drayan on behalf of Environmental Health Service advised that he was originally concerned that the application for a 5 am licence as this ,vould make the premises a destination with people in the West End to congregating .... Mr Drayan informed the Sub-Committee that the premises are located close to the Marylebone Road and already have high levels of noise."
- "The Sub-Committee decided to grant the licence with core hours as they were concerned that any later hours would detrimentally impact the licensing objectives, namely, public nuisance and crime and disorder".
- Condition 4: "Takeaways of food and drink by use of a courier service shall only be r
  with a courier service who have agreed that their delivery divers have been given clear,
  written instructions to use their vehicles in a responsible manner so as not to cause a
  nuisance to any residents or generally outside the licenced premises; not to leave
  engines running when the vehicles are parked; not to obstruct the highway."
- Condition 5: "All outside tables and chairs shall be removed or rendered unusable by 23:00 each day".

A copy of the Decision is enclosed/attached for ease of reference.

## **Application**

- 5. The Application is for a new premises licence to enable "the provision of late night refreshment" until 3:00am on Monday to Saturdays. However, the Application also indicates that the Applicant intends to open until 3:00am on Sundays.
- 6. The Applicant is not currently licensed to sell alcohol and is not applying for a licence to sell alcohol. However, the Application also states that the Applicant's staff will receive full alcohol training and that they will implement a "challenge 25" policy.

## **Objections**

- 7. We are instructed that our client opposed the Application on the following basis:
- 7.1. Baker Street is becoming increasingly noisy and dirty and this issue will get worse if food outlets are allowed to operate overnight. Food litter is a particular problem for the residents of Bickenhall Mansions, who have previously complained to Westminster City Council about the issue.

- 7.2. Late opening hours may lead to an increase in anti-social behaviour. Residents of Bickenhall Mansions already find strangers sitting on the front doorsteps of Bickenhall Mansions eating fast food late at night and this problem will worsen if food outlets open overnight.
- 7.3. Our client considers that granting the Application would contradict the City Plan:
  - Paragraph 16.2 of the City Plan provides that proposals for food should be accompanied with an assessment of development impacts. This paragraph notes that later opening hours are likely to have a disproportionate impact on surrounding areas.
  - Paragraph 16.3 of the City Plan states that: "The cumulative impact of multiple food ... uses in a particular area can have a negative impact on the fimctioning and use of an area and can negatively impact residential amenity. We will therefore prevent
    - the over-concentration of these uses and require proposals to make sure any negative impacts are managed ... "
  - Paragraph 16.8 of the City Plan states: "In recent years there has been significant growth in mobile technology-based platforms used to order hot food. This often leads to negative impacts on the amenity of residents and businesses arisingfiom the noise and other disturbance fiom large numbers of delivery agents outside food premises or elsewhere. Hot food takeaways fall under a different use class to restaurants and cafes and by their nature, can result in increased disturbance as a result of motor vehicles, mopeds and motorbikes taking deliveries of food to customers .... we will ensure that any negative impacts are minimised and managed. We will therefore seek to control numbers and hours of operation .....
- 7.4. Other local fast-food restaurants on Baker Street such as McDonalds, KFC and Chick'N are only licensed to open until midnight at the latest. Our client is concerned that if the Application is granted, it will set a precedent for other local fast-food restaurants.
- 7.5. The Applicant has been operating beyond its permitted hours:
  - Our client has emailed Westminster City Council on a number of occasions since 07 July 2022 with photographic evidence showing that the Applicant has been serving food later than 12:00am on a number of occasions, sometimes as late as 01:20am, and that on these occasions customers have been sitting outside and also forming large queues obstructing Baker Street. Our client has also provided Westminster City Council with photographs of delivery bikes laying on the ground outside of the Property at these times. Copy photographs are closed/attached for your ease of reference.
  - We enclose/attach a print-out of the Applicant's Google profile, which states that the Applicant is open until at least 2:00am every day.
  - At the hearing of the Licensing Sub-Committee on 07 July 2022, the Applicant, who attended, was informed that it was not permitted to operate outside its licensed hours until its application had been determined. Accordingly, the Applicant is well aware that it should not be operating beyond 12:00am.
  - Our client understands that Westminster City Council has issued letters to the Applicant warning that it is breaching its license by trading beyond permitted time. Our client also understands that Westminster City Council is planning to can-y out an inspection under the Licensing Act.
- 7.6. Given the Applicant's flagrant disregard to comply with its current licence, our client is also concerned that if the Application is granted, the Applicant may also open late on Sundays and/or attempt to sell alcohol, both of which are referred to in the Application.
- 7.7. Delivery drivers use Bickenhall Street as a "cut through" between Gloucester Place and Baker Street, frequently travelling in the wrong direction. This is a hazard to pedestrians. Further, the noise of these vehicles is having an adverse impact on the residents' amenity and is disrupting sleep. This problem will worsen if food outlets open overnight.
