The establishment provides takeaways and seating outside and is APPLYING FOR A LICENCE TO OPERATE ALL THROUGH THE NIGHT.**



This will have a number of negative impacts and we are strongly urging all Lessees and Residents to voice their objection to the application. Please encourage local friends, businesses, neighbours in local area, contacts from local school or work community to do the same.

Allowing all night opening would set a dangerous precedent for other fast-food shops at this end of Baker Street. Please Object.

As it was a while ago, a visit was done by me and CI Alan Kittredge at 23:20 hrs. Premises was open spoken with the owner over the phone who said that he has submitted an application for TEN's which has been granted by the council. We checked Uniform and the TEN's application was submitted on the 4/03/22 and granted for the 14/03/22 from 23:00 hrs to 5am 15/03/22. As there was no valid license in place for that evening I advised him stop trading and close up, which he told his staff to do. I also asked him to provide me with HM Land Registry document from the leaseholder showing that the forecourt is private land. The blue public notice was not displayed on the shop window which I advised he must do and it must be in blue paper on black ink.

05/02/22, at 23:05hrs

Visit was carried out by me and CI Alan Kittredge again and on this occasion the premises was open with two customers inside the premises. Open sign was still displayed on the shop window. Spoken with Mohammed Shade who said he was bringing in the T&C and the shop is closed he just forgot to turn the sign over to close. He said to us that the two people inside the shop have just walked in and begged for some food, the food was given to them free no payment was taken. In regards to the entrance door being open, Mr Shade said that the door was open because they were bring in the T&C and the last order was at 22:38 hrs.

A recent license inspection was done on the 14/10/22 in the presence of the owner Mr Ali. Few matters of concern were observed and discussed with him. After speaking with the owner he feels like having these complaints and objections against his business are all racially motivated and what ever they do it seems like noting is correct. I advised him that they must follow what his license says and don't worry about what anyone has to say as long as they comply with their license conditions then, we as the council won't need to keep making visits at his premises.

Since the inspection no further complaints have be received and even when we do general observation no issues were raised.

Shawarma has been witnessed breaching its licence conditions recently and I spoke to the manager, Mushtaq about the situation and informed him that I will be starting a legal action against the business. Mushtaq pleaded with me not to take any enforcement action, that I should give them the last chance. I made it clear that they have had many chances and that I will be reporting them for prosecution on this occasion. This incident occurred on Sunday 13th November.

Furthermore, I have been made aware of further breaches of licence conditions by a resident who witnessed them trading beyond the licenced hours.

I hope to find time to write and submit papers to our legal team on Wednesday 23rd for the litigation against Shawarma.

As you may already be aware, the above premises has made an application to extend hours for LNR to 3am Monday to Sunday. The case was originally scheduled for a hearing on 17/11/22 but has been rescheduled to 01/12/22.

I have been checking the complaint history and I note that on 24th February 2022, you visited the premises with Lee C at 01:06 and found the premises to be open and trading. You subsequently issued a letter Act Letter.

Again on 05/03/22 at 23:20 hours, MK & AK visited and found the business to be open and trading.

The records also show that on 05/02/22 at 23:05 hrs, the business was found to be open with two customers inside and the open sign still displayed on the shop window. Uniform is not clear who made the 05/03/2022 observation.

As part of documents to help the committee make a decision, I will need you to provide a witness statement that captures the above account.

Can you ask MK or AK to provide me with a statement too.

If your statement cannot account for the observation of 05/02/22, can you please ask the responsible CI to update the records, so I am able to give an accurate account to the committee

For the committee members to receive all information in good time, I would appreciate if your statement(s) reach me before 20th November 2022.

Re: Further Submission for Sharwama n More, 123 Baker Street, W1U 6RZ – 22/09054/LIPV

With regards to the above, the Metropolitan Police Service would like to further to further submit the following information.

The Police are maintaining their position to oppose this application for a number of reasons which I will explain below.

1. Firstly, I have concerns that the venue may have already breached their licence conditions which was only issued on the 7th July 2022 (22/01952/LIPN). On the 19th September 2022, the Police Licensing Team were informed by the Westminster City Inspectors of a potential CCTV breach of conditions at the venue. They stated that a Police Officer investigating an allegation of assault at the venue had tried to obtain some CCTV. However, the Police officer stated that staff at the venue were very obstructive and they even called 999 to report the officer which almost led to the arrest of the staff.
The DPS later attended and spoke to the officer and said he would download the CCTV. This never happened and was he failed to provide the footage. The Police Officer continued to try and obtain the footage and was then told by the DPS that the footage was only kept for 14 days. These were clear breaches of the CCTV condition requiring that all recordings should be kept for 31 days and made available immediately upon the request of a Police Officer. I therefore have no confidence in the DPS and am concerned of his lack of knowledge of the License conditions to allow his venue to operate well beyond core hours.
2. Secondly, since having a licence issued on the 7th July 2022, there have been reports that the venue have been trading beyond their licensable hours which have been investigated by the Westminster City Inspectors. Again, this would be a breach of the recently issued licence

and I again have concerns that the DPS would continue to breach the licence and open beyond the licensable hours.

Below are copies of the email chain between PC Best, WCC City Inspectors and myself which detail the breach of the CCTV condition and make mention of the trading beyond the licensable hours .

Morning Dave,

We've been called to the venue to reports of an assault. The victim has then told us that he has worked at the shop for 7 days doing wash up and has now asked for payment and the chefs have punched and ejected him from the venue - refusing to pay.

The victim is an asylum seeker with no working permit. I've reported both him and the shop to immigration. As the chefs were the suspects at this point – I've asked them to provide details. They have both refused and one of them has called 999 on me 3 times (bearing in mind I was in full uniform at the time). They were extremely uncooperative to the point where a van was called for because I was going to have to arrest them in order to ascertain name and address.

At this point the manager has come down (Mushtaq Ali), who has facilitated things by giving us the staff members details. He then said he would send me the CCTV later that day but this never happened. I've chased him multiple times to which he always said he would send it later that day. I've attended the venue to chase this up – this is when the council were in attendance as well.

The crime is shut due to being unable to get in contact with the victim.

Thank you for taking time out to speak with me over the phone today during my visit at your premises, Shawarma N More Limited, 123 Baker Street, W1U 6RZ.

While I was in your premises two police officers attended to request CCTV footage dating back in June. It was brought to my attention from one of the officers that the owner is being uncooperative in providing CCTV footage as requested.

I would like to remind you that under your current premises license you have a Conditions attached after a hearing by the licensing authority,

1. The premises shall install and maintain a comprehensive CCTV system as per the minimum requirements of the Westminster Police Licensing Team. All entry and exit points will be covered enabling frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises are open for licensable activities and during all times when customers remain on the premises and will include the external area immediately outside the premises entrance. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Viewing of recordings shall be made available immediately upon the request of Police or authorised officer throughout the entire 31-day period.

2. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises are open. This staff member must be able to provide a Police or authorised council officer copies of recent CCTV images or data with the absolute minimum of delay when requested

Can you please kindly confirm that you have the CCTV footage as requested by the police officers if so can you make this available.

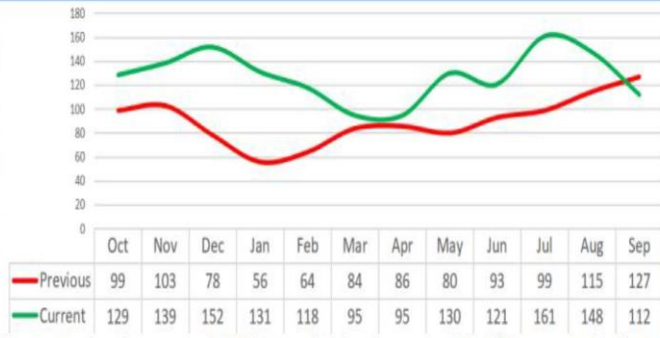
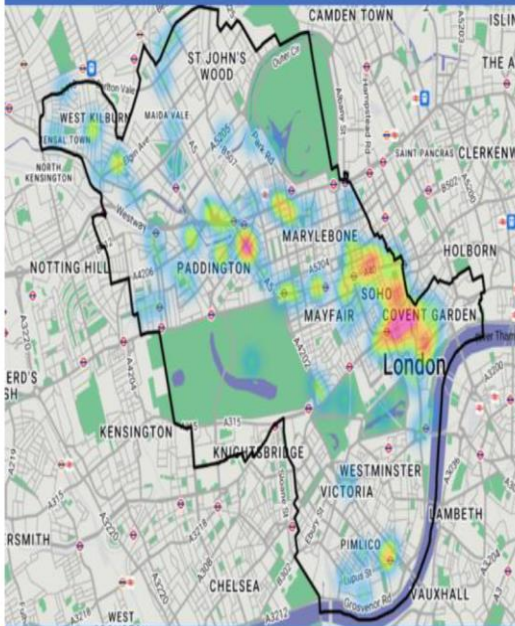
- Reports about ASB, noise and drugs being received from businesses and residents by moped and bicycle delivery riders that park up at the junction of Baker Street and York Street
- Reported riders causing sexual harassment of people
- Police patrolling and stopping people where they have grounds to do so
- City Inspectors have challenges when dealing with riders as they are often aggressive and threatening toward officers. Parking visit and they report that moped are either complying with parking restrictions or ride away when approach. ECC have no powers to detain.. Bid Security face similar negativity from riders when they try to engage, and they are gathering Body cam evidence.

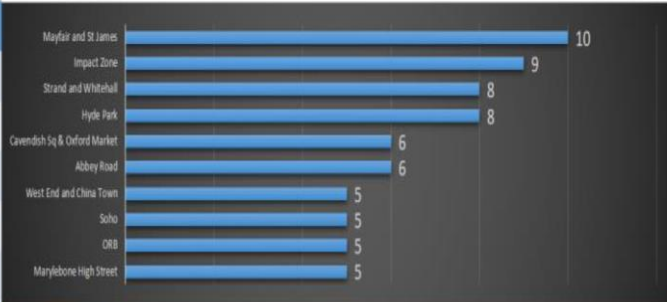

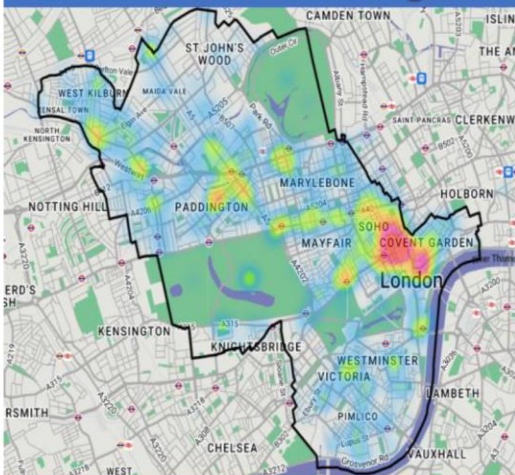

Violence Against the Person Excl Domestic



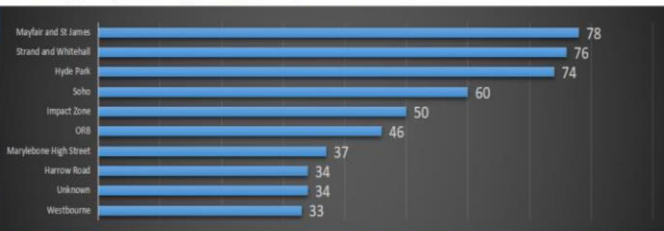

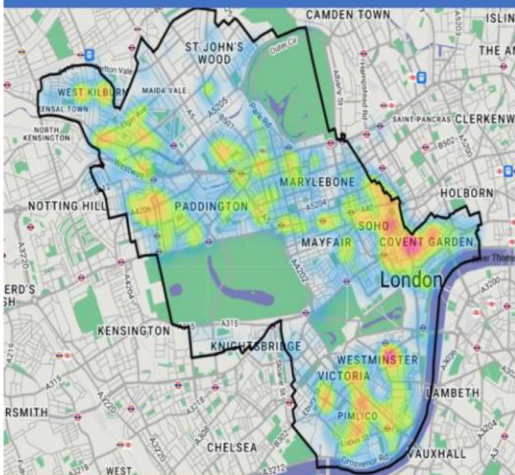

Anti Social Behaviour



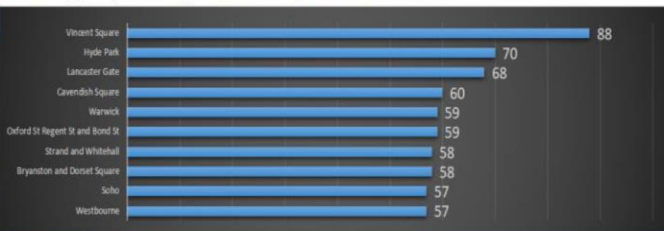

Please advise on the action that WCC will be taking.

- WCC license permitted opening until 11.30pm but they were still serving food at 1.22am with no sign of stopping
- WCC license permitted outdoor seating allowed until 11pm but people were still sat there at 1.22am
- WCC condition imposed was that they would ensure ensure that delivery drivers used their vehicles responsibly but as you can see they even allow their motorbike delivery drivers to park on the pavement
- WCC condition imposed was that the establishment would manage queues so that there is no public nuisance or obstruction of the highway but as you can see this is not the case
- WCC Informatives included a note that all advertisement for opening hours will reflect the times of the license. Their door sign states they are open until 1am, their google hours show 3am.

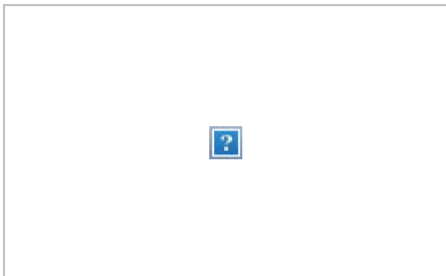
