

On Friday 27 July 2023, at approximately 22:00 hours I was on duty in Soho, London, W1 with my colleague City Inspector Sam BUCPAPAJ. Our intention was to visit Canwood55, located at 55 Frith Street, to monitor for compliance of the conditions of the Licence issued under the Licensing Act 2003.

Mr BUCPAPAJ and I walked along Bateman Street to get to the entrance of the venue, which is on the corner of Frith Street and Bateman Street. The rear of the venue is viable through a large window in Bateman Street. When we reached the window, we briefly paused for Mr BUCPAPAJ to finish the cigarette that he was smoking. Whilst standing with my colleague, I looked through the large window and could see several people seated at tables. The tables were a combination of restaurant style tables and chairs, a taller, large table, with approximately six soft high seats, and a sofa in a lounge setup. The majority of the customers had a drink with them which were in standard V-shaped martini glasses. I also saw small plates with pizza slices on them. Apart from the small plates containing pizza, none of the customers were seen to be actively eating using cutlery or other utensils.

At approximately 22:20 hours Mr BUPAPAJ and I walked to the front entrance of

us. He directed us inside where a male member of staff took us to a table for two

at the front area of the venue. The front area consisted of five two-seater-tables

in a restaurant style on the right-hand side, a high table with three highchairs

cocktails in V-shaped martini glasses and a small plate containing four slices of

pizza.

At approximately 22:50 hours we signalled to a male member of staff and ordered two more espresso martinis. They arrived soon after. During this time, I watched the couple immediately to my left eating only one slice of pizza as well as paying their bill using a card with a hand held terminal. The price on the terminal read £16:88. They then left leaving 3 pizza slices behind. I also noted that some other coupes had a small plate with pizza slices, but not everyone.

At approximately 23:10 hours I walked towards the bar and asked the male member of staff where the toilets were. He gestured and stated that it is left and left again whilst pointing towards the rear of the venue. Walking to the back of the venue I saw the entrance to the room, that I saw before we entered the venue. I looked into the room and can confirm that this was the same room as what I saw from outside. I did not see any substantial food on any of the tables. I then used the facilities and returned to the table.

At approximately 23:15 hours we settled the bill which came to £33.75 and left the venue at 23:18hrs. During this time I did not see anyone being offered or consuming anything other than a small plate containing four pizza slices.

The following is an account of my visit, with Heath Richards, to Canwood 55, 55 Frith Street, London W1D 4SJ, on the evening of 29 July 2023:
Mr Richards and I arrived at Canwood 55 at 21:37. Outside the premises on the footway in Frith Street there were three tables and seven chairs. I took a photograph of them. Six people were seated at the tables.
At the entrance we were confronted by a man who appeared to be acting as a door supervisor, but denied that he was one. He was holding a clicker, but didn't appear to be displaying a SIA badge and wasn't wearing a hi-vis jacket.
When we entered the premises I asked for the manager and was introduced to a man who later identified himself to me as asked me to speak by telephone to the designated premises supervisor. I explained to that I was following up on my inspection of Canwood 55 on 5 July after which I had written to the licence holder describing the licensing breaches I had found. I told I had not received a response to my letters and he responded by saying all the issues I had identified had now been addressed.
I then went with into an office where I was able to see screens showing live CCTV images from the cameras inside Canwood 55. I pointed out that the clocks on the screens were displaying a time which was eight minutes late. I asked to show me images from two weeks previously and he initially responded by saying he couldn't do this because he couldn't operate the system. The conversation was in a foreign language that I dd not understand, but appeared to be explaining how to use the CCTV system and after a while was able to show me the images I had asked to see.
I asked to produce the premises licence. He initially did not appear to understand what I meant, but again after consulting with by telephone he was able to locate the licence behind the bar and brought it to me.
asked me to speak to again. asked if I had identified any problems and I told him my main concern was that I did not believe he was complying with condition 13 of the premises licence, which requires that the venue operate as a restaurant. I said it was clear to me that it was primarily a bar and not a restaurant. He denied this and said the business was operating in full compliance with condition 13. I put it to that customers were able to buy alcoholic drinks without food and that food was given to some customers free of charge. He denied both of these allegations, but I know his denials to be untrue on the evidence of the covert test purchases carried out by council officers on 15 and 28 July.

I told	he may be contacted and asked to produce CCTV footage and he said he
could	lo this. He asked that the request be sent to him on the following email address:

As we left the premises Mr Richards spoke to about the door supervisor, who after speaking with Mr Richards had disappeared leaving the entrance untended.

On Saturday 29 July 2023, at 21.33 hours I was on duty on duty in Soho, London, W1 with City Inspector Martin RATLEY. Our intention was to visit Canwood55, located at 55 Frith Street, to monitor for compliance of the conditions of the premises licence issued under the Licensing Act 2003.

On arrival at the premises, I noted a male who appeared to be acting as a door supervisor. I approached him and identified myself by explaining who I was before showing him my Westminster warrant card. He was wearing a blue arm badge on his left arm but the way the armband was positioned made it difficult to confirm if he was an official SIA (Security Industry Authority) door supervisor. I noted he was holding a clicker and so I asked him if he was a door supervisor.

He replied that he wasn't. I then asked if I could see and check his badge and his reply was "No you can't see it and I'm not going to show it to you". He was very dismissive and then promptly walked off up Frith Street leaving no-one stationed at the door.

I then entered the premises at 21.37 hours and using my council issued clicker, counted 32 customers inside the premises. I did not count staff. There were three lots of 2 tables which had drinks and pizza on them. The remaining tables had no food on them. In the back area I noted 7 (seven) people sat at a large rectangular table. They had what appeared to be alcoholic drinks, mainly cocktails, on them but no food. There were two other people sat at a table for 2 with drinks but no food. There were also two young females sat at a sofa positioned on the left side of the back area. There was a table next to the sofa which had a menu on it. I then decided to count the total number of covers; I noted 18 chairs in the front area and 19 chairs in the back area, making a total of 37 covers inside the premises. This figure did not include the two sofas in the front area and one sofa in the back area.

I left my colleague, Martin RATLEY, to talk with the person in charge of the premises, and walked outside to check on outside area of tables and chairs. On my way out I noted 3 people sat at a table near the entrance. There were six drinks in cocktail glasses on the table and one plate of pizza between them. At 21.54 hours I noted two people sat at a table outside, there were two expresso martinis and the table and one plate of pizza between them. Another table outside was occupied with 2 people; each person had what appeared to be an alcoholic drink but there was no food on the table.

Overall, it was clear that the Canwood55 was in breach of condition 13 of its

premises licence requiring it to operate as a restaurant.

At 21.56 hours and I noted the male with the clicker stationed at the door on my

arrival had not reappeared. I then walked back inside and conducted another count

of customers inside and noted there were 36. I did not include persons who

appeared to be members of staff.

Condition 15 of the premises licence states the number of persons accommodated

inside the premises should be 35 and at this point it was clear that the premises

was overcrowded and there was still no sign of the door supervisor. Neither was

there a member of staff from the premises managing the capacity. In the absence

of no-one managing the capacity, people were freely entering and exiting the

premises.

I conducted a final count at 22.13 and noted there were 39 persons inside the

10. A staff member from the premises who is conversant with the operation of the CCTV system shall always be on the premises when the premises is open. This staff member must be able to provide a Police or authorised council officer copies of recent CCTV images or data with the absolute minimum of delay when requested.

PC STEWART said he may be able to operate the CCTV and after receiving consent from that he could do so, PC STEWART started to view the CCTV. As we went through the footage, I noted a clear breach of the Health Act 2005. This was noted on Camera 5 at 01.08 hours on Saturday 30 September 2023. I saw a middle-aged male in a T-shirt, short black hair who was smoking a cigarette. Initially, I thought he was vaping, but I saw smoke rising from the end of the object he was smoking, and at one point he is seen walking towards a nearby table and flicking what appeared to be ash into a receptacle. At no point did I see a member of staff challenging him.

I also saw a speaker to the left of the room. There was no sound on the CCTV footage, but I saw at least 2 people dancing. The bar area was also viewed, and I noted what appeared to be alcoholic drinks being placed on the counter by bar staff. It appeared that these drinks were brought to customers in the back room of the venue.

Subsequently having agreed a schedule of conditions (which I will detail the significant conditions later in my statement) the representations were withdrawn by all interested parties and the licence granted under delegated authority.

On 9<sup>th</sup> December 2022 PC Muldoon and myself were on duty in plain clothes, as we were walking passed the premises I noticed that there were a large number of customers inside the venue who appeared to be consuming alcohol and I couldn't see any customers with food. I then recalled that I had dealt several Temporary Event Notices (TEN) which sought to extend their permitted hours to 0100 hrs. The TEN gave the following undertakings:-

To add a sub condition (b) to 9 of the premises licence at 55 Frith Street London W1D 4SJ number 22/08929/LIPDPS "(b) Notwithstanding the above, a maximum of 10 persons may be supplied with alcohol whilst waiting to be seated at a table in the restaurant".

We explained our concerns at the distinct lack of food and the premises should be trading as a restaurant, with alcohol being sold ancillary to substantial table meals. He stated that food was being served and that customers had either finished or were waiting for their food. Myself and PC Muldoon the walked around and asked several of the customers who were consuming alcoholic drink if

the DPS to see the kitchen and were escorted to the kitchen, there we met a single member of staff working in the kitchen, who I presumed was the chef. We asked him how much food he had prepared that evening and he went and showed us food order tickets, there were approximately five or six tickets, we asked if that was for the entire days trading and the chef confirmed it was.

We then spoke with the DPS if we could see the full copy of his premises licence, and he showed to his office where he began looking for the premises licence, it appeared to me that he was not going to be able to locate it, so I searched for the online version. I then went through the conditions as shown on the licence.

We asked the DPS to show us the CCTV, he was initially unable to logon the CCTV system as he claimed the password was incorrect. eventually he gained access to the system but was unfamiliar with how to operate it. We asked to see footage from earlier in the evening to corroborate his claims that customers had ordered food, the CCTV did not provide evidence of food being served or the premises operating as a restaurant.

We then asked to see footage of the previous weekend. The premises had submitted a TEN to extend hours for sale of alcohol and late night refreshment to 0100 of Friday and Saturday trading night and midnight on Sunday trading night.

On viewing CCTV for that evening, the footage did not provide any evidence of the premises trading as restaurant, I could not see any customers with food. We viewed further footage after 0100 hours, at

	My involvement with this premises started on the 9th December 2022, Myself and Pc Reaz Guerra were on foo patrol in the West End in plain clothes. At time we were working a late shift and had various premises to meet throughout the night. We saw a large amount of people inside the venue with all appearing to just be drinking alcohol. Pc Guerra had advised me that he was aware this premises was a restaurant due to a number of Temporary event notices that he had dealt with recently. As we suspected the premises was in breach of at least one of the conditions and was potentially over capacity, we entered to discuss our concerns with the Dps/manager.
	We both entered the premises and were not met by any member of staff and were not shown to any table. We walked around for a short time and were still not approached, I on closer inspection now I was inside could see no food on the tables, no menus on any table or at the bar and could see that all the customers at tables were drinking alcohol. We eventually saw a member of staff and asked for the manager. The member of staff brought over the weight of the weight ourselves to him and he advised us that he is the manager and the DPS.
	We had a discussion with advised him of our concerns that no customers had food and there were no menus. Advised us that most had eaten or were waiting for food. We asked to show us to the kitchen. He did so and in the kitchen was 1 male who said he was the chef. The male was standing against a unit and was not engaged in any preparation of any food and it was clear no food was currently in any oven or microwave. We asked the chef how much he had cooked and he produced a small number of tickets that showed approximately 5 tables had eaten. The chef however said this was for the whole day.

We were on FRITH ST having had a meeting at another venue when we decided to see if the premises had opened up as a new restaurant. we arrived at the door, walked in, I could see that some tables had pizza on but most had alcohol. I also noted it was odd that the pizza did not appear to be eaten or getting eaten by those drinking alcohol.

We asked for the manager and were initially told "WE ARE ALL MANAGERS" by a male that turned out to be the Dps . There was a discussion between staff and we were told "WE HAVE NOT DECIDED WHO THE MANAGER IS" We made it extremely clear who we were and why we were there and at that point

	Due to the failings I issued the premises with a closure notice under section 19 of the criminal justice and police act 2001. I documented this being issued for the following reasons:
	<ul> <li>Failure to use operate CCTV</li> <li>Fail to produce an incident book</li> <li>Fail to operate as a restaurant</li> <li>Operating over capacity.</li> </ul>
	I identified what could be done to rectify this. This notice means these failing need to be resolved in 7 days.
	On Tuesday 6th June I was attending a meeting with Heath Richards (WCC), Heath had advised me that he had a public complaint about the amount of tables and chairs that had been put out by the premises at 55 Frith St, he asked if i minded if he went to resolve this on the way to the meeting, I was happy to do this and attended with him.
	Upon arrival i saw 4 tables and chairs on the front facing Frith St and 5/6 tables along the side of Bateman St. Heath spoke with the DPS who was immediately aggressive and confrontational, Heath simply asked the DPS if they had a licence for the tables and chairs, responded by arguing and saying things like "YOU TELL ME" this went back and forward until stormed inside and said he was calling his solicitor. Came out and eventually removed the tables saying his solicitor told him to move them. When moving them demanded to know the name of the complainant saying Heath had made it up. The was told he was not entitled to this information but he maintained that his solicitor Gavin Venamore had told him he was. We went to leave as the tables had been moved. Prior to moving said to me "I HAVE SPOKE TO THE FIRE BRIGADE AND THEY SAY I CAN HAVE MORE THAN 35 IN HERE" I pointed out to that there is a condition on the licence that only allows for 35 customers.
	It was clear from this comment that had no knowledge of the licence.
	I opted on this occasion not to assess the CCTV as was in a confrontational state and it was unnecessary to have further discussions about licence breaches then.
	I however returned to the premises approximately a week later with Pc Adam Deweltz, the purpose of this visit was to ensure the premises had completed the actions on the section 19 notice. We attended and met the assistant manager, he advised that he could not use the CCTV and that nobody there could. This meant the premises was still in breach of the conditions on the premises licence. The assistant called however who arrived approximately 5 mins later, walked into the office and without speaking made an attempt to view the CCTV. The managed eventually to use it and turned to us and said "HAPPY NOW" was still confrontational.

On the lead up to London Pride myself and James Hayes (WCC) engaged with all premises regarding what is expected of licenced premises. No temporary event notice was ever received from the venue for the day of Pride so it was expected by us that the premises would operate following the conditions of their premises licence.

On the day of pride (Saturday 1st July) I was on duty with Pc Reaz Guerra, Pc Dave Morgan and Martin Tuohy. We were also accompanied by managers from Pride. We were walking round the streets of the West End to ensure that there were no licensing issues prior to Soho getting extremely busy in the late afternoon. It was approx. 14:00 when we were walking up Frith St, my attention was drawn to Canwood when I saw that all the tables and chairs had been cleared away essentially creating a large dance floor. I saw a mini bar at the window and signs all over the window advertising how much alcohol was. We approached and i saw and heard a speaker playing music. Spoke with us, we informed him that he could not do what he was doing, claimed he did not know. I explained that I had been in as had James Hayes and advised them.
denied this and once again said he would call his solicitor.  claimed this to be his solicitor but seemed is not a solicitor and is a manager at another premises) passed me the phone and seemed shocked when speaking to me as it was clear he was not expecting someone that knew of him. He changed his tone and asked what was up, i informed him that the venue was failing to abide by the restaurant condition and was set up like a bar.

A number of visits took place throughout the day and each time they failed to set it back into a restaurant, On each of the visits it was clear there were people inside drinking alcohol and that no food available apart from outside the side window on Bateman St, the staff were selling hotdogs out of the window to passers by. I witnessed drinking throughout the day and towards later in the afternoon into the evening a DJ playing to people with loud music that was audible from the street. The customers the DJ was playing to were dancing in the space that had clearly been cleared as a dance floor. Engagement was done throughout the day but it was clear the staff had no intention of returning the venue to a restaurant.

Later in the afternoon I was then on patrol with Pc Adam Deweltz, and then from 19:00 we were joined by James Hayes (WCC). From 20:00 the role was to visit venues that had a TEN to ensure the conditions offered were being adhered to and that the streets could be readied for opening. We were on FRTITH ST at approx. 20:45 approx. and my attention was drawn once again to Canwood, 55 Frith St. I heard from the street extremely loud music coming from Canwood. I could see a doorman standing at the front door, the DJ playing music inside the window with one speaker pointing outside and one inside. I could see a number of people inside drinking what appeared to be cocktails.

someone that was in charge. I instructed the DJ to stop as it was now 21:00 approx. At this point i was approached by a female who was extremely intoxicated, she was slurring her speech, stumbling round and was still drinking alcohol, the female shouted abuse to us that resulted in her shouting to us "FUCK OFF"
James Hayes advised he had found in a back corridor, Pc Deweltz spoke with him and issued another section 19 closure notice. Pc Deweltz explained the process to but refused to sign the form, he then negotiated signing the form with Pc DEWELTZ and eventually said he would sign but did not agree. Whils leaving I saw that there was a large crack on the window to the left of the door. A member of staff had then said "SOMEONE SMASHED IT EARLIER" I asked if it had been reported and was told it had been. I asked what happened and the staff member shrugged his shoulders.
Whilst inside the venue it was clear tat the staff were all intoxicated. This was clear and obvious.
We left the venue with instruction that they should not continue to trade as their customers were too intoxicated and a vast amount of conditions were being breached.
Having left the venue I can say this was by far the worst run premises throughout the entire event during pride. I pride myself with the pre-engagement I do prior to and the weeks leading up to pride. I visit every single licensed premises to ensure all are aware that there is no relaxation of their premises licences and if venues want to do anything for Pride then they need to apply for a TEN.
On the 14th of July just some 2 weeks after I was again on patrol with Pc Reaz Guerra, at 23:40 hours we were on Frith St and again my attention was drawn to Canwood. I saw the venue was open with a doorman on the front door and customers drinking alcohol. I saw from the side of Bateman St through the window i saw a barman pour 2 cocktails and pass to a waiter who then served to customers. As this was 10 minutes passed their terminal hour we went in to discuss this. We entered and approached the bar where the bar staff were pouring the drinks, i identified myself and pointed out that is was after 23:30. I was asked "WHAT TIME IS IT", I showed them on my watch that it was 23:40. I was handed a receipt which had 23:37 as the time served and was for 2 margaritas. This was 7 minutes after the terminal hour. I asked to speak with appeared and we advised him that w e had witnessed sales after the terminal hour, was extremely dismissive of this and claimed his customers buy and experience and when they pay for the drink they can have it when they want. When we did not agree immediately adopted an attitude that he didn't care. He said "IT'S 7 MINUTES, I WILL STOP NOW AND YOU CAN GO" This was said in an extremely sarcastic manner.
I asked to download his cctv and I will send a link to add it online, I confirmed the correct e-mail for both and the licence holder. Confirmed the email was correct. Later that shift I sent a evidence.com link asking for the CCTV. To date this has never been uploaded. I sent an email to the premises licence holder and have had no response. The email i sent was:
Dear
I am contacting to request to meet on Saturday 15th July at your venue on Frith St. I am starting work at 4:30 so can meet with you at 5.
Myself and a colleague attended tonight and witnessed at 23:40 alcohol being poured. I found the drinks order slips and these were timed at 23:37. I have body-worn video of my visit.
I will in the morning send you a link from evidence.com, when you receive this drink can you please provide cctv covering the restaurant and bar area from 23:20 and 00:00.
I briefly discussed this with however as you are the premises licence holder I would like to discuss this issue with you.

I have to date had no response to this email.

I was asked to attend the venue again with Heath Richards and Pc Tom Stewart on Tuesday the 2nd of October. Heath Richards was attending due to a complaint that the venue had once again operated passed their terminal hour. We arrived at the venue and saw this was open, I met the assistant manager who give his name as a lasked if the was in charge and he said he was. I asked if we could view his cctv and he advised us that there was nobody there that could use it. He said the manager was the only one. I asked if this was and he said no, he give surname but I cannot recall exactly what he said, he showed us to the venues office and called he attempted to use the CCTV by looking through the camera to on the phone. It was clear that he could not operate it. Pc Stewart was able to operate this and asked if he could do so, said yes. Pc Stewart found the date and time suggested in the complaint. It was clear on the footage that there were approx. 25 people inside the venue at 01:30. This is some 2 hours after their terminal hour.

I saw a speaker in the corner of the room this was clearly lighting up as if it was playing music, I could see people danging which would further imply that there were music playing. It was cleared in the footage that

people dancing which would further imply that there was music playing. It was observed in the footage that there was clearly a male smoking a cigarette. I could see the male smoking as there was smoke coming from the cigarette and I saw the male tapping the ash into what appeared to be a cup.

We viewed the footage for the bar area, i could see a number of drinks leaving the bar, i saw on at least one occasion payment being made.

It was clear that the venue made a clear attempt to hide this from the street as they used black-out blinds to hide them in the back room. Prior to leaving the venue I was given the phone from Nicholas who asked me to speak to I spoke with him and asked him to download the footage to a USB and someone from WCC will collect that night.

I was made aware that a city inspector had attended but the manager said he could not download it and we had already done it. We did not do this at any point.

It baffled me that whilst going through a review the venue would act in this way.

I on Monday the 9th of October bumped into the new manager who advised he was at the premises on the night we asked him to download the footage but it had been deleted. He advised me that Nicholas told him that the police deleted the footage. I said to that, that was ridiculous and it would evidentially make no sense for us to do that. I advised that he could not serve people after the terminal hour and that things like we witnessed on camera should not happen.

Over various occasions I can say with confidence the following conditions have been breached on countless occasions with no intervention or resolution from the licence holder or either of the DPS's.

9. The premises shall install and maintain a comprehensive CCTV system as per the minimum requirements of the Westminster Police Licensing Team. All entry and exit points will be covered enabling frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Viewing of recordings shall be made available immediately upon the request of Police or authorised officer throughout the entire 31-day period.

- 10. A staff member from the premises who is conversant with the operation of the CCTV system shall always be on the premises when the premises is open. Substantial food and non-intoxicating beverages, including drinking water, shall be available in all parts of the premises where alcohol is sold or supplied for consumption on the premises.

17. No noise generated on the premises, or by its associated plant or equipment, shall emanate from the premises nor vibration be transmitted through the structure of the premises which gives rise to a nuisance.

This venue has been run and operated in an awful way with no considerations for any of the licensing objectives. It is for this reason we as the Metropolitan police fully support this review and fully support the local authority in seeking revocation of this premises licence.

I was also aware that back in May 2023, PC Muldoon had issued a closure notice under Section 19 Criminal
Justice and Police Act 2001 for failing to supply or view CCTV when he and PC Guerra attended to view some
CCTV.
As we entered the venue, I could see that all the tables and chairs had been removed from the main seating
area and that there were make shift bars set up on tables around the edges selling what looked like cocktails.
Knowing that the venue had not applied for a temporary event notice to be able to vary their way of operating,
it was clear from the lack of tables, that the venue was setting itself up to operate as a vertical drinking bar and
not a restaurant whereby alcohol would be served ancillary to a meal.
Whilst in the venue, we were approached by the designated Premises Supervisor,
explained to him, by both the Police and Martin Tuohy from Westminster City Council, that he could not
operate as a bar and that he would have to return the venue to a reataurant and comply with the licence
conditions. He eventually agreed to return all the tables to their correct positions and to trade as a restaurant
and so we all left the venue to continue our walk-around.
An hour or two later, we returned to Canwoods only to find that the venue was still operating as a bar and that
had still not returned the tables as he said he would earlier in the day and I could see that the
makeshift cocktail bars were still operating. I recall that there were customers within the venue consuming
what looked like alcoholic drinks and cocktails and that none of them appeared to be consuming food. Again,
was warned by Martin Tuohy from Westminster Council and ourselves (the Police) that he could not
continue as he was as he was breaching his licence conditions and was liable for prosecution. He again
promised that he would return the tables to where they should have been and that he would resume to

I am the above named person and I am a Police Officer attached to the Westminster Licensing Team. I have been a Police Licensing Officer for 6 years. I have been a Police Officer in the Metropolitan Police Service for 14 years and nine months.

This statement is in regards to a Licensing visit at 'Fifty Five' (formally Canwood) 55 Frith Street, London W1D 4SJ on Tuesday 3rd October 2023 at approximately 17:00 hours. I was in the presence of PC Steve Muldoon and Mr Heath Richards, a Westminster City Council City Inspector manager.

I and PC Muldoon joined Mr Heath Richards with a visit to the above mentioned premises as the City Council had received a complaint from a local resident that the premises were undertaking licensable activities outside the hours allowed by the premises licence (23/03488/LIPDPS). The allegation was that the premises were trading on Friday 29th October between 23:30 and 01:30 on Saturday 30th September 2023. The premises have a premises licence that permits the sale of alcohol Monday to Saturday 10:00 to 23:00 and Sunday 12:00 to 22:30. The opening hours of the premises are 10:00 to 23:30. There is no authorisation for regulated entertainment on the premises licence.

The premises are currently under review by Westminster City Council for undermining the licencing objectives, primarily through the breaching of conditions and conducting unlicensable activities. This process is ongoing and will be heard before Westminster's Licensing Sub Committee in due course.

Pc Muldoon and myself entered the premises and introduced ourselves to a male who stated that he was called and gave his positon as the assistant manager. Mr Heath Richards informed that he wanted to view the CCTV in accordance with condition 9 on the premises licence, which states:
The premises shall install and maintain a comprehensive CCTV system as per the minimum requirements of the Westminster Police Licensing Team. All entry and exit points will be covered enabling frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum period of Mays with date and time stamping. Viewing of recordings shall be Witness Signature:

made available immediately upon the request of Police or authorised officer throughout the entire 31-day period.

He asked if he was able operate the CCTV system, to which Nicholas stated that he did not. He was asked if any other member of staff in the premises could operate the CCTV system. He states that there was not. This was in direct breach of condition 10 on the premises licence, which states:

A staff member from the premises who is conversant with the operation of the CCTV system shall always be on the premises when the premises is open. This staff member must be able to provide a Police or authorised council officer copies of recent CCTV images or data with the absolute minimum of delay when requested.

said that his manager, Chris was able to operate the CCTV system but was not there. He called on his mobile phone, who then attempted to instruct on how to retrieve the CCTV footage. It was clear immediately that this was not going to work as seemed unable to navigate the system, even with instruction. It was at this point that I stated that I would try and retrieve the relevant CCTV footage, as I had seen that particular system before. It should be noted that the system was very intuitive and easy to navigate. Very little training would be required to use the system.

I searched for footage covering Friday 29<sup>th</sup> September from 23:00 to 01:30 on Saturday 30<sup>th</sup> September 2023. There were multiple cameras covering the internal areas of the premises, including the main bar/seating area and a secondary area which is also on the ground floor. The second area has a large window that looks out onto Bateman Street. This window was covered by a large retractable blackout blind. At 23:30 hours there were approximately 15 customers within this area, with further customers in the main bar area. A speaker could be seen positioned on the floor, which was intermittently lighting up, as if to a beat of a song. There was no audio on the footage, but it was clear that music was being played. This music would be 'recorded music' and therefore would be regulated entertainment under section 1 (c) of the Licensing Act 2003. The premises are not authorised for regulated entertainment and was not operating under the authorisation of a Temporary Event Notice.

The footage also showed the people consuming drinks from glasses. The look and colour of the drinks appeared to indicate that the majority of the drinks being consumed were alcoholic. We viewed the footage up till 01:30 hours. During this time the persons within the premises continued to consume alcohol. On several occasions, a male could be seen to smoke a cigarette. Smoke could be seen exiting his mouth and he flicked the ash of the cigarette into an empty glass that was on the table next to him. The customers left the premises around 01:30 hours.

At no time did I attempt to download, delegate or otherwise tamper with the CCTV footage. Throughout the entire time that I was operating the CCTV system, PC Steve Muldoon and Mr Heath Richards were in my presence.

We act for and on behalf of the Freeholder of 55 Frith Street, NW3 Firth Limited.

We have taken steps to forfeit the lease granted to 8UERTE Ltd (Premises License Holder) and with effect from 10 October 2023 we have forcibly taken 'back' the premises.

This therefore means that the Premises License Holder and/or the Designated Premises Supervisor are no longer and will not continue to trade from 55 Frith Street.

We would like to engage with the council so that the License for this premises is not withdrawn while we market the premises for new occupiers or even a form of 'shadow' license is granted to the Freeholder for this duration.

I am a long term resident of Soho, and Council's application for a review of these premises, following numerous breaches of their licence over a period of time, but most recently the summer of 2023.

It seems that council and licensing officers have visited the premises on numerous occasions regarding breaches, about which no attempts seem to have been made to comply with their conditions.

I, myself, have been past the premises on numerous occasions, and have seen customers outside at tables (for which there is no licence), drinking without food in breach of the restaurant condition.

I would suggest that this inability to comply with so many conditions has failed to promote the licensing objectives of the prevention of crime and disorder, public nuisance and public safety.

The Licence Holder and Designated Premises Supervisor have clearly demonstrated a blatant disregard of their licence conditions, and from their behaviour it is clear they will not abide by any conditions the Licensing Sub-Committee may chose to impose, therefore we find the only course of action is for the licence to be revoked.

I have been a resident in Soho in the same flat for over 15 years and always enjoyed living in this vibrant neighbourhood. Since I have lived here. I have always been aware of and accepted the elevated noise levels from patrons and businesses in the vicinity. Several businesses have occupied the ground floor of 55 Frith Street. At first, a Pret-A-Manager branch resided here for several years, followed by a Middle Eastern Take Away, none of which caused any issues or disturbance. When Canwood originally started moving into the premises, I highly supported their proposal. The then owner, explained his intention of bringing his Art Gallery Canwood to Soho to operate a non-profit business in support of cancer research for children and reasoned that his application for an alcohol license was to be able to serve visitors to his gallery a glass of wine. The gallery looked like a great addition to the area and ensured a diverse mix of businesses in Soho. During COVID, I strongly supported the al fresco dining and drinking deregulation for the businesses. While it imminently led to an increase in noise and antisocial behaviour, I was willing to accept the temporary nuisance to help businesses back on their feet. I have always been fond of living in the area and have never expected a silent life or environment comparable to living in the countryside.

However, issues started to arise with Canwood as soon as they had opened as a "gallery". It became apparent that while some artwork was hanging on the walls, the premise was increasingly used as a bar to drive alcohol sales. There were countless incidents of nuisance, ranging from out-of-hours trading, loud banging music, screaming patrons, hosting DJ events without a TEN, slamming doors in early morning hours, lock-ins, etc. Most of the time, we dealt with directly to avoid having to call out the council. However, any feedback given was only a temporary fix until the next occurrence only a few days later. The occupation of the premises by Canwood marked the beginning of continuous nuisances that have negatively impacted the daily life of my household, from sleepless nights to tiredness at work and a complete deterioration of residential life.

After was removed from the business, several changes to the company's directors and different operators seemed to have occurred. Seemingly somewhat opaque but still operating under Canwood. Unfortunately, the type of operation did not change. While now licensed to be operating as a restaurant, the business has been run as a bar over the last few years. It continues to create nuisance and antisocial behaviour stemming from intoxicated patrons and loud music to attract customers into the bar. If I recall correctly, I have only reported the business to the council less than a handful of times when I thought the premises to be out of control in terms of nuisance. I do not call the council for minor issues or every incident, as I believe personal contact and feedback with a business ought to be the first approach and attempt to come to an amicable solution. However, on average, I need to bang on the floor/ceiling twice a week for music to be lowered alone. Several nights a month, the possibility of sleeping is impacted or significantly delayed due to music that travels up into the flat.

Notably, it became apparent when WCC visited the premises that immediate improvements such as cutlery on tables and music being switched off at the licensed operating hours were observed. However, my main frustration is while feedback is taken onboard for one or two weeks, as soon as WCC has turned its back in good faith, the operators go straight back into bar operations to drive alcohol sales - cocktails served to all guests with a slice of pizza, music loud, license disregarded. I specifically remember

examples of going down to a previous manager to complain about the levels of music, to which she answered she "had a bar to run". Last year, operator James was published in an article in the Westminster Extra stating his intention to apply for a 3 a.m. license and that overly sensitive neighbours and a too rigid WCC were the problems in the area. After recruiting a licensing consultant one summer, we were bombarded with a weekly series of TENs for weekends that seemingly weren't for events but merely in place to extend the opening hours for trading on weekends. All these statements and actions seem more aligned with an intent to run a bar. Only last month, three additional tables were again placed outside for the weekend during hot days (in addition to the three tables licensed at the front), and often more than six chairs are placed outside against their license; today, there were eight. Two weeks ago, a waitress pointed out the '2-for-1 cocktails' offer to the public passing by in the street. Last month, I observed some customers being sat and served at midnight after their licensed trading hours. One week before that, I watched a table at the back with a whole Vodka bottle, typical for a service in a nightclub. Further, I can also confirm the observations from previous reports from WCC and the licensing team that slices of pizza were offered to patrons for free (if at all) or part of a 2-for-1 cocktail deal to look like a restaurant.

The premise has never caused any issues previously during. As the ground floor and first floor only share a simple layer of ceiling/floor, the noise levels travelling from the Sandwich shops before never impacted residential life. However, the years since Canwood moved in have been particularly challenging, no matter which operator runs the business. A consistent breach of several points of the license has led to an unbearable amount of noise and continuous nuisance that has not existed before. From uninterrupted sleep to constant anxiety about what type of night one might experience, the business has persistently looked to find and use any kind of loopholes to operate as a bar. While communication has always been polite with the managers, the biggest frustration with Canwood has been the continuous disregard of their license after the vast amount of feedback from us, the residents, and official notices from the Licensing Team. I am afraid that an extension of their alcohol license will only cause further nuisances, as observed over the last two years, and that the business will continue to disregard their license and operate as a bar disguised as a restaurant, with several of their licensable activity regulations disregarded to prioritise alcohol sales.

- 1. No supply of alcohol may be made at a time when there is no designated premises supervisor in respect of this licence.
- 2. No supply of alcohol may be made at a time when the designated premises supervisor does not hold a personal licence or the personal licence is suspended.
- 3. Every supply of alcohol under this licence must be made or authorised by a person who holds a personal licence.
- 4. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
  - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
  - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to;
    - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
    - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
  - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
  - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
  - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
  - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 5. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 6. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
  - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
  - (a) a holographic mark, or
  - (b) an ultraviolet feature.
- 7. The responsible person must ensure that—
  - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
    - (i) beer or cider: ½ pint;
    - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
    - (iii) still wine in a glass: 125 ml;
  - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
  - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

A responsible person in relation to a licensed premises means the holder of the premise licence in respect of the premises, the designated premises supervisor (if any) or any individual aged 18 or over who is authorised by either the licence holder or designated premises supervisor. For premises with a club premises certificate, any member or officer of the club present on the premises in a capacity that which enables him to prevent the supply of alcohol.

- 8(i) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 8(ii) For the purposes of the condition set out in paragraph 8(i) above -
  - "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
  - (b) "permitted price" is the price found by applying the formula -

P = D+(DxV)

Where -

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and

- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
  - (i) the holder of the premises licence,
  - (ii) the designated premises supervisor (if any) in respect of such a licence, or
  - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 8(iii). Where the permitted price given by Paragraph 8(ii)(b) above would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 8(iv). (1) Sub-paragraph 8(iv)(2) below applies where the permitted price given by Paragraph 8(ii)(b) above on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
  - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

#### Annex 2 - Conditions consistent with the operating Schedule

- 9. The premises shall install and maintain a comprehensive CCTV system as per the minimum requirements of the Westminster Police Licensing Team. All entry and exit points will be covered enabling frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Viewing of recordings shall be made available immediately upon the request of Police or authorised officer throughout the entire 31-day period.
- 10. A staff member from the premises who is conversant with the operation of the CCTV system shall always be on the premises when the premises is open. This staff member must be able to provide a Police or authorised council officer copies of recent CCTV images or data with the absolute minimum of delay when requested.
- 11. An incident log shall be kept at the premises and made available on request to an authorised officer of the City Council or the Police. It must be completed within 24 hours of the incident and will record the following:
  - (a) all crimes reported to the venue
  - (b) all ejections of patrons
  - (c) any complaints received concerning crime and disorder
  - (d) any incidents of disorder
  - (e) all seizures of drugs or offensive weapons
  - (f) any faults in the CCTV system, searching equipment or scanning equipment
  - (g) any refusal of the sale of alcohol
  - (h) any visit by a relevant authority or emergency service.
- 12. A Challenge 25 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram.
- 13. The premises shall only operate as a restaurant
  - (i) in which customers are shown to their table,
  - (ii) where the supply of alcohol is by waiter or waitress service only,
  - (iii) which provide food in the form of substantial table meals that are
  - (iv) prepared on the premises and are served and consumed at the table using non
  - (v) disposable crockery.
  - (vi) which do not provide any takeaway service of food or drink for immediate consumption,
  - (vii) which do not provide any takeaway service of food or drink after 23.00, and
  - (viii) where alcohol shall not be sold or supplied, otherwise than for consumption by persons who are seated in the premises and bona fide taking substantial table meals there and provided always that the consumption of alcohol by such persons is ancillary to taking such meals.


Notwithstanding this condition customers are permitted to take from the premises part consumed and resealed bottles of wine supplied ancillary to their meal.

- 14. Patrons permitted to temporarily leave and then re-enter the premises, e.g. to smoke, shall not be permitted to take drinks or glass containers with them.
- 15. The number of persons accommodated at the premises at any one time shall not exceed 35 persons (excluding staff).

- 16. Substantial food and non-intoxicating beverages, including drinking water, shall be available in all parts of the premises where alcohol is sold or supplied for consumption on the premises.

- 20. Notices shall be prominently displayed at all exits requesting patrons to respect the needs of local residents and businesses and leave the area quietly.
- 21. Notices shall be prominently displayed at any area used for smoking requesting patrons to respect the needs of local residents and use the area quietly.
- 22. A direct telephone number for the manager at the premises shall be publicly available at all times the premises is open. This telephone number is to be made available to residents and businesses in the vicinity.
- 23. No deliveries to the premises shall take place between 23.00 hours and 08.00 hours on the following day.
- 24. All waste shall be properly presented and placed out for collection no earlier than 30 minutes before the scheduled collection times.
- 25. No waste or recyclable materials, including bottles, shall be moved, removed from or placed in outside areas between 23.00 hours and 08.00 hours on the following day.
